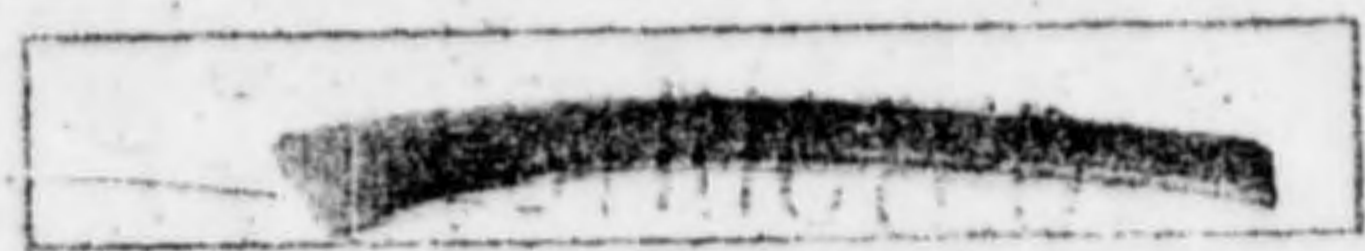

It is the present investigator's opinion that the objects were aircraft. The "bobbing up and down" can be explained as a "seeing" effect -- that is, distortion of the image by air currents.
