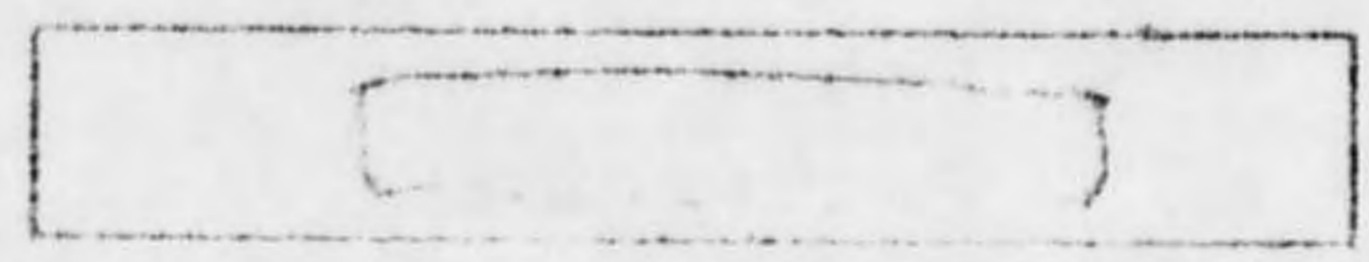

observer(s):

Mr. [REDACTED] appeared to be above average in intelligence  
and of sound character. Due to harrassing by friends and fellow newsmen,  
Mr Brannon has assumed a slightly belligerent attitude with respect to  
his sighting. He has adopted the attitude that he knows what he saw and  
has not been convinced by any explanation to date.

#### NA NARRATIVE SUMMARY:

At approximately 1630 hours on 16 Jan 1949 while proceeding in his  
automobile in a southwesterly direction toward Paris, Ky, accompanied by  
his wife and his niece, Mrs [REDACTED] called his attention to the sunlight  
reflected on the clouds in the western sky. As he gazed into the sky  
his attention was attracted to a walnut shaped object emerging from behind a  
cloud. The sight of the object emerging from obscurity into reflected  
light was maintained for less than one minute. Attention was then focussed  
on a "tube of light" that remained behind as the object moved across the sky.  
Mrs [REDACTED] made four exposures of the tube of light during its progress.  
Mr [REDACTED] described the course as steady and as though some object on an  
outward sweeping arc had crossed his field of vision at a great distance  
from the earth. The fourth and last exposure of the "tube of light"  
fully extended as published in the Nicholas County Star and the Kentuckian-  
Citizen is attached as Exhibit "A". (See files)

Comments of Interrogator relative to intelligence and character of observer(s): Informant has a local reputation as a "publicity bound"

#### NARRATIVE SUMMARY:

An unexplained moving object trailing a bright light across the sky was sighted near here today by [REDACTED] Paris newspaper publisher. [REDACTED] and his wife observed a ball-shaped object "literally opening up a path across the heavens". Object was sighted between Paris and North Middletown. At first the object had a silver color but took on a golden hue from the sun's rays. "It looked almost like another planet", he said. "I've seen meteors and Halley's Comet, but it wasn't as small as those. This thing was a brilliant shaft of light that you couldn't help but see..." [REDACTED] said it was visible at least 15 minutes. A picture was taken by Mrs [REDACTED] a few minutes after they first observed the object streaking out from behind a small cloud.

#### Possible Explanation by CIC Agent CHARLES J. FLETCHER, 109 CIC Detachment & gleaned from various newspaper clippings

Mr [REDACTED], Jr., brother of CIC Agent J. D. Haggard, 109th CIC Det, was interviewed on 18 Jan 49 and stated that he, too, had seen the "thing in the sky" as outlined in the news story. He stated that it was unquestionably a very high flying aircraft with concomitant vapor trail.

[REDACTED] who lives 8 miles from Lexington on the Richmond Road stated that he saw a small plane emitting smoke going toward Winchester about 4:30 P. M., 16 Jan 49. He said the fiery-colored smoke trail remained visible several minutes.

[REDACTED], [REDACTED], said he was returning to Louisville on State Highway, 169 between Richmond & Nicholasville when he first observed the plane flying at a high altitude. He thought that it was a sky-writing airplane trailing smoke.



#### ~~NARRATIVE~~ NARRATIVE SUMMARY

About 1630 hours on 16 Jan 49 Mr. [REDACTED] on one occasion when he gazed at the sky noted a "vapor streak" building up. The streak was forming in a manner similar to that used in ejecting smoke in "sky writing". The building up process was observed for a period of approximately three minutes and then was lost behind the clouds. The streak formed on a bearing between ten and twenty degrees south of east and appeared to be climbing during the period of motion observed. The altitude of the "vapor streak" was not less than 15,000 feet and appeared to be at an angle of approximately 70° from the horizon. [REDACTED] stated that he had seen numerous "vapor streaks" from both the air and ground during his period of service as a paratrooper in the European Theater and had given the sight no further consideration.

Incident #237 -- Bourbon County, Kentucky -- 16 January 1949

There is some confusion as to whether the object or the smoke trail reported in this incident was visible for fifteen minutes. If the object itself was, it could not have been a meteor, but the gist of the report seems to indicate that only the trail was visible for any length of time. In that case, it could have been either the trail from a meteor or the vapor trail from an aircraft: the description is not sufficient to distinguish the two. Other observers (not those reporting the incident) indicated that the object was a high flying plane with a vapor trail, but this does not necessarily exclude the meteoric hypothesis, because of the general unfamiliarity of the public with such phenomena.

REFERENCE Telephone call from Captain B. Sneider, Technical Intelligence Division, HQ AMC, to Major Farrell, 5D-OSI, on 21 October 1948

SYNOPSIS

This investigation was requested by Captain B. Sneider, Technical Intelligence Division, HQ AMC, whose Section is charged with the investigation of unidentified aerial objects. At 1630 hours on 16 January 1949, Mr. [REDACTED] of Paris, Kentucky, saw a walnut shaped object emerging from behind a cloud, which object remained in sight for less than a minute. A "tube of light" remaining behind the object was photographed by Mrs. [REDACTED], wife of Mr. [REDACTED]. Also at 1630 hours on 16 January 1949, Mr. [REDACTED] of Paris, Kentucky, noted a vapor streak building up for approximately 3 minutes, and which appeared to be climbing. At 1630 hours on 16 January 1949, a Mr. [REDACTED] of Paris, Kentucky, also saw a vapor trail, the source of which was not visible from the ground.

DETAILS:AT PARIS, KENTUCKY

1. Mr. [REDACTED] Street, Paris, Ky., was interviewed on 26 January 1949 and stated, in substance, that at approximately 1630 hours on 16 January 1949, he was proceeding in his automobile in a southwesterly direction, towards Paris, Ky., accompanied by his wife, Mrs. [REDACTED], and his niece, [REDACTED] St., Lexington, Ky. Mrs. [REDACTED] called his attention to the sunlight reflected on the clouds in the western sky, and as he gazed into the sky, his attention was attracted to a walnut shaped object emerging from behind a cloud. Sight of this object emerging from obscurity into reflected light was maintained for less than one minute. Attention was then focused on a "tube of light" that remained behind as the object moved across the sky. Mrs. [REDACTED] made four exposures of the "tube of light" during its progress. Mr. [REDACTED] described the course of the object as steady and as though some object on an outward sweeping arc had crossed his field of vision at a great distance from the earth. The fourth and last exposure of the "tube of light" fully extended, as published in the Nicholas County Star and the Kentuckian-Citizen, is attached hereto as Exhibit "A". The photograph is accompanied by an article written by Mr. [REDACTED]. Specific answers to essential elements of information, furnished by Mr. [REDACTED] is attached hereto as Exhibit "B".

Mr. [REDACTED], Paris, Ky., was interviewed on 26 January 1949, and stated, in substance, that he was in the yard of his residence about 1630 hours on 16 January 1949 and on one occasion when he gazed at the sky, he noted a "vapor streak" building up. The streak was forming in a manner similar to that used in ejecting smoke in "sky writing." The building up process was observed for a period of approximately three minutes and then was lost behind the clouds. The streak formed on a bearing between ten and twenty degrees south of east, and appeared to be climbing during the period of motion observed. The altitude of the "vapor streak" was not less than 15,000 feet and appeared to be at an angle of approximately 70 degrees from the horizon. Mr. [REDACTED] stated that he had seen numerous "vapor streaks" from both the air and ground during his period of service as a paratrooper in the European Theater and had given the sight no further consideration. Specific answers to essential elements of information, furnished by Mr. [REDACTED] is attached hereto as Exhibit "C".

2 37 3. Mr. [REDACTED] Street, Paris, Ky., was interviewed on 26 January 1949 at the Paris Airport, and stated in substance, that he was standing in front of the Operations Office of the Airport about 1630 hours on 16 January 1949, and someone in the immediate vicinity mentioned that a vapor trail was forming in the sky. On looking in the indicated direction, he saw a "vapor trail" building up between 25,000 and 30,000 feet over a formation of Cirrus clouds and moving in a southeast direction. The position of the

"vapor trail" was at an angle of approximately fifty degrees from the horizon when first observed. The source was not visible from the ground due to the altitude of the trail. The speed, in Mr. [REDACTED] estimation, based on time required to traverse horizon to horizon, was greater than a gasoline propelled craft, and he automatically thought the trail was formed by an Army or Navy jet propelled craft. Mr. [REDACTED] stated that he was familiar with "vapor trails" from both the air and ground and he had seen innumerable such trails during his service as a B-24 Pilot in the European Theater. Mr. [REDACTED] further stated that he is presently employed as Manager of the Paris Airport. Specific answers to essential elements of information, furnished by Mr. [REDACTED], are attached hereto as Exhibit "D". Attached hereto as Exhibit "E" is an unsworn statement furnished by Mr. [REDACTED], in support of the above interview.

4. A review of the files by the Officer in Charge, Weather Detachment, Godman AFB, on 3 February 1949 indicated the teletype sequence of weather as of 1630 hours, 16 January 1949 to be as follows:

A review of the files made by the Officer in Charge, Weather Detachment, Godman AFB, on 3 February 1949 indicated the Winds Aloft Report of 16 January 1949, to show winds 60 miles per hour, southwest, at 20,000 feet increasing to 100 miles per hour at 35,000 feet.

AT LEXINGTON, KENTUCKY

5. A review of files made by the weather office, Lexington Airport on 6 February 1949 indicated the teletype sequence of weather as of 1630 hours on 16 January 1949 to be as follows:

A check of the files of the weather office, Lexington Airport on 6 February 1949 showed the winds aloft on 16 January 1949 to be southwest, 35 miles per hour at 10,000 feet increasing to 60 miles per hour at 20,000 feet and 60 miles per hour, southwest, at 20,000 feet increasing to 100 miles per hour at 35,000 feet.

GENERAL WEATHER CHECK FOR STATE OF KENTUCKY

6. The weather reports for 16 January 1949 showed conditions in the State of Kentucky to be generally overcast with rain. Occasional breaks occurred in the overcast at which time the ceiling was estimated at 5,000 feet. Winds aloft reports showed a velocity of 35 miles per hour at 10,000 feet progressing to 100 miles per hour at 35,000 feet.
