On Sunday night, April 3rd, 1949, Mr. ██████████, patrolman of the Border Patrol, U.S. Immigration Service, came to my home to report the following:

A Mr. ██████████ and a Mr. ██████████ reported to Mr. ██████████ that on Thursday, 31 March 1949, Mr. ██████████ heard a plane overhead and missing. He next heard a very heavy explosion and thought that a plane had crashed. The time of day or night is not fixed in this second hand report.

The following day, Mr. ██████████ and Mr. ██████████ rode on horseback to the site of the explosion and described a swath in the brush and timber culminating in a huge crater. Mr. ██████████ described a piece of metal about 12 inches in diameter and pointed. He felt it was some kind of a "war head" for a guided missile. Nothing resembling a plane was found.

The site of the explosion is described as wild mountainous country, about ten miles east of Rodeo, New Mexico and about five miles from the ranches of Mr. ██████████ and Mr. ██████████. The nearest emergency landing field by plane is said to be at Rodeo. The site is about seventy-five miles by automobile from Douglas.

Mr. ██████████, Border Patrol, phone Douglas 126 can guide anyone to the ranch of Mr. ██████████ or Mr. ██████████ and from there, either of these persons can guide a party to the explosion site.

It is suggested that Davis Monthan Air Force Base, conduct further investigation.

1. Reference is made to letter, your headquarters, dated 5 August 1949, in which request is made for results of investigation of an alleged crash of an unidentified aerial object ten miles east of Rodeo, New Mexico on 31 March 1949.

2. At the time of the occurrence it was determined from Mr. [REDACTED], Rancher, Douglas, Arizona, who was approximately one (1) mile away at the time of the explosion, that there were five B-29 type aircraft over head. [REDACTED] E, 1st Lt, [REDACTED] 4, 97th Supply Squadron, Biggs Air Force Base, advised that the fragments and fuse of the exploded bomb were from a 100 or 150 pound bomb, similar to the practice bombs used by the United States Air Force.

3. Inasmuch as the preliminary investigation by both this office and the Federal Bureau of Investigation revealed the explosion to have been caused by the detonation of a practice type bomb, used by the United States Air Force, no further investigation was conducted.
