6. Number of objects and sketch of formation or grouping.

- a. First group - Eleven in this group. This group went directly overhead - heading due West. A noise which sounded like a group of ducks coming in to land on water or an air hose, drew the attention of the Informants to the group passing over. However, the noise which they heard did not come from this group.
- b. Second group - Nine in this group. Passed overhead about 2 to 3 minutes after the first group. This group approached from the East and was headed due West. Then they were directly overhead one pulled off to the left side of the formation at a 45° angle and proceeded Southwest. The other eight objects in the formation continued on due West. This group was in sight from five to ten seconds.
- c. After they had gotten into the boat and proceeded out into the lake, 8 or 10 more groups passed directly overhead. There were two or objects in each group, and they approached from the West headed due East.
- d. The last group passed slightly to the east of them, and were heading due South. They approached from the North. There were five objects in the group and they were in line (one behind the other).

Dear Sir:

Dr. La Pas I am writing to you because you happen to be the only person of whom I know in the State of New Mexico who is, in the interest of science, interested in unusual occurrences or manifestations. I have read of you excavating the meteorite that fell in Nebraska and of your interest in that field.

Dr. La Pas I am 25 years old and do consider myself a rather young man, but the strange sights I have just seen make me wonder.

I am writing you for information about certain "objects" which have been reported from time to time and have been called "Flying Cruisers".

On the morning of April 25, 1949, at 6:30, Mr. [redacted] and myself were in the process of seining for minnows to use for fishing, we were at Springer Lake which is (4) four miles NW from the town of Springer, N. M.

We had just finished putting the minnows we were going to use in the bucket and we heard a peculiar sound, sort of a high pitched whistle. We both thought it was some high flying ducks coming in for a landing and we looked up in the air. What we saw was certainly not ducks, but what it was we don't know.

We saw "objects" which were silvery white, in color and to us what looked like balls, sort of like Christmas tree ornaments. They passed us at a very high altitude and going very fast. They were out of sight in a very few seconds.

I was an Army Pilot during the war and I know they were not "jet Planes" or "guided missiles". Whatever these "things" were they were traveling faster than sound. I know that because we were hearing the sound of the objects we had not seen and looking at others whose sound had not yet reached us.

This may sound a bit on the fantastic side, but it is what we actually observed. We saw these things for over an hour. I am enclosing a sketch of the behavior of the "objects" just as we both saw them.

We wondering if anyone else has reported seeing these "things" on or approximately the date mentioned? I might add that the day was CAVU ceiling and Visibility Unlimited and we would never have seen the objects except for the sound we heard.

Dr. La Pas I would like an answer from you if you can spare the time, all this is very strange to us and maybe you can supply the answer to it.

Due West



First time we saw the "objects", heading due west at an extremely high altitude and at a very high rate of speed, they were not in sight over 10 seconds. They passed directly overhead. Time 6:30 in the morning. They were in a tight group as shown at left, eleven in group.

Due West



About 10 minutes later we observed another flight of these "objects" heading due west very high and fast. When directly overhead the last one on the left suddenly left the rest and headed southwest. All went out of sight in a very few seconds. Nine in group.



Due West

At approx. 7:00 we saw two more "objects" heading due east in the same manner as the others we had seen. These were much farther apart than the first ones we had seen.

South



The last large "formation" we saw passed due east from us and heading south. They were strung out in a line going very fast and low but at quite a distance from us. All these "objects" made a peculiar sound like a high pitched whistle. The sound was some distance behind the objects. Five in line.
