(17) On 23 May 1949, Dr. [REDACTED] Moorehead Planetarium, University of North Carolina, Chapel Hill, N. C., was interviewed in regards to any unusual occurrences that might have taken place in the skies on or about 7 Apr 1949. He stated that he had neither seen or heard of anything that might be construed as even slightly unusual either before, on, or after the time in question. Likewise, none of his associates have reported to him anything of an unusual nature. He was equally positive that if anything out of the ordinary had occurred, he would have been one of the first to know about it. (B-2)

AGENTS NOTE: Dr. [REDACTED] gave the appearance of an intelligent man who knows whereof he speaks. In parting, he said he would report to this office, immediately, anything of an unusual nature that might occur. He is more than willing to cooperate in any manner what-so-ever.

(14) On 19 May 1949, Professor [redacted], Wake Forest, N. C., Astronomy Professor, and in charge of the 6" telescope at Wake Forest College was interviewed concerning SUBJECT. Professor [redacted] stated that nothing of an unusual nature on or about 7 April 1949, has been brought to his attention, nor has he heard of any unusual craft in the skies. (B-2)

(15) On 24 May 1949, Mr. [redacted], Hi-Y A. C. (Amateur Club) YMCA, Rocky Mount, N. C., home address of [redacted] was interviewed concerning SUBJECT. Mr. [redacted] stated that the Hi-Y Amateur Club has not been functioning for the past several months, and that he has not heard or seen any UNUSUAL craft in the skies, on or about 7 April 1949, or any other time. (16) On 24 May 1949, Professor [redacted], Atlantic Christian College, Wilson, N. C., part-time instructor in astronomy, was interviewed concerning SUBJECT, with negative results. Professor [redacted] stated that he has not seen, or heard of, any unusual craft in the skies, on or about 7 April 1949, or any other time. (B-2)

AGENT'S NOTE: All informants above are men of above the average intelligence, and stated that they would gladly report to this Office any unusual craft that might appear in the skies, or any report of same that might reach them.

(12) On the night of 25 May 1949, at approximately 2030 hours, Mr. [redacted], Stadium Manager, City Parks and Recreation Commission, turned on the same lights which were used at the stadium during the Rodeo on 7 April 1949 and Mr. [redacted] and Mr. [redacted] made observations from approximately the same position in the stadium which they had occupied on the above mentioned night. The Pyrex insulator described above cast an unusual and weird reflection of the lights and this agent noted that the wire on which it is located was not visible at night and that it would be difficult for a person to get a clear perception of its height. Mr. [redacted] and Mr. [redacted] expressed amazement at the above object, stating that it was in the same location and presented the same appearance as when observed on the night of 7 April 1949, and advised that there is absolutely no question but that this is the object which they previously reported. (Reference Exhibits "A" and "B"). (1-2)

Agent's Note: This agent received the impression that the above person were completely sincere in their statements regarding the above incident and were honestly "fooled" by the unusual effect of light on the appearance of the above object. Mr. [redacted] could not be present on the above date as he was out of town in connection with the operation of his air port.

(10) On 20 May 1949, Mr. [redacted] on, Proprietor, Plaza Airport, Charlotte, N.C., stated that the above mentioned object was pointed out to him by Mr. [redacted] when he was attending the Rodeo at the Memorial Stadium on the night of 7 April 1949 and that after observing it for a short time he visited the office of the Charlotte Observer and reported it to Mr. Granbery Dickson, Reporter, for the above newspaper, who prepared the article which appeared in the above newspaper on 8 April 1949. Mr. [redacted] advised that he was sitting near Mr. [redacted] in the stadium and gave a similar description of the above object as given by Mr. [redacted] and Mr. [redacted]. He stated that the object may have been as low as one thousand (1,000) feet but that it appeared much higher to him and that he still does not know what it could have been. He advised that it did not move during the time he saw it at the stadium and that he thought he observed it disappear after he reached the observer building but is not certain that what he saw at that time was the above object. The above object defied identification according to Mr. [redacted] but based on the short period that he observed it he is satisfied that it was not aircraft. He stated that the above incident was not a "publicity stunt"; that he has no idea as to the identity of the above object; that it was very difficult to estimate its height, and that he does not know the names of any other persons who observed it except those persons listed above. Mr. [redacted] stated further that at the time the above observation was made the sky was clear and the moon was shining brightly. (P-3)

Agent's Note: This agent received the impression during the interview with Mr. [redacted] that he obviously used his imagination in elaborating on this incident in his report to the newspaper, in order to obtain publicity, but that he is sincere in his statement that he was unable to identify the above mentioned object.

(11) On 24 May 1949, Mr. [redacted], 1411 Thomas Ave., Charlotte, N.C., accompanied this agent to the Memorial Stadium and the above mentioned insulator, which extends across the stadium in approximately the same direction as the object which he reported, was pointed out to him. He stated that the insulator is located in almost the exact direction, angle at which he observed the unidentified object on the night of 7 April 1949, but that he is convinced that the above insulator could not possibly present the appearance of the object which he observed as previously reported. He agreed to observe the above insulator under similar conditions as existed on the night of 7 April 1949, stating that he would be glad to cooperate and that he is very anxious to receive any information regarding the above incident in order to "ease his own mind" in this matter. He concluded by stating that he would be willing to take an oath that the object which he saw was several thousand feet in height and that if the above equipment has anything to do with the object which he saw he "expects to go to see a doctor".

(7) On 20 May 1949, Mr. [REDACTED] Soule Steel and Iron Co., N. Church St., Charlotte, N.C., stated that he was the member of the Charlotte Junior Chamber of Commerce who had charge of the "props" and stadium arrangements during the Southeastern Championship Rodeo which was sponsored by the above organization at the Memorial Stadium. He advised that he attended the above rodeo during all performances with the exception of one night performance and that he did not observe any unidentified object or light in the vicinity of the stadium and received no reports regarding the presence of any such object. He advised that he is positive that no lighted balloon or other objects were used by the management of the Rodeo, which would give the appearance of a light or unidentified object in the sky. (B-2)

(8) On 20 May 1949, Mr. [REDACTED] Athletic Director and Stadium Manager, City Parks and Recreation Commission, Charlotte, N.C. stated that he has not heard of any unidentified object having been sighted over the stadium and that there has been no changes in the lighting facilities or various wires located around the stadium since before the night football games were held there. He could not explain such a report in connection with the equipment located at the stadium, and advised that he had charge of the lighting and operation of the stadium during the entire period in which the rodeo was held there and attended every performance. (B-2)

(9) On 21 May 1949, Mr. T.C. Wood Jr., Radio Technician (Major, Civil Air Patrol), 1300 E. 5th St., Charlotte, N.C., stated that he is in charge of the Civil Air Patrol radio station which is located in his residence at the above address and that the antennae for the above station extend across the Memorial Stadium which is approximately one block from his residence. There have been no changes in this equipment during the past year and there has never been any electric current on these wires, which could account for a spark or short circuit. He advised that there are two of the antennae and that one extends across the stadium in the direction of approximately 55 degrees from North. This antennae is fastened to the top of poles which are approximately 45 feet high and are located on the highest ledge around the stadium, approximately 50 feet above the ground in the stadium floor. The antenna itself is approximately 276 feet long and is connected to a cable approximately 60 feet long which extends from the Northeast end, by an insulator which is approximately twelve (12) inches long and is made of Pyrex. Mr. Wood advised that no lights whatsoever appear on the above antennae and stated that he does not know whether the above mentioned insulator could reflect light. He further stated that he knows of nothing in connection with the above equipment which would present an unusual appearance at night, and that he has received no reports regarding an unidentified object being sighted in the vicinity. was made to verify this report from other sources with the exception that he telephoned Mr. [REDACTED], [REDACTED], Charlotte, N.C. later on the night of 7 April 1949, and he gave somewhat similar information as furnished by Mr. [REDACTED]. He recalls Mr. [REDACTED] having stated during the above meeting that although the above object was very confusing to him, he would guess that if it was some type of aircraft it would be large enough to carry approximately twenty (20) passengers. Mr. [REDACTED] stated that [REDACTED] appeared to be very excited regarding the above observation; that based on his previous contacts with him he considers him to be an excitable type of person and his desire for newspaper publicity is well known to Mr. [REDACTED] that he gave credence to the report in view of the fact that [REDACTED] was willing to leave the rodeo in order to make the above report and in view of the fact that his telephone conversation with Mr. [REDACTED] tended to confirm the information which he gave. Mr. [REDACTED] stated that he knows of no other persons who might have observed the above object, and that [REDACTED] impressed him as being sincere and as making the above report in good faith. In his past dealings with the above newspaper [REDACTED] has always been honest and reliable according to Mr. [REDACTED].

(4) On 21 May 1949, Mr. Sturkey and Miss Altman, Operators, Morris Field Radio Control Tower, Charlotte, N.C., stated that the above office did not receive any reports of unidentified aircraft or objects in the air in the vicinity of Charlotte, N.C. on 7 April 1949, and also that they have received no inquiries regarding any such object. (3-2)

(5) On 21 May 1949, Mr. Spencer, Observer, U.S. Weather Bureau Station, Morris Field, Charlotte, N.C., stated that the above office neither observed nor received reports of any celestial phenomenon or unidentified objects appearing near Charlotte, N.C. on 7 April 1949. Mr. Spencer stated that the Weather Station at Charlotte, N.C. does not use weather balloons and that the nearest weather station which does use balloons in making weather observations is located at Greensboro, N.C. approximately one hundred (100) miles away. He advised that the above office has received no information which could explain any report of an unidentified object over the city on the night of 7 April 1949. (3-2)

(6) On 21 May 1949, Mr. Joe Crosby Jr., C.A.A. Communications Office, Morris Field, Charlotte, N.C., stated that the above office has received no information regarding unidentified aircraft or objects in the air near Charlotte, N.C. on 7 April 1949 and that he has no information which would explain a report of any such object. (1) On 20 May 1949, Mr. [redacted], Painter, [redacted] Charlotte, N.C., stated that, to the best of his knowledge, he was the first person to observe the unidentified object which was seen from the Memorial Stadium on the night of 7 April 1949, and that he immediately pointed it out to his brother-in-law, Mr. [redacted] who was sitting next to him and later showed it to Mr. [redacted]. He first observed the object a few minutes after he had taken his seat at the stadium when he happened to look towards the sky. He was sitting on the North side of the stadium and the object was observed at an angle of approximately 150 Degrees from North and approximately 75 degrees above the horizon. He watched the object intermittently during the game and stated that he could never decide what type of object it was. It appeared to be cylindrical or oblong in shape and appeared to be lighted with a steady or constant amber light which was brighter at some points along the side of the object than at others, and appeared to be brighter at the northeastern end. He could observe the side of the object from where he was sitting and advised that the object apparently was pointed lengthwise in the direction of Northeast and Southwest, with the line of his vision forming almost a 90 degree angle with its axis. He advised that he paid more attention to this object than he did to the show and estimated that he first observed it at approximately 2015 hours and that it was still there when he left the stadium after the show at approximately 2230. When he had walked several blocks from the stadium in a Northerly direction on his way home he stopped and observed the sky to see if the object was still visible but could not locate it. The object did not move in any direction during all of the period that he observed it and he did not see it appear or disappear. Mr. [redacted] stated that the above object impressed him as being about half the diameter and length of his "little finger" when observed at arms length and that he was of the opinion that it was possibly 20,000 feet in height but that it may have been only several thousand feet high as it was very difficult to estimate its height. He stated that he is an amateur airplane pilot; that he received a student license and flew for pleasure over a period of several years during the past few years. He has not flown for approximately the last year and although he has logged approximately 75 hours flying time has never received a Private Pilot License. He was wearing his regular eye glasses at the time the above observation was made and stated that viewing this object "upset" him as he has never been able to decide what it was. After he showed this object to Mr. [redacted] he remarked to Mr. [redacted] that it was probably a mistake to have told him about it as, according to Mr. [redacted], [redacted] is well known in local flying circles as an avid "publicity hound", going to extremes to obtain publicity. [redacted] did not remain at the stadium but a few minutes after the object was pointed out to him and Mr. [redacted] assured that he went to the office of the Charlotte Observer to report the incident as Mr. [redacted], reporter for the above paper, telephoned him at his home later in the evening to verify information given him by [redacted].

that the object was pointed out to Mr. [redacted] at approximately 2130 and that he observed it for less than ten minutes before leaving. He advised that a number of other persons sitting near him in the stadium observed the object but that he does not know the identity of any of them except as mentioned above. Mr. [redacted] advised that he is still mystified by the above object and has never observed anything like it before. (B-3)

(2) On 20 May 1949, Mr. [redacted] U.S. Post Office, Charlotte, N.C., [redacted] stated that the above mentioned object was pointed out to him by his brother-in-law, Mr. [redacted], at approximately 2015 on the night of 7 April 1949, a few minutes after they had taken their seats at the Stadium. They were sitting on the North side of the stadium and he described the object as having been observed in approximately the same location as described by Mr. [redacted] with the exception that he estimated its height as being less than one thousand (1,000) feet or possibly twice as high as the Liberty Life Building, Charlotte, N.C. which is twenty (20) floors high. His description of the object was substantially the same as that given by Mr. [redacted], above, and he advised that it did not move and was visible until they left the stadium. After they had walked several blocks from the stadium in a northerly direction they attempted to locate the object in the sky but were unable to do so. After Mr. [redacted] first saw the object, and while they were at the stadium he noticed approximately twelve (12) other persons observing the object and making comments regarding it. To the best of his knowledge none of them could decide what it was and he has not come to any conclusion yet as to the identity of the above object, although he spent considerable time during the rodeo on the above mentioned night, observing it. (B-3)

(3) On 20 May 1949, Mr. [redacted], Reporter, Charlotte Observer, Charlotte, N.C., stated that he wrote the article which appeared in the above newspaper on 8 April 1949, regarding the unidentified object observed from Memorial Stadium on the night of 7 April 1949. He advised that Mr. [redacted], Proprietor of the [redacted], Charlotte, N.C. came to his newspaper office around 2145 hours on the night of 7 April 1949 and gave him information which was published in the above article. Mr. [redacted] told him that he was attending the Southeastern Championship Rodeo at the time the unidentified object was observed and left the Rodeo in order to report the above information. Mr. [redacted] and Mr. [redacted] then observed the sky in the direction of the Memorial Stadium from the second floor of the Observer Building but noticed no such object as described by Mr. [redacted]. He stated that he has received no further information or reports regarding the above incident and that [redacted]

NARRATIVE SUMMARY:

On 25 May 1949, Mr. [REDACTED], Proprietor, Plaza Airport, Charlotte, N. C., stated that the above mentioned object was pointed out to him by Mr. [REDACTED] when he was attending the Rodeo at the Memorial Stadium on the night of 7 April 1949 and that after observing it for a short time he visited the office of the Charlotte Observer and reported it to Mr. [REDACTED], Reporter, for the above newspaper, who prepared the article which appeared in the above newspaper on 8 April 1949. Mr. [REDACTED] advised that he was sitting near Mr. [REDACTED] in the stadium and gave a similar description of the above object as given by Mr. [REDACTED] and Mr. [REDACTED]. He stated that the object may have been as low as one thousand (1,000) feet but that it appeared much higher to him and that he still does not know what it could have been. He advised that it did not move during the time he saw it at the stadium and that he thought he observed it disappear after he reached the observer building but is not certain that what he saw at that time was the above object. SYNOPSIS: Unidentified object as reported in the Charlotte Observer, Charlotte, North Carolina, on 8 April 1949 was first sighted by a Mr. [REDACTED] at 2130 on the night of 7 April 1949 while attending a rodeo at Memorial Stadium, Charlotte, North Carolina (1). It was also observed by a Mr. [REDACTED] and Mr. [REDACTED] (8, 10). It was reported to Mr. Granbery Dickson, Reporter, Charlotte Observer, by Mr. [REDACTED] who has a reputation of being an avid "Publicity Hound," and who would go to extremes to obtain publicity (1, 3). On the night of 25 May 1949, Mr. [REDACTED] and Mr. [REDACTED], accompanied by a CIC Agent from the 11th CIC Detachment returned to Memorial Stadium and had the lights turned on.
