A telephone call came in from Dalton, Georgia., Mr. ~~██████████~~ ~~██████████~~, 200 miles N WRB. He reported an aircraft passing over his driveway when he was backing out flying very low. He could see the navigation lights Red and Green. The plane made no sound and was gone in one (1) second. He jumped out of the car. His two (2) children fourteen (14) and sixteen (16) years of age also saw it. He was told to report it to WRB Field. He said all other aircraft flying over that area want N & S. This aircraft was flying E to W very low. There was no obstruction of trees or houses in the line of flight.

The man said he sold cars at Dalton and could be reached there.

I reported this to the Superintendent of Flight Service and they said they would look into it. His initials XX.
