(Nunavut) 1998 - The body of Grace Lee, 26, who went missing in April, was found shot dead on the Bering Sea near the Canadian coast. Siberian tundra north of the Arctic Circle, Alaska, USA.

Whitaker started his flight from Yokohama on September 12, 1931, at 10:30 A.M. He reached Tokyo at 10:30 P.M., having covered 1,000 miles in 14 hours.
