1. An unidentified flying object was observed at 1950 hours, 13 October 1950 by [REDACTED], navigator, and [REDACTED], supply technician, both of March Air Force Base. Said object was observed from the "Dusty Acres" area, this base.

2. The object was a bright-reddish cast, unsteady in intensity, and shaped similar to a planet. It was observed at 80° azimuth from the observers and appeared on a true course of 180° at a great distance for a period of five (5) minutes at great speed before it faded out.

3. Witnesses ruled out the possibility of object being a star, planet, or meteor because it neither maintained a fixed position nor followed a constant path. The speed and maneuvering of the object ruled out the possibility of its being a balloon. The apparent great altitude and speed, plus remarkable maneuvering of the object seemed to indicate to the witnesses that it was not a conventional aircraft. In short, the object's movements were erratic.

1. The following is an account of an observation of an unidentified aerial object sighted from a position of 33° 53' 30" N, 117° 15' 30" W, at approximately 0350 GCT, 14 October 1950. The sighting was made by a USAF officer-navigator during a period of celestial navigation.

- a. Number : One
- b. Shape : Round, similar to that of a planet.
- c. Size : Approximately that of a planet.
- d. Color : Luminous, bright red, unsteady in intensity, somewhat similar to an aircraft's exhaust flame.
- e. Speed : Undetermined, but appeared to be great.
- f. Heading : 180° true course.
- g. Maneuverability: Object seemed to accomplish every maneuver and combination thereof known to witness.
- h. Altitude: Undetermined, but appeared to be at a very great altitude as though within the celestial sphere.
- i. Sound : None.
- j. Exhaust trail: None."

2. The weather prevailing at the time of the observation was: Clear skies, with but slight haze and slight surface fog. Surface winds and winds aloft were not determined.

3. While the object observed resembled somewhat a meteor, this possibility was ruled out because the object did not follow a constant path. The apparently high altitude, the high speed and erratic movements of the object would suggest that it was other than a conventional type aircraft.

4. Apparent confirmation of the observation is furnished by a USAF sergeant who reports having observed a similar object.
