1. On Thursday morning 15 March 1951 an object was sighted by Mr. [redacted], the chief aerial engineer of the [redacted], along with his assistants, Mr. [redacted] and Mr. [redacted]. Also some twenty other mechanics and helpers professed to have witnessed this object. When interviewed by the reporting officer the stories were all the same. Dr. P. Nilakantan, educated at California Institute of Technology and now Director of the Research and Development Laboratory of the Director General of Civil Aviation agency in India, accompanied the reporting officer while interviewing these people. Dr. Nilakantan recommended Mr. [redacted] as one of the best aerial engineers in India.

2. The object sighted was shaped like a cigar with no outer visible control surfaces. It was about one hundred feet long and as big around as a C-47 fuselage, bare metal color and only one object sighted. The exhaust was described as white except when its speed was increased; then the exhaust turned black. Mr. [redacted] estimated the speed to be about three times greater than cruising speed of a British Vampire. The object came over Safdarjang Airdrome, New Delhi (28°25'N) (77°12'E) from the north at about four to five thousand feet high, made one pass over the field to the south, then came back over the field in a very large loop. At the top of the loop it was out of sight but came into sight again in its dive. Upon recovering straight and level flight it proceeded out of sight travelling in a south-westerly direction at very high speed. The exhaust smoke stayed visible in the sky for over twenty minutes. The object was sighted at 1020 local time and was observed for approximately seven minutes. The observers were on a taxi strip working when the object was sighted. The weather at the time of sighting was clear, sun shining with thirty mile visibility. Surface wind was from 300 degrees at fifteen to twenty knots.

Call it what you like---a Flying Saucer, a Suicide Bomb, or a Pink Elephant. So what you may - that I must have had one over the mark and what I saw were the effects of the morning after the night before, but, whatever you say think or say is ruled out by the fact that what I and many others saw was certainly something out of the ordinary.

Before I say any more I would like to mention that I have been associated with aeronautics for over twenty years. I am an Aeronautical Engineer and a Pilot and without exaggeration my eyes and ears are so trained that should there be any unusual sound or irregularity in the sky, before you could say knife my attention would be attracted to it.

On Thursday morning the 13th March, 1951, at 10.30 hours Indian Standard Time I was standing by my car which was being serviced by three mechanics and Mr. [REDACTED], a young lad who recently qualified as an engineer. All of a sudden my attention was drawn to a whitish, swirly cloud suddenly appearing in the sky from North to South about seven hundred feet in length and approximately four to five thousand feet high quite near the Delhi Flying Club Hangar. I immediately called out Mr. [REDACTED], showed him the strange cloud and said what in the hell is that? Before he could say anything the cloud increased in length and then at the end of it appeared a bullet nosed shape with a whitish tail approximately 100 ft. long. On seeing this we shouted out to all those (mechanics, cleaners, and electricians) working in the hangar. About 17 to 20 people rushed out and saw it. I must not omit to say that all those who saw it with me have been in the aeronautical line for 3 years and over. The object made no sound whatever and it proceeded South. After travelling in this direction for 3 minutes it made a loop or (what looked like a loop from a distance) at the top of the loop we could clearly see a silver-coloured bullet nosed shape glittering in the sky which seemed to be some sort of metal. At the end of the nose there was a line of Crimson Red colour followed by a whitish tail. I give below a rough sketch.

After completing the loop it headed south-west leaving a swirling whitish cloud similar to the one left over the aerodrome. The object was

only visible to all of us for a little over 7½ minutes. 4

To be a little more descriptive I must say that this peculiar object travels at varying speeds and alters its course in such a manner that it appears to be under a manual or wireless control. While travelling at slow speeds it does not smoke trail but when it accelerates it leaves a black smoke trail which turns into a whitish swirly cloud which denotes as if left by a turbine.

I estimate that when travelling at top speed the so called Flying Saucer is travelling at a speed of 2,000 miles per hour.

I do not understand why it is called a Flying Saucer as it is not shaped like a saucer but more like a Cigar. Perhaps when this object is viewed from the underside it may have the shape of a Saucer.
