Platillos voladores sobre la Selva Peruana

Junto con la foto que publicamos arriba, hemos recibido copia del siguiente despacho radiotelegráfico transmitido desde la hacienda Iberia a Lima por el servicio interno de la Corporación Peruana del Amazonas:

"El dia 19 de julio, a las 4 y 50 de la tarde, cruzó el cielo de Iberia (departamento de Madre de Dios) un disco luminoso con núcleo o cabeza de color azul eléctrico intenso y estela luminosa con su comienzo amarillo, terminando en un color anaranjado intenso. La dirección fué de Sur a Norte, visible de uno a dos minutos, dejando una estela vaporosa, espesa, que quedó flotante por más de quince minutos. La altura a que iba esa más o menos de 2.500 a 3.000 pies; a plena luz solar. Durante su recorrido, la instalación

servicio de radio de la Corporación Peruana del Amazonas se paralizó, no funcionó ni para transmitir ni para recibir señal alguna".

Nuestro informante añade que dicho disco fué observado en Maldonado, capital de Madre de Dios, a las 4.55 de la tarde del mismo dia. La distancia entre Iberia y Maldonado es de ochenta millas, lo que quiere decir que el recorrido lo hizo este disco en cinco minutos. Un avión de tipo corriente hace igual recorrido en 50 minutos.

En nuestra edición matinal del veinte de julio último, publicamos un despacho enviado por el correspondiente de "El Comercio" en Puerto Maldonado en el que se daba cuenta del paso del platillo volante, con idénticos pormenores, agregándose que más de trescientas personas

pudieron observarlo. Ahora nos llega, confirmando gráficamente la noticia y por primera vez en informaciones de esta índole, una foto del extraño artefacto, cuyas características no es fácil apreciar, pero si sus dimensiones y la extensión que lleva a su paso, como si se desplazara en el espacio por el sistema de propulsión a cho-

The following is an exact translation of an article appearing in a Lima daily newspaper of 15 August 1951:

"Together with the photograph printed above, we have received a copy of the following telegram transmitted from the Hacienda Iberia to Lima by the Peruvian Corporation of the Amazon:

'On July 19th at 4:50 PM a luminous disc was seen over Iberia (Department of Madre de Dios). The color of the head or nucleus of this disc was an intense orange. The direction was south to north; was visible from 1 to 2 minutes, leaving a thick vaporous trail which floated for more than 15 minutes. The altitude was more or less 2500 to 3000 feet. It was seen in broad daylight. During its passage, the Peruvian Corporation of the Amazon radio went dead and wasn't able to transmit or receive any signals.'

"Our informer adds that this disc was seen in Maldonado, capitol of Madre de Dios, at 4:55 the same afternoon. The distance between Iberia and Maldonado is 80 miles, which means that it made the trip in 5 minutes. It takes an ordinary plane 50 minutes to make this same trip."

"In our morning edition of July 20th, we published an item, sent by our reporter at Puerto Maldonado, concerning the flying disc, giving identical details, but adding that 300 people had seen it. Confirming this news and for the first time in this kind of information, we have received a photograph of the strange object, the characteristics of which are difficult to determine, but not so the dimensions and the trail that it leaves, as if it were traveling by jet propulsion."

CONTENTS of Preparing Officer:

1. The Peruvian Minister of Education in discussions with Embassy officers subsequent to the publication of the above article, explained that the picture was taken by a teacher in Punto Maldonado near the Bolivian border. According to the Minister, the teacher was having a picnic with a group of friends and, as he was about to take a picture of the group, he noticed something strange flying through the air and lifted his camera in time to snap it.
2. Examination of three (3) different photographs supposedly taken by three (3) separate individuals reveals a fairly clever attempt at trick photography.
3. It is the opinion of the A-2, Peruvian Air Force, that such falsification was for commercial reasons. El Comercio bought the picture and story, and numbers of prints have been sold to the public.
