

SUMMARY OF INFORMATION

Incident report received on 14 November 1951, from Sgt. [redacted] Co. "C", 1st Alaska N. G. Scout Bn, Barrow, Alaska, contains the following information.

On 31 October 1951, between 1530 and 1600 hours a light, similar to that of a spotlight, was seen 1/2 mile Northeast of Point Barrow. Observation of the light lasted for approximately one minute and appeared to be coming from a point just above the horizon. Because of the lights relation to the horizon observer believed it came from a vessel leaving the vicinity of Point Barrow.
