

This is in response to your recent inquiry for an evaluation of an unidentified object sighting you witnessed in 1951.

The Air Force is unable to make any evaluation of your observation although your description contained essential data and was quite clear and explicit.

Attached is the latest Air Force Fact Sheet on the Aerial Phenomena Program. In it is an explanation of why it is sometimes impossible to reach a conclusion on a sighting even though sufficient details are given, and the case remains listed in the "Unidentified" category.

It is regretted that we are unable to give you a definite answer on your query. It may be of interest that in over 8,000 sightings during the past 16 years, there has never been any evidence or indication that Unidentified Flying Objects represent either a threat to the security of the United States or an extraterrestrial vehicle under intelligent control.
