<p>On 13 March 1952 a report was received from Mr. Harry Franken of the Columbus Citizen newspaper in Columbus, Ohio, telephone AD 1111, that an unidentified aerial object was sighted northwest of Columbus between 1815 and 1845 on 12 March 1952. It was traveling SW and made a circle north.</p> <p>Lt R [REDACTED] went to Columbus on 13 March 1952 to interview the observers. At North American, Mr. K [REDACTED]er, [REDACTED] for plant protection, was contacted prior to seeing Mr. G [REDACTED]. Mr. [REDACTED] stated that he also saw the object and had immediately recognized it as a North American B-45 from Lockbourne AFB flying at an altitude of approximately 28000 to 30000 feet. The vapor trail of the aircraft was struck by the rays of the sun, which was setting at the time, giving off an orange or reddish color.
