SUMMARY OF INFORMATION On 19 August 1952, Mr. [redacted] co-owner, Mel-Art Photo, [redacted] Elizabeth, New Jersey, telephoned the Newark Field Office of the 108th CIC Detachment and volunteered the following information to the SAIC:

He has in his possession some pictures belonging to one of his customers, in which certain unidentified objects appear in the sky. These pictures may or may not be of some interest to the G-2. An appointment was made with [redacted] to have an agent contact him personally and obtain details concerning the pictures. (C-3)

On 19 August 1952, Mr. [redacted] co-owner, Mel-Art Photo, [redacted] Elizabeth, New Jersey, volunteered the following information to an agent of the 108th CIC Detachment:

While scanning through the pictures which belonged to one of his customers, a group of four pictures came to his attention because of unusual unidentified objects which appeared in the sky. Since he was associated with the Air Technical Intelligence during World War II, he felt that the pictures may be of some interest to the G-2 and he immediately contacted an Army Captain at the Newark Airport, who in turn referred him to the Office of the CIC. The pictures were taken by an amateur photographer by the name of Mr. [redacted] a chef at the Winfield Scott Hotel, Elizabeth, New Jersey. (C-3)

On 19 August 1952, Mr. [redacted] Cook, Winfield Scott Hotel, Elizabeth, New Jersey, residing at [redacted] Street, Elizabeth, New Jersey, submitted the following information:

The pictures (See Exhibit I) which reveal certain unidentified objects in the sky, were taken at a roughly set time of 2300 hours during the week of 6-12 July 1952. His purpose in taking the pictures was to obtain photos of the moon and it was not until after the film was developed that he became aware of the objects. The initial picture, identified by three spots with trailing lines, was taken with the shutter open for ten minutes. The second picture, identified by three spots, was taken with the shutter open for fifteen minutes. The third picture, identified by the presence of the moon with a spot mid-way between the moon and the tree tops, was taken with the shutter open for twenty minutes. The last and final picture, identified by the presence of the moon with a spot appearing directly under and near the moon, was taken with the shutter open for twenty-three to twenty-five minutes. All pictures were taken within a period of about one hour. A Mercury #2 Camera, single frame, 35mm, was used for all pictures with a shutter opening of 2.7. The camera was mounted on a tripod and the pictures were taken from the roof of his residence with the camera pointed in the general direction of Staten Island, New York. (C-3)

It is apparent from appended statements of witnesses and newspaper articles that no conclusive statements can be made regarding description, location, speed and pertinent or unusual features of the sighted object. Witnesses agree that the object appeared to be a ball of flame which traveled at a high rate of speed. Time of sighting was set at approximately 1030 hours MST, 7 July 1952, and the entire performance was of a few seconds duration.

Manner of observation by all witnesses was visual, with no optical or electronic equipment having been used. One witness (Statement attached as Incl #1) observed the object from the air in a B-26 type aircraft, altitude of 6000 MSL, true air speed 300 MPH.

Location of observers covered a vast area in Utah, Idaho, Oregon, Washington and Nevada with resultant variations in reports of location of the object with respect to observers.

Reliability of witnesses, whose statements are attached as Incls 1 and 2, is considered "reliable."

Weather, at the time of sighting, was clear with surface winds reported of 20 to 30 knots, with gusts to 40 knots from the Northeast in the vicinity of Hill AFB, Utah.

There is no known activity or condition, meteorological or otherwise, which might account for the sighting.

No physical evidence has been discovered nor are photographs available; therefore, no interception or identification action was possible.

The only known air traffic was as reported above.

There is no apparent significance from an intelligence standpoint in this instance.

S T A T E M E N T

At 1030 hours on the morning of 7 July 1952, the undersigned while on a duly authorized test flight in a B-26 type aircraft, observed an aerial phenomenon in the vicinity of Hill AFB, Ogden, Utah. The crew included three civilians, members of the Flight Test Branch; one riding in the Engineer's seat, one in the rear checking radio and armament equipment and one riding in the nose. The weather at the time was clear, visibility over 40 miles with surface winds of 20 to 30 Knots, with gusts to 40 Knots from the Northeast.

The aircraft was departing Hill AFB at an altitude of 6000 MSL, and approximately a  $345^{\circ}$  heading when the undersigned saw a brilliant yellowish, orange flame descending earthward at a near vertical angle. It appeared to be moving from a South to North direction at a very high rate of speed. When first seen by this observer, its azimuth was estimated at approximately  $50^{\circ}$ , and this flame continued until nearly a  $5$  or  $10^{\circ}$  azimuth was reached. Immediately following this flame, and in its place was a bluish, gaseous type cloud which was nearly half the length of the flame. Immediately below the end of the flame and cloud, a dark object was seen to descend earthward at the same trajectory.

The entire performance was at a split-second speed, faster than anything ever seen by this observer. My crew, although they did not see the flash, were able to follow the cloud-type trail, and we expected to see the dark object hit in the adjacent Great Salt Lake or at least the shore immediately North of the estimated position.

In the resultant search, our aircraft traveling at a near 300 MPH true airspeed, could not reach the cloud trail nor see any evidence of an object having struck the ground.

The Hill AFB tower was notified immediately and an extended search of the area by the undersigned revealed little else.

It is the opinion of this observer that he saw a meteorite of better than average size traveling at a rate of speed so great as to preclude the possibility of its being anything else. Also, the distance from the phenomenon indicated the size and brilliance, and is the reason for not being able to see any evidence of this object striking the ground in this area.

S T A T E M E N T

On 7 July at approximately 1030 hours the undersigned was driving his car north on US Highway 89-91, midway between Provo and Pleasant Grove, at a speed of approximately 40 MPH. At approximately 20 to 30 degrees to the left (northwesterly) of his line of sight (north) he saw a flash of light and immediately turning his eyes in the direction of the flash he observed the following at approximately 111 degrees 45 minutes west longitude and 40 degrees 20 minutes north latitude:

The morning sky was clear and blue with the exception of a few scattered clouds on the horizon. Outlined clearly and distinctly against this background was a seething, boiling, turbulent, brilliant orange column of what appeared to be flame which surged upward seemingly to follow the path of descent. The flaming column reminded the undersigned of an oil fire less the smoke and flame color. The brilliant orange color and turbulence comprising the column was more noticeable at its base or earth end, becoming less turbulent and lighter in color as this observer glanced up the column, which tapered in proportion to its length, to the extreme limits of his sight. At an incalculable distance a transparent glow or mist enveloped the column to the extreme limits of this observers sight. The column appeared to be absolutely straight (no breaks or deviations) with a northwesterly inclination of not too great an angle (approximately 15 to 20 degrees). The entire column of turbulence appeared in the sky almost instantaneously which to this observer was indicative of something traveling at a terrific speed. The undersigned saw no fireball or object but did see the base or earth end of the column. The column of turbulence at its nearest approach to the earth appeared to be approximately 2 to 3 feet in diameter, ending in an elongated "V" (vee) shape with small particles emanating from the junction of the two sides forming the "V". The column ended at approximately 200 to 300 feet from the earth's surface and blotted out by its diameter that portion of a mountain on the opposite side of the valley approximately 15 to 20 miles to the west. No smoke was visible during the display or after the column faded from sight. The column was visible for several seconds and during this period there was no explosion or audible sound.

Assumptions. A container from which a substance, upon release, became a turbulent flame, surging and boiling upward in the opposite direction (180 degrees) from the downward (sky to earth) path of the flash. The reason that the undersigned saw no container was due to its terrific speed and the relatively short distance the base of the column appeared from his point of observation.

# Scores Report Fireball Here

## See Bright Orange Flash And Light Smoke Trail

It was probably a meteor—rather than an exploding jet plane, guided missile or flying saucer.

But whatever caused the brilliant fireball and long smoke trail in the skies northwest of Ogden today—it was real enough.

Dozens called The Standard Examiner saying they saw the phenomenon at about 10:30 a.m., and Hill air force base even dispatched a search plane to the general area.

The pilot, Maj. Robert S. Kalweit, said all evidence of the explosion—if that's what it was—had disappeared when he circled the vicinity in a B-26 bomber.

It may have been the same flaming object sighted from Nevada, Idaho and eastern Oregon. Some pilots insisted it was a meteorite that fell and started a forest fire near the Utah-Idaho border.

Although Ogden area observers saw no particles falling after the "explosion," a Salt Lake airport tower operator said he saw a "square black object" plummet to the ground.

Most witnesses located it a mile or so northwest of Ogden municipal airport.

They said a bright orange fireball traveled downward from the south, leaving a "gaseous" light blue smoke trail and suddenly blossomed into a much larger flash and disappeared. None reported any falling debris afterwards.

It was variously reported to have been at an altitude of from 4000 to 25,000 feet.

A check with Hill field and the C.A.A. communications tower at Ogden airport showed no military or civilian aircraft were known to be in the vicinity.

### Unusual in Daytime

It fitted the general description of a meteorite, but an expert said it is very unusual for one to be bright enough to be seen during broad daylight.

And bright this one was—indeed. So bright there was even

one report to Hill field that it had been seen from Donner summit, almost 500 miles away.

Charles Osmond, Weber college astronomy instructor, said the long trail of smoke and orange flash were characteristic of a meteorite. He said meteorites enter the atmosphere at a speed of about 7 miles a second and are usually entirely consumed before reaching the earth.

Osmond declared that the meteorites which fell in the Seattle area last year were accompanied by terrific explosions heard all over the city. No one reported any sound in connection with today's spectacle.

C.A.A. communications men in the control tower at Ogden Municipal airport said they had not seen or heard anything. But they were getting a lot of telephone calls from persons who had seen a flash and an explosion.

The C.A.A. man said he had no reports of airplanes being down in the area, but the characteristics were not those of a falling aircraft he said.

#### "It was a Long Blue Streak"

Among those who saw it were: Willard Nelson and Norman Maero, South Ogden: "It was a long blue streak, tipped by an orange fireball, which suddenly expanded, then disappeared leaving a haze of pale blue smoke."

Robert Cauffman of Salt Lake City saw it from the mountain highway south of Uintah junction. His description tallied with the others.

Mrs. George Soteras, 148 26th St., said it looked like a comet with a long bluish-green tail.

Robert Sellick of Salt Lake City said it appeared to be about 25,000 feet up when he first sighted the object which "exploded with a yellow light, then a ball of fire kept falling in an arc."

He said it went out at about 10,000 feet leaving a cloud-like pall of white smoke. He sighted it from Layton.

Everett M. Wilson, 470 34th St., saw the flames shoot in all directions. About five minutes later, he said, smoke began curling up from the ground, directly below where the flash had illuminated the sky.

## 'Fireball' Gets a New Twist, Nevada Has Blast and Blaze

Yesterday morning's mysterious fireball, viewed over a vast area in Utah, Idaho, Oregon, Washington and Nevada, was still just as much a mystery today.

Reports of witnesses varied from a "green pea fireball followed by a long orange streamer" to a "bright orange fireball with a gaseous light blue smoke trail."

People who know about meteors, including Charles Osmond of Weber college and Dr. R. N. Thomas of the University of Utah, agreed it had to be awfully big.

A new twist was injected this morning when W. S. Hobbs, assistant trainmaster at Montello, Nev., for the Southern Pacific railroad, reported many railroaders and others heard a heavy explosion about 10:30 a. m. yesterday and saw a column of smoke and dust hanging in the sky.

Montello is about 112 miles almost due west of Ogden as the crow flies. Hobbs said the grayish-blue cloud, outlined with yellow dust remained for several minutes, then gradually drifted away.

He said there was no known blasting in the area at the time.

Ralph Gibbs, soil conservation official, and ranchers went out to investigate. They found a 600-acre tract burned in Dairy valley, 26 miles north and five miles east of Montello. They could find, however, no evidence of a meteor.

At 1 p. m. today a brief flurry of excitement was caused here when a high flying B-36 with its vapor trail was mistaken for a fireball over the city.

# Flaming Meteorite Stirs West Areas

A flaming object which streaked across the sky Monday morning caused a flurry of excitement among observers in Northern Utah, Northern Nevada, Idaho and Eastern Oregon.

It is believed to have started a forest fire near the Utah-Nevada border.

The object, presumably a meteorite, first was observed near Pendleton, Ore., by an Empire Air Lines pilot. He thought it was another aircraft with a burning engine.

Observers at Boise said they noticed it about 10 a.m., and that it fell to earth somewhere south of that city.

At 10:32 a.m. numerous persons in Salt Lake City, Ogden and Brigham City saw the object coming from the skies to the northwest at high speed.

Rudolph Orlob, 1514 Arlington Dr., who was walking along Main St., described the brilliant flash of light as "like an enormous skyrocket being shot toward the earth instead of upward."

#### Brighter Than Sun

Gus P. Backman, executive secretary, Salt Lake City Chamber of Commerce, said he thought it might have been a rocket dropped from an airplane.

He described it as a "long white streak, which exploded with a brilliant flash," and said he heard no concussion, although the flash lit the sky with greater intensity than the sun.

Jay Nation, superintendent; Paul E. Strong, general foreman, and John Livingston, labor foreman of a Utah Construction Co. job at Vitro Chemical Co., 600 W. 33rd South, also reported seeing the flash, which they described as a "wedge-shaped" streak of fire which left a ball of smoke.

A control tower operator at Salt Lake Municipal Airport described the phenomenon as a black speck, trailed by a streak of light that was green but changed to red. He said the object exploded somewhere west of Great Salt Lake with a brilliant puff of white smoke. He said that a black object—"more square than round"—fell to the ground.

#### Seen at Cedar City

The Airways Traffic Control Center said the flaming display also was seen by airmen over Reno; Donner Summit, Cal., and Hanksville, Wayne County.

From as far south as Cedar City, Mrs. Heber M. Sevy, wife of an Iron County representative in the Utah legislature, and her son, Russell, reported seeing what they at first thought was a flash of lightning on the northern horizon. They soon decided "it could

not possibly be, because of the long string of fire left behind the falling object."

O. R. Olson, Ephraim, saw the flash as he emerged from Spanish Fork Canyon while en route to Salt Lake City, he reported.

The object loomed before him for about two seconds, then streaked off into Utah Lake, he said. He described it as a "long orange streamer following a pea green fireball."

At 11:30 a.m. an air lines pilot said he could see a "fresh" forest fire in scrub pine and sagebrush near Pilot Creek, about 30 miles west of Wendover, Tooele County.

Other airmen who converged there thought the fire had been started by a falling meteorite.

### Montana Reports

Conflicting reports of residents seeing large planes in flames, a fireball or a meteor, poured into sheriffs' offices, Civil Aeronautics Administration stations and police offices throughout Central and Southern Montana, but the CAA center in Great Falls said there were no commercial or private planes missing.

Dr. R. N. Thomas, associate professor of astronomy at the University of Utah, said if the flash was that of a meteor "it must have been awfully big."

Ordinary meteors seen at night are about as big as a man's thumb, he said, and usually are about 50 to 80 miles above the earth. The flash of light, visible to the eye, is caused by the meteor's terrific speed.

He said only a trained observer can estimate the size of a meteor by its brightness.

Charles Osmond, Weber College astronomer, said the object may have been a meteor. However, it would be unusual if one was so bright in the middle of the day, he said.

A. B. Carpenter, U. S. Weather Bureau meteorologist, said that "we expect meteors in August when we pass through the field, but they easily could come earlier."

### Couldn't Start Fires

Clyde T. Hardy, professor of geology, Utah State Agricultural College, Logan, who observed the phenomenon, said he is sure the object was a meteorite, but discounted its ability to start a forest fire.

He said a meteorite, when it hits the earth, is cool enough to be touched by a human hand. It couldn't start a forest fire, he said.

The flashes that were emitted were approximately 2 inches in diameter. The object then faded to the size of 1/16 inch when last seen. The color of the object at first sighting was a dull white. Last section of space "C" only a dull white ball about 1/2 its original size could be seen falling slowly toward Athens which was in view.

I first saw the dull whitish orange ball when it was on a declination that was even with the Hotel Weston here in Athens. Then it disappeared. I took my calculations thus: I was driving a 1951 4 door 200 series Packard not heavily loaded. I am 5' 9 3/4" high and weigh 145 pounds. I was leaning on the driver's door as in figure #1. I wear a G.I. X-10 shirt, 5 7/8 hat. The dotted line from the rear object represents the path of the object in relation to my position while in the car. It first appeared to be about 1/8" in diameter in space A and B and began to grow larger in "C" until the flash covered approximately 2 inches in diameter. The object grew smaller from this point on until it was approximately 1/16" in diameter when I last could see it.

Enclosed you will find a print to help clarify my sighting report.

If I may be of further service, please do not hesitate to ask.

I have informed the Police Department here in Abilene and expect a report from the Desk Sergeant late this evening. If any of the Patrolmen might have seen the object, I have asked that they give me the direction he saw the object from Abilene, and the time. If any of the policemen saw the object, I will send you the information post haste.

I would appreciate any help you can give me that would aid me in making a more accurate report should I see another such object. I will especially want to know how to determine the distance of the object from me, its altitude, direction, etc.

I am a draftsman with some eight years of experience so I trust my approximations will be close to correct.



Object was sighted by [REDACTED] College Drive, Abilene, Texas, on the morning 7 July 1952, at 0340 and was observed for a period of 30 seconds. When first sighted the object appeared to be 1/8 inch in diameter and grew larger as it progressed toward the earth until it reached the size of 3/8 inch or 1/2 inch in diameter. The flashes that were emitted were approximately 2 inches in diameter. The object then faded to the size of 1/16 inch when last seen. The color of the object at first sighting was a dull white. The color changed to a brilliant blue-white, to a blue, to a copper green, followed by flashes of red-white light, leaving a trail of sparks in what seemed to be a shower of dust or smoke that trailed after the object. The speed of the object was unknown. The observer said nothing as to sounds the object may have made. The object made no maneuvers except one slight deviation from its course.

The observation was made by the observer with no visual aids or any other sighting equipment. The object was sighted through the glass wind-shield of his car. At the time of the observation, the observer was 15 miles west of Abilene, Texas, sitting in his car and sighted the object at approximately one o'clock high. The object was proceeding toward the ground at an angle of 30° to 35°. The direction of the object is believed, by the observer, to be North. Altitude was not estimated by the observer.

Mr. [REDACTED] is the only one that submitted a report on this object and no other witnesses are known of.

Mr. [REDACTED] is a draftsman with 8 years experience and it is assumed that the calculations given by him should be accurate because of his experience with such.

The observer stated that the observation took place on a cool, moon-light night, with a few scattered clouds. He made no mention of wind at the time and place of sighting, with the exception that wind was responsible for the slight change in the course of the object, as stated.

There was no known meteorological activity or otherwise which might account for the sighting of the object. There is no physical evidence, fragments, photographs or any other physical evidence of the sighting with the exception of the diagram drawn

by Mr. [REDACTED], which is inclosed. There was no attempt at interception and identification was impossible. There was no known air traffic of any type in the general area at time of sighting. Mr. [REDACTED] own written report and sketch of what he observed is inclosed and this is the only information available to us at this time.

The letter was received by this office on 8 July 1952 and an electrical report was submitted immediately. Due to the fact that there have been no personal interviews with Mr. [REDACTED], no further information can be surmised.

As stated in Mr. [REDACTED] letter, he seems to be very interested in these flying saucer questions. He did not commit himself by saying that the object sighted was a flying saucer. Acknowledgment of Mr. [REDACTED]'s letter was made 11 July 52.

This object was traveling in a northerly direction approximately 400 MPH. The nebula was constant with no indications of atmospheric resistance. The phenomenon was visible for about three seconds and appeared to be at a height of from three to five thousand feet. It appeared to be the size of the full moon but there was no means of estimating the actual size or other comparative data.

COMMENTS of Preparing Officer:

1. I have had an interview with the officer who observed the phenomenon described below. This officer has had previous experience as an observer and reporter for the Air Materiel Command at Muroc, California. He was working for this Command on the "Flying Saucer" Project and by reason of his experience along that line, he impressed me as having a good knowledge of the subject. As he expressed it, "Because of so many reports that later proved to be mass hallucinations and distorted views of material objects, I am rather skeptical about most of the stories on Flying Saucers. I hesitated before turning in a record of my observation."

2. Captain [redacted] is known to the section of Air Materiel Command handling the "Flying Object" Project as is explained in the above paragraph.

3. This Directorate checked with the Control Tower of Pope AFB, with the Headquarters of the 507th Tac Control Group, G-2 32nd Airborne Division, and the Weather Squadron at Pope AFB. As nearly as may be determined, there were no unusual activities or conditions, meteorological or otherwise, taking place at the time of sighting.

4. Captain [redacted] impressed me as a conservative individual and one not given to exaggerated statements. He stressed the fact that he had this flying object in view for only a few seconds and had no real point of reference from which to check its size.



Suddenly realized there were four of these oddly (completely round) shaped things, and while commenting on the fact they were evenly spaced saw there were seven. Kept watching because of their unusual shape and exact spacing. We were intrigued because they were so different from anything we had ever seen. ~~and~~ Two planes were in the sky at the time, one very high and the other lower. Neither plane gave any indication of anything unusual occurring at the time.

20. Do not feel at all qualified to estimate distance or speed. However, at that point the mountains are, I believe, between 15 - 20 miles distance and sighted objects were in front of the mountains - perhaps 10-12 miles distant.

These objects remained at about the same height, and from our position appeared to be below the top of the mountain, and some distance in front of it. When first sighted, they were considerably ahead of us and we kept them in view until we were no longer able to see them through the back window of the car, due to distance. At all times they kept the same shape and formation and solidity.

As we passed the same spot on July 10th on our way home we remembered having read in an El Paso paper that one of the physicists at Alamogordo had seen a so-called 'flying saucer' the same day we had witnessed these objects and thought we may have seen the same thing. Because of the close proximity of Biggs airport at El Paso and Holoman air field near Alamogordo, we assumed what we saw was not unusual in that locality and it was not until we returned home that we thought it sufficiently important to report.

1. SYNOPSIS: Spherical object sighted by civilian in vicinity of El Paso, Texas, (7 July 1952,) believed to be similar to objects reported in El Paso newspaper as seen by an Alamogordo scientist.

2. DETAILS: This office was advised telephonically, 30 July 1952, by a Mrs. [REDACTED] Street, Berwyn, Illinois, of the following:

a. On 7 July 1952, Mrs. [REDACTED] while visiting her son, stationed at Fort Bliss, Texas, was enroute accompanied by her husband and daughter from El Paso, Texas north to Alamogordo, New Mexico. Approximately fifty (50) miles from El Paso, Mrs. [REDACTED] stated, she and her daughter observed at about 1000 hours a spherical object in the sky to the northwest of her automobile. This spherical object was joined by three (3) more of the same objects and in seconds later three (3) more, totaling seven (7) spherical objects, which were very high and far to the northwest. Mrs. [REDACTED] could not determine the color of these objects nor the speed at which they were traveling in a southerly direction, but she did recall that they seemed to be flying in perfect formation (very evenly spaced). She and her daughter observed these objects for approximately six (6) minutes until they disappeared to the south. Mrs. [REDACTED] further observed two (2) aircraft at the same time, one of which seemed to be a single-engine aircraft and the other which was quite high and distant. She could



At 1315 hours 8 July 1952 an unidentified object was observed by Mrs. [redacted] of Bear Lake, Florida. The observer was riding in an automobile, going east, on West Central Avenue, Orlando, Florida, when the object was sighted.

The object was in sight 10 to 15 seconds, during which time it was travelling at a very high rate of speed at an estimated altitude of 5000 feet.

The object was travelling from north to south. When first sighted object was approximately 30° above the horizon flying straight and level, then made a gentle turn to the right with a moderate bank.

The object was dull gray in color and appeared to be a concave disc with veins or ridges radiating from the center towards the edges. The observer stated she had seen B-36 type aircraft in the air and the object was as large as a B-36, with thickness approximately 1/8 of the diameter. There was no audible sound and no exhaust visible.

Weather at time of sighting was CAVU with thunderheads in area.

No interceptions were made, and no photographs were taken.

T-33 type aircraft from this base and Naval aircraft from Sanford Naval Air Station were flying in the vicinity of Orlando during period of observation from 1500 to 30000 feet. No aircraft from Macdill Air Force Base or Patrick Air Force Base were reported in this area at time of observation.






