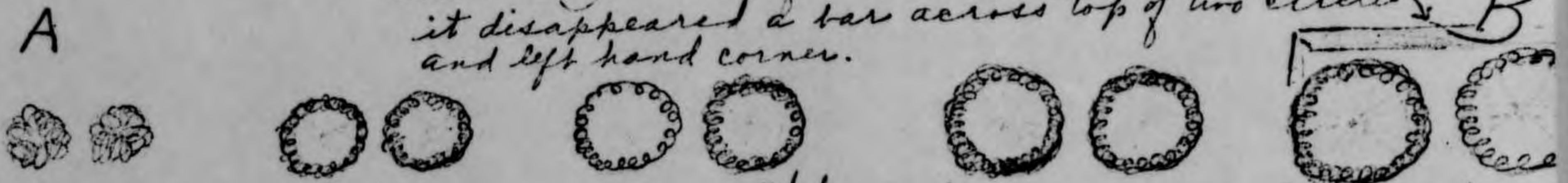

As it made right angle turn and headed East I noticed for about 3 seconds before it disappeared a bar across top of two circles and left hand corner.



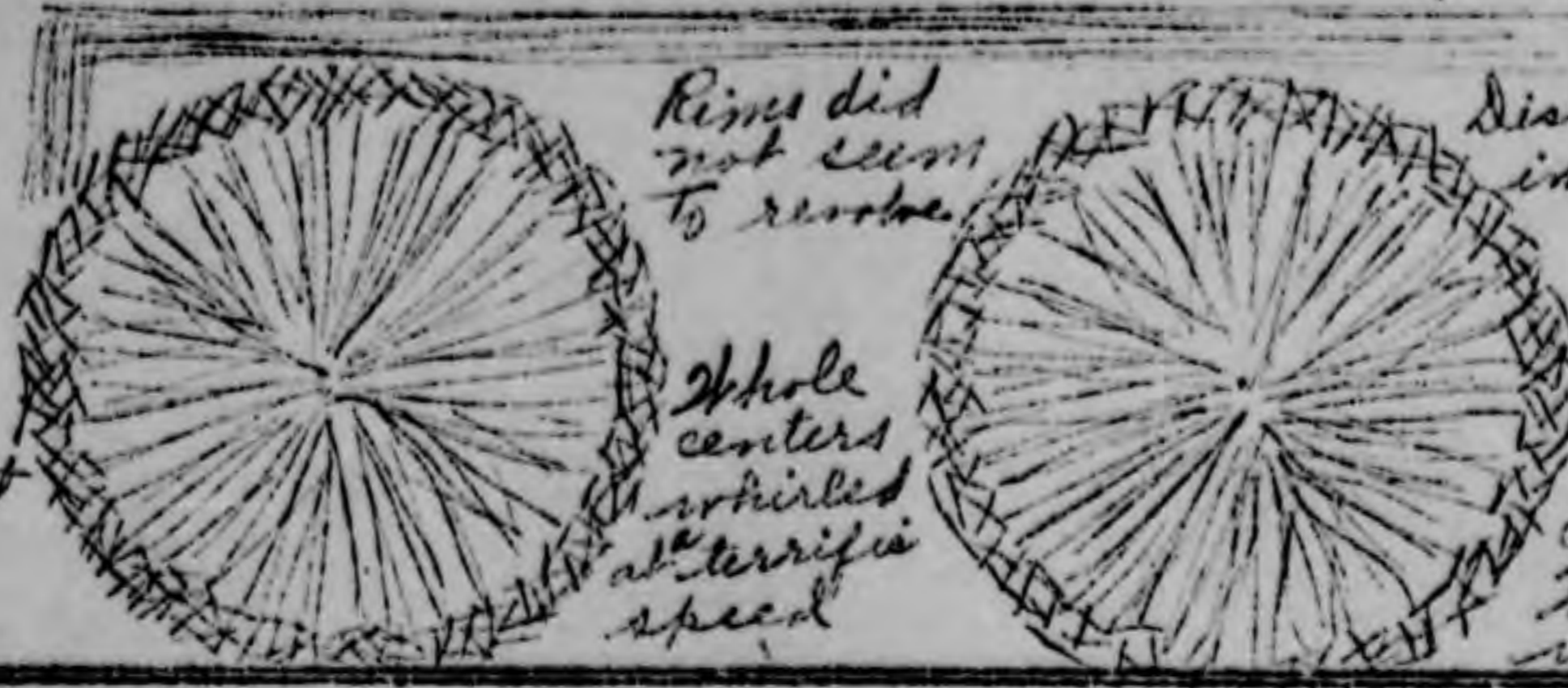
Traveled very smoothly. When they appeared in the north looked to me like revolving blades of a propeller of a bomber. The circles became larger and larger (always together as though attached) and then rims were dazzling blue white against pale blue sky. The whole centers were whirling at a terrific speed like the blades of an electric fan, but the rims seemed stationary. Gave off no rays.

To get idea how they disappeared I saw a sheet of paper and slide sheet from right to left of this drawing. It's only as they were disappearing I saw bar, and the left corner was last to disappear. One circle at a time disappeared, as though passing through a side wing on a theatrical stage.

The space between the two circles was always about half the diameter of circle, and they were perfect circles at all times, no part of outline faded. They were at their largest when they disappeared as though through a slit in the sky. Noise ceased abruptly as soon as circles disappeared.

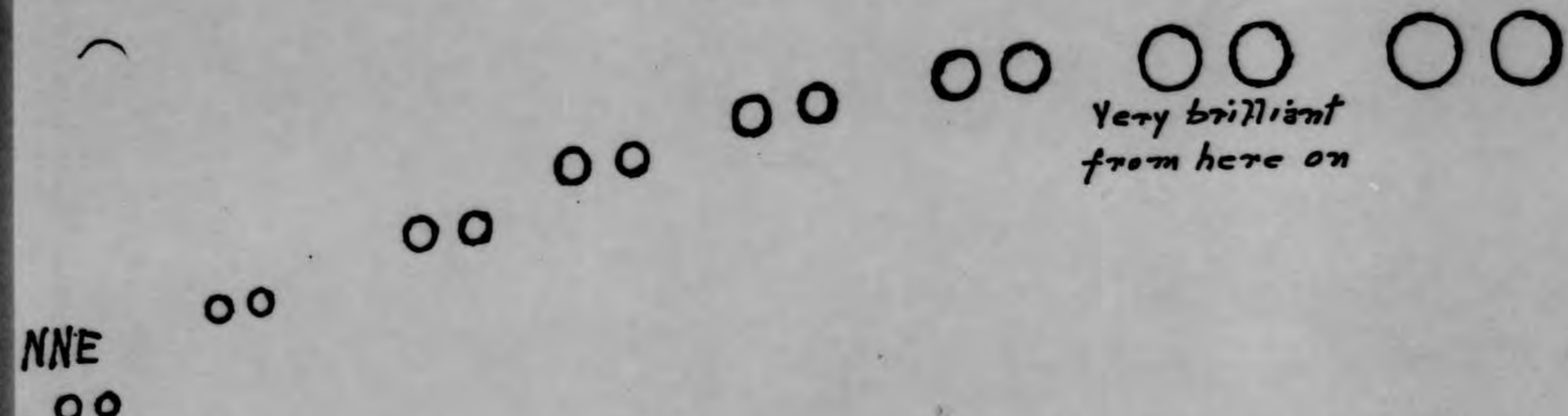

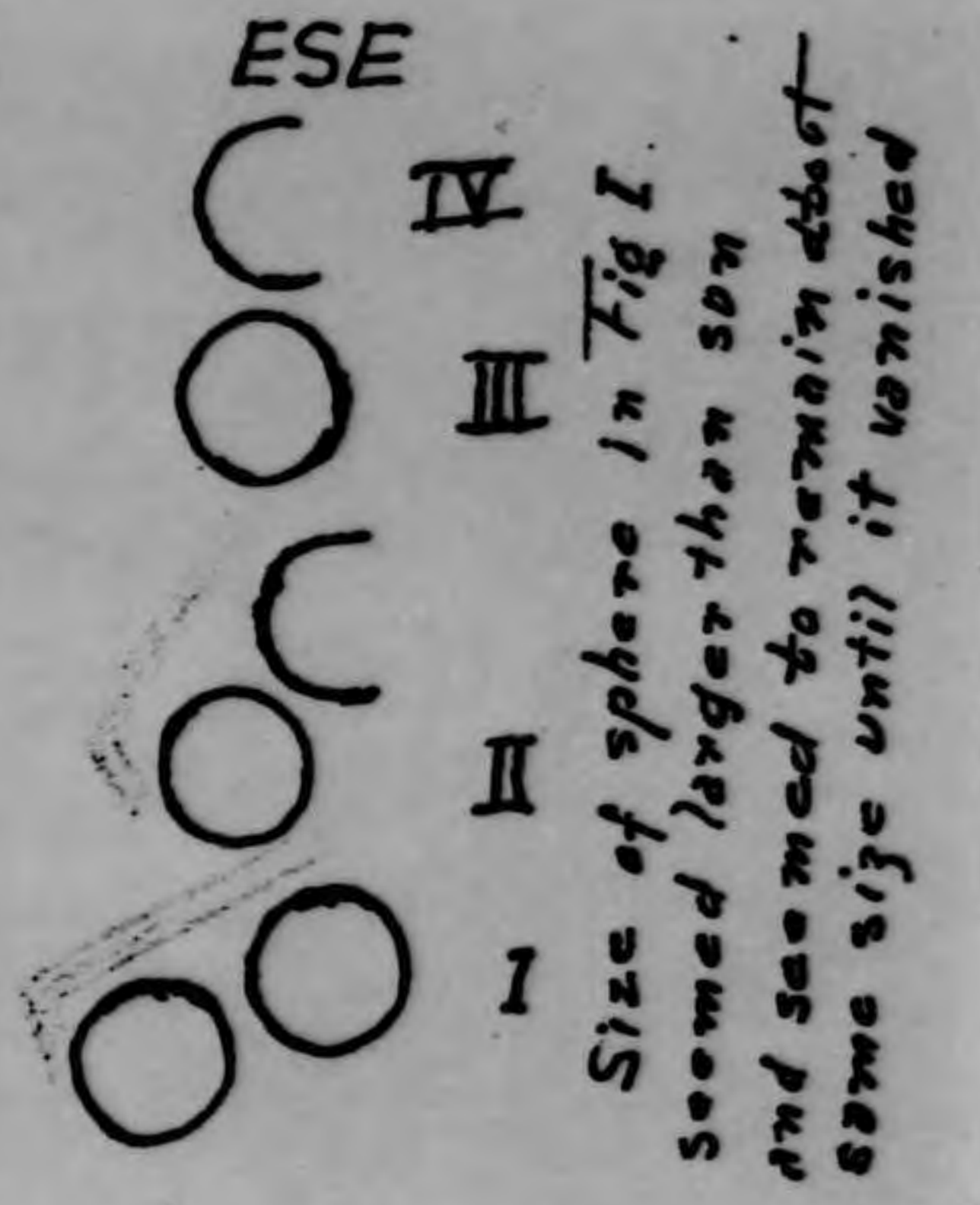
These objects took approximately 60 seconds to travel between points indicated. About 3 to 4 seconds to make right angle turn and vanish.



Heard noise before I sighted small disks.
 The noise increased in volume at Fig II similar to noise one hears on a small steamer or Ferry boat. When bar was in this position I saw down in between spheres + frame what appeared to be attachments or gadgets but too indistinct for me to try to describe or sketch

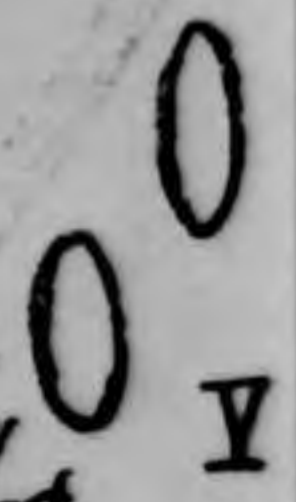
Fig II Shows how it appeared to ascend, one sphere here became cut in halves as though going through a side wing of a theatrical stage.

Fig IV This last sphere was cut in halves as the first and then vanished instantly.

This sketch shows how the two circles appeared coming directly from the North toward me, traveling constantly on an even keel, as though attached together, becoming larger and larger to my view, and disappearing at their largest size, almost instantly, by making what seemed to be a right angle turn directly East, one circle disappearing at a time, as though going through a side wing on a theatrical stage, the side wing being of the same pale blue color of the sky. The disappearing act took a matter of about three seconds. It was only at the last stage of this act that I noticed a pale gray bar at the top, and behind the two circles, and the left corner which appeared to be part of some sort of framework that these two circles were attached to. I might add that the top bar seemed to have a slight upward swing that made the object appear to be rising higher as well as making that right angle turn.

As you will notice I left the last circle of this twin object unfinished in my sketch, as well as the end part of the bar, to show how this twin object vanished from my view. I at no time saw the right hand corner of this twin object.

Here the circles appeared larger than the sun, and whirling sound ceased after the circles vanished.

The space between twin objects was half the diameter of circles at all times

I heard noise a few seconds before, ^{I got} the first glimpse of these two small circles. The noise continued until the objects vanished.

The arrow points to location where twin objects crossed path of sun.

What I thought the sun's orbit



The two circles I saw appeared to be traveling in the path of the sun, not directly overhead. I had to keep turning my eyes as well as my head toward the right until my chin was over my right shoulder. I judge it took a good sixty seconds to make the distance I saw it travel in.

This observation was made July 17, 1952 at about 3:10 P.M. DLST by XXXXXXXXXX White Plains, N.Y.



The circles at this point looked about as large as the sun without rays (as the sun appears when looking at it with sun glasses) and in about the same position of the sun at 9 A.M. DLST in July but somewhat lower in the sky.

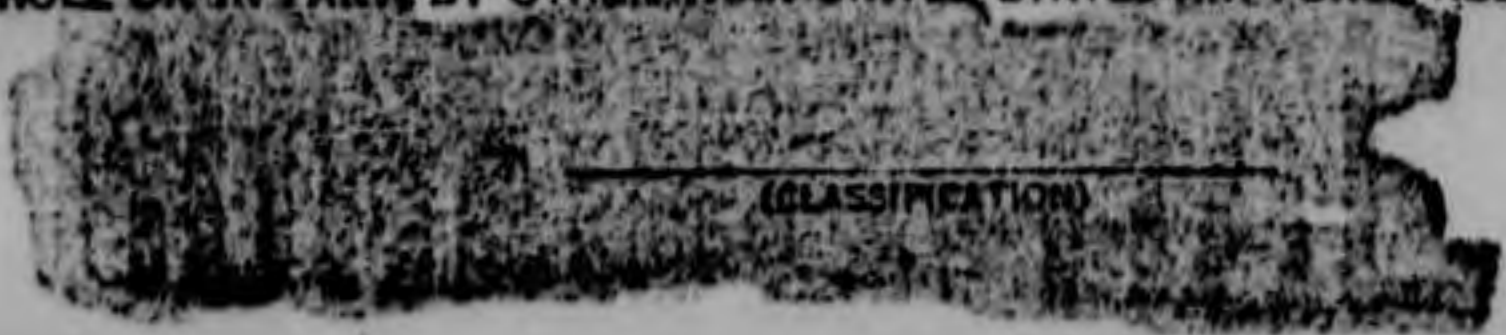

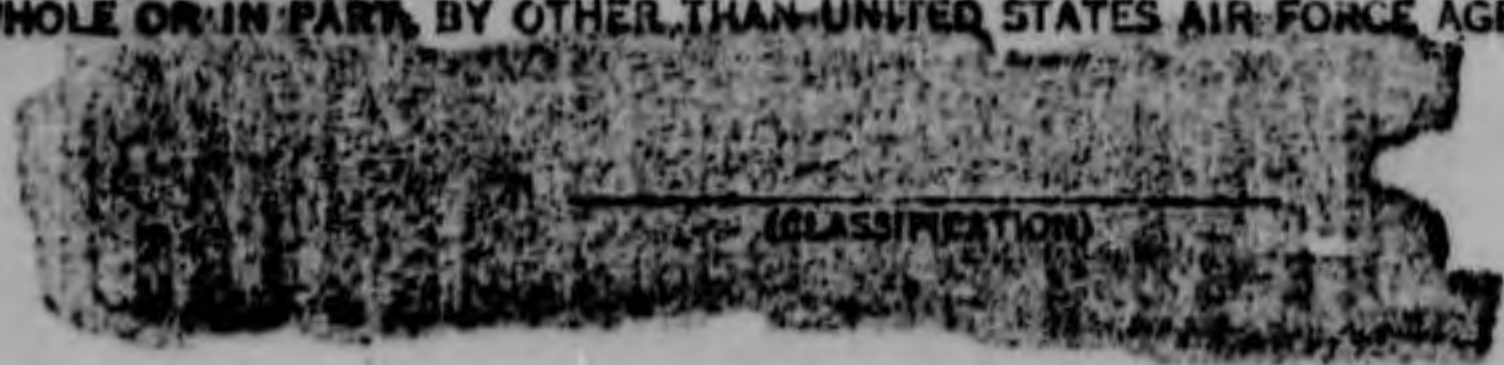

Dear Sir:

I am enclosing with this letter another sketch I have drawn of the twin objects I sighted and reported to Dayton, Ohio July 29. In my previous sketch I sent along with my filled out questionnaire August 9, I drew only the first phase of the right angle turn these twin objects took, as I didn't know at the time how to sketch the different phases these objects presented without confusing everyone. Since then, I recall that the last disk disappeared at a higher location in the sky, making it less difficult for me to sketch these different phases these twin objects presented in making that right angle turn.

Furthermore, up until now I could not understand why these twin objects, which were perfect circles at all times, did not take the logical form of an elongated ellipse which one would expect them to take in making that turn. After studying a sketch of what I actually saw, I have come to the conclusion that what I saw were objects spherical in form. No doubt you have already arrived at that same conclusion.

I have numbered on this sketch the different phases these twin objects presented, and a description of each follows:

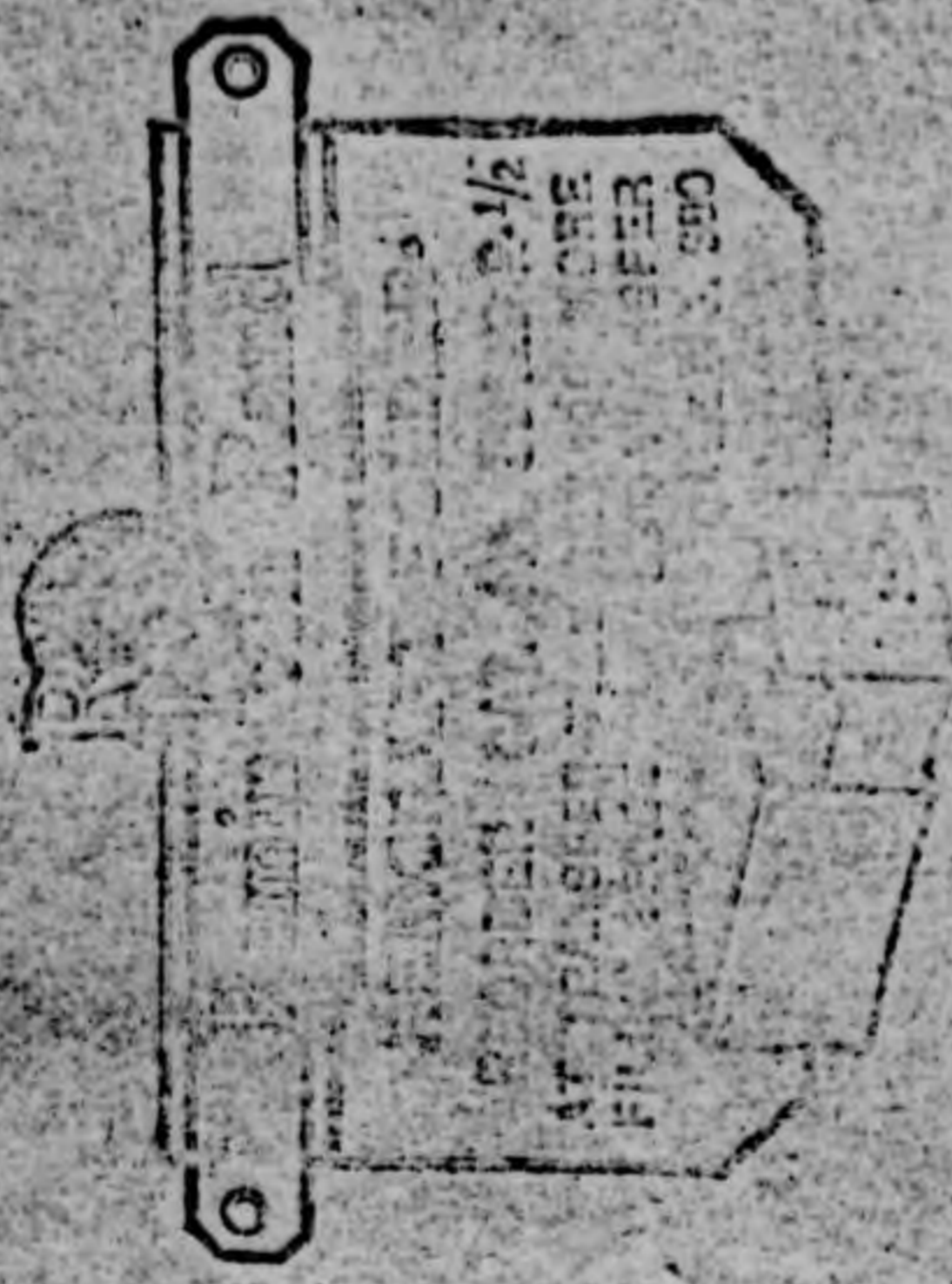
Fig. 1. This shows the beginning of the right angle turn, at which time the circles appeared at their largest size, reminding one of two large Ferris Wheels made of crystal. It's at this stage that I noticed some sort of framework attached to the two spheres, but no attachments were visible. I simply saw the top bar and left corner of framework which seemed to be of a solid dull pale gray material. This top bar and corner of frame was well defined against the pale blue sky. The width of this framework in my sketch is approximately correct in relation to the dimensions of these spheres. I also noticed at this point that the bar across the back of these spheres seemed shorter in length than the overall measurement and besides placed a little lower than the top of spheres. This fact no doubt accounts for my seeing only two circles up to this point.

The whirling sound I had been hearing from the beginning seemed to increase in sound, with another type of sound added, as though some other form of machinery had been set in motion to make this right angle turn.

Fig. 11. Here the spheres, including frame, tilted upward very suddenly as though ascending, and the noise increased again in volume, very similar to the noise one hears on a small steamer, such as the one that plys between Boston and Nantasket.

As you will notice the top bar in this figure is practically upended, and when in this position I saw what seemed to be gadgets or attachments down in between the framework and spheres. However, this feature was altogether too indistinct for me to try to describe, much less try to sketch.

Fig. 111 Only one big sphere remained, brilliant as when it made the right angle turn with it's twin, and the noise abated somewhat at this point.

The one sphere remaining puzzled me no end, but I now believe the reason only one sphere was visible at this stage, was because the spheres had completed the right angle turn and one sphere was traveling directly behind the other on their way directly eastward.

Fig. 1V. This sphere was finally cut in halves like the first and then vanished instantly. The noise also ceased simultaneously. To get the exact effect of how they vanished from view take a strip of paper three quarters of an inch wide and draw it slowly across Fig. 1 from right to left, until sphere is cut in halves. Now you will have a picture resembling Fig. 11 except for the framework. Do the same with Fig. 11 until you have only one sphere. You can now see what I have been up against in trying to sketch this right angle turn.

Sunday August 10th, an investigator from your Center called on me. Among other things he asked to see the yard from where I had observed these twin objects. In pointing out the location where I first sighted these objects I remarked to him that I thought I had been mistaken in saying that they came from the north. We agreed that they may have appeared more in the North Northeast. I have corrected this error in this new sketch, and I also changed the point of the disappearance to East Southeast.

I hope I have succeeded in giving you a clearer picture this time of this unidentified aerial object.

Dear Sir:

In reporting the Twin Objects I sighted July 17 from my back yard, I purposely withheld one very important feature as I couldn't bring myself to reveal such an astounding feature. I had kept this particular feature a very dark secret for one whole month, when I felt I could do so no longer. Therefore, on August 18 I made an appointment with the pastor of our church, bringing all correspondence I had had with your Intelligence Center for him to read. I then told him the secret, and asked him if he thought I did right in withholding this information. He replied, by saying he thought I had given enough information for the time being, as it sounded so unbelievable, and added smilingly - "At least we know they are not Russians."

Since then I have watched newspapers and periodicals (even going through past issues) for reports on sightings, being very much interested since my experience, but found very little reference has been made to "Saucers" since the first part of August. However, I did come across the following items, which have made me decide to divulge my secret:

1. Time magazine of April 14, 1952 reported that Lancelot Hogben, F.R.S. gave a lecture to The British Interplanetary Society and the article starts "How do earthlings go about striking up a conversation with the inhabitants of other planets?" Assume said Hogben that the earths ETN (Extraterrestrial Neighbors) can perceive or record radiation in some part of the electromagnetic spectrum (light, heat, radio waves etc.) Also assume that the earth can send such radiation strongly enough to reach the nearest planet," etc. etc.
2. Read in our local paper that our Air Force had ordered pilots to shoot at unidentified objects they may come across in the sky.
3. Read in our a New York City paper dated Sept. 15 that a ten foot tall monster was supposed to have alighted from a "Flying Saucer" down in Sutton, W. Va.

The very afternoon I sighted this Twin Object I felt it was a friendly sight-seeing space ship from another planet. If you will refer to my very first letter reporting this Twin Object I wound up my letter by saying "To me these objects appeared to be of too great a size to have been created on this earth." It was not only the size that convinced me of this, but this other feature which I am about to reveal.

First, as I wrote in my letter of Aug. 15 (explaining Fig. 1 of my sketch) an added noise was heard to the hum I had been hearing from the very beginning, very similar to noise made by a small steamer, a muffled staccato

sound, about three beats to the second. It wasn't loud, but as I have remarked in my previous letters and questionnaire, it was a very hot, quiet afternoon, the temperature being up in the 90's, no planes were flying in this vicinity at the time, the children of the neighborhood were away at camps, and the adults that were home kept indoors due to the intense heat, so the conditions prevailing at the time were perfect to see and hear every sound without any interference whatever.

In Figure 11, as per my sketch, this Twin Object took a sudden upswing and in this practically upended position the most astounding features were revealed. First I noticed attachments and gadgets down in between the framework (which I now think was housing for beings aboard) and spheres, and then above the hum and staccato thump I was hearing, I distinctly heard voices greatly amplified, that seemed to come from beings similar to ourselves. It was as though a door of a large auditorium had been opened the instant the Object took this sudden upswing on a group of eight to ten people conversing with one another in a slow quiet manner, seemingly unaware that their voices were being heard down here below. The vocal tones were beautiful, and all seemed to be of the same quality with no guttural or nasal sounds. They were all of a middle range, more like mature feminine voices than masculine. No harsh consonants were audible, and the vowels were well rounded, open and long. If consonants were used they were not heard. I never heard a language on this earth as beautiful. I grant you, I haven't heard all languages spoken, but I have heard several.

I had no stop watch, but I estimate I heard these voices for at least four or five seconds, during the whole time this Object was in this upended position, then all sound and voices were cut off abruptly as the Twin Object went into the next phase as shown in Figure III of my sketch, when only one sphere could be seen as it was going directly E.S.E. hiding the sphere ahead.

It has taken considerable courage for me to divulge this secret, but since reading about Hogben I feel compelled to disclose this secret for the sake of science. Should I, by chance, have been the only person to have had the opportunity of seeing and hearing such an astounding revelation, science would have been the loser had I continued keeping silent. I understand the U.S. Government has engaged scientists to work in conjunction with the work done at your center, and I feel confident you will see that this information is passed on to scientists who believe other planets are inhabited, such as Dr. Walther Riedel and Dr. Maurice A. Eiot.

Lancelot Hogben would be most interested in this voice feature. Would the Air Intelligence Center object to my sending him a copy of this letter?

The Editor of Club Dial, a monthly magazine put out by our Woman's Club (Membership close to 900) of which I have been a member for the past twelve years has asked me to write an article on the "Saucers" I have sighted. I noticed your investigator who called on me had my letter in a secret file. Does this mean that I should keep silent? Of course, if I should accept the invitation to write an article I would not mention the voice feature, as I don't think the public is ready for such a revelation.

My answer to 20.1

Since July 17

I have been trying to determine how high these two circles were, just before they vanished and appeared at their largest size, and found that by watching bombers flying across that particular location on a very clear day I have observed that a bomber would look no larger than one half inch long to the naked eye, by measuring at arm's length with a pencil, whereas each of the circles I saw were at least one and one quarter inch in diameter by a similar measurement. I figure a bomber would fit in one of those circles as per this sketch. This is the only way I can answer this question. The wing spread about one half inch.



My answer to 20.2

The following is the only answer I can give as to how far it was away from me. When I first saw these twin objects in the North, I would say they were no more than a quarter of an inch in diameter, measuring at arm's length with a pencil. They first appeared upon the scene like two small silver disks at that distance. I was lying on a cot facing North in the direction they were coming from. I thought at first these silver like disks were the propellers of a bomber, but it immediately dawned on me that propellers wouldn't be discernible at that great distance, so I kept my eyes focused on these two objects. Prior to their appearance I heard noise similar to the noise of bombers flying in formation, but a much softer smoother hum. Upon scanning the sky nothing could be seen, then presently silver disks appeared directly North and coming directly toward me in what seemed to be traveling in the orbit of the sun, ^{in orbit} traveling very smoothly and as though the two circles were attached. The circles were identical in shape (perfect circles) and identical in size and color. They were traveling constantly in an upright position and on an even keel. As they became larger I noticed the whole center of both circles were whirling and couldn't help but attribute the noise I was hearing to the whirling appearance in the center of circles. The whirling appearance reminded me of the nickel plated blades revolving in an electric fan, and revolving at a terrific speed. The rim of circles were of a dazzling blue white crystal, almost like diamonds, but this rim did not seem to be revolving. When this twin object disappeared at its largest size, making a right angle turn I noticed the circles appeared to have a rectangular framework behind them. I saw only the top bar and the left hand corner. This framework seemed of a dull pale gray material. The noise ceased abruptly as soon as these twin objects vanished. I stayed on the cot a good ten minutes after the circles disappeared watching the sky for planes, as I wanted to make sure no plane had been traveling simultaneously. There was no plane in sight anywhere, in fact, for such a clear day I couldn't understand why none were about.

My answer to 20.3

Again, I have no means of determining how many miles an hour these twin objects were traveling. The only thing I can say to give you an idea, is that it took about sixty seconds for these twin objects to travel between the two points I observed them to travel in. I couldn't have been in a better spot to view these circles, and only wish that a scientist could have had the opportunity I had.

It was the most beautiful sight, more breath taking than any planets to be seen with the naked eye. It made a profound impression on me, and a day doesn't go by that I don't find myself dwelling on that most unusual celestial apparition.

Could I have been witnessing a couple of planets doing an epicycle they speak of in Ptolemaic astronomy?

I have never studied astronomy, but common sense tells me there would be no framework to account for, noise or a right angle turn.
