

<p>Mr. [REDACTED], [REDACTED], Marietta, Pa., reported observing an unidentified flying object on 2 August at approximately 0005Z.</p> <p>Mr. [REDACTED] first noticed the object while parked on a highway approximately one mile west of Marietta (7635N - 4005W). Mr. [REDACTED] related that he noticed a brilliant white light suddenly appearing at a point N.W. of his position. According to Mr. [REDACTED], the object was traveling West to East, approximately 40° above and parallel to the horizon. He reported that the object maintained a straight course without altering altitude or direction and suddenly vanished in the East.</p> <p>The object was physically described as a brilliant white light with a relative size of approximately half the size of the moon. Mr. [REDACTED] did not observe any exhaust or trail and could not report any sound as being heard. Although no accurate estimate of altitude or speed could be given, the observer described the object as traveling "very fast" and as being at a "low altitude." Mr. [REDACTED] total observation lasted approximately two to three seconds.</p> <p>Mr. [REDACTED] observation was collaborated by Mrs. [REDACTED], [REDACTED], Marietta, Pa. Mrs. [REDACTED], whose location was approximately one mile east of Mr. [REDACTED], reported observing an object at approximately 0100Z. Mrs. [REDACTED] description of the object was similar to that of [REDACTED] with the exception that she observed the object to have been climbing at approximately a 45° angle. While Mrs. [REDACTED] agreed with [REDACTED] on the size of the object she believed the object to have been orange in color.</p> <p>Mr. [REDACTED] educational background included a high school education and the man may be described as having average intelligence. [REDACTED] served as a radio operator with the USAAF during World War II and has had some experience with aircraft. Mrs. [REDACTED] background was not determined.</p> <p>The weather at the time of the observation was clear, with 10-mile visibility.</p> <p>This Office can offer no definite explanation for the sighting. The facts given seem to rule out the possibility of aircraft or astronomical phenomena as being the explanation. (i.e., size of the object and its behavior).</p>
