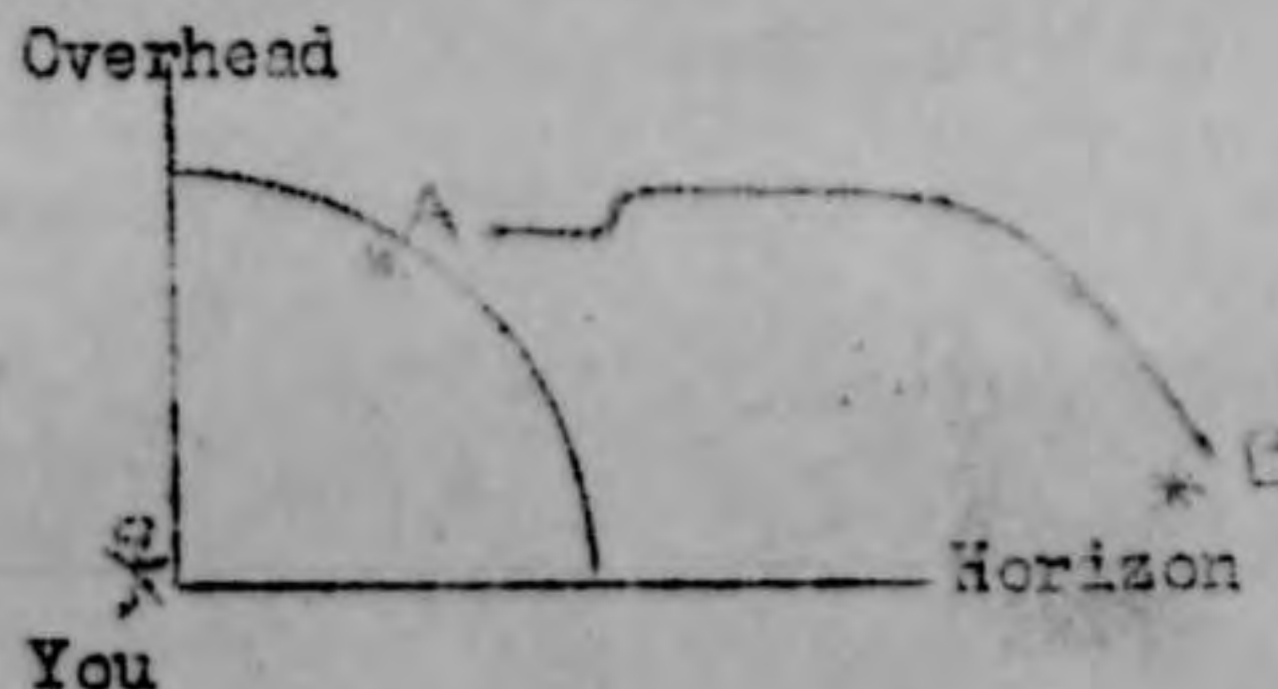

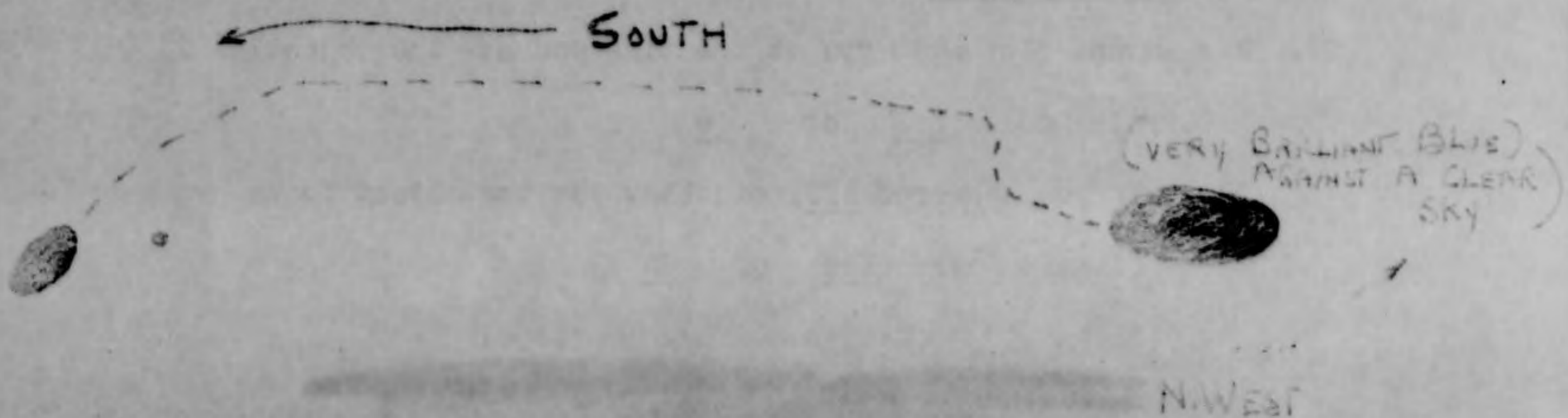
23. In the following sketch place an "A" at the position the object was when you first saw it, and a "B" at its position when you last saw it.

In reference to FLYOBRPT teletype reporting the observation of an unidentified flying object by Mr. [REDACTED] Pa., investigation has established that both objects can be explained.

From the information furnished by the observer, it appears that the object seen on 12 September was, in reality, a blimp and the object seen on the succeeding night was either an extremely bright star or a planet. These explanations are, of course, not 100% conclusive; however, at this time they appear to suffice.

Officers [redacted] and [redacted] civilian [redacted] at this Base, reported seeing an unidentified flying object while on duty at 0735Z on 14 September 1952.

Officer [redacted] first noticed a sound similar to a "distant motorboat" and called York to verify it. While both men were attempting to locate a boat on the Susquehanna River they noticed a round bright light in the sky southwest of their position at an elevation of approximately 22 degrees. The light was stationary when first observed and was a "brilliant light blue" color. It began to move horizontally, "hesitated", moved again horizontally in a southeastern direction and then accelerated and appeared to drop toward the river. The object disappeared behind a tree and the observers could not determine whether the object disappeared into the river or behind the hills beyond the river. Both men said that it did not resemble a meteor in either behavior or appearance.

The observers stated that as soon as the object began moving the sound stopped. They also reported that while the object was moving it appeared to be brighter than when first sighted in a stationary position. No trail or exhaust was noted.

The length of the observation was timed at three minutes.

Both observers maintained that the sound came from the direction of the light. Officer Burnett reported that he had heard the same sound briefly at 0430Z, but that he did not notice anything unusual at that time.

Weather at the time was clear with two to three miles visibility. Winds were: surface 290/5k, 2000' 320/6k, 4000' 350/11k, 6000' 330/13k.

It is possible that the guards were observing a light aircraft, but the absence of navigation lights would seem to discount this. Further-more, if the light were the landing light of an aircraft, a beam should have been visible under the conditions of low visibility at the time, but the observers said they saw only a bright light. This office can offer no definite explanation of the sighting.
