SPOT INTELLIGENCE REPORT

SUBJECT: Sighting of Unidentified Flying Objects in San Diego, California, on 17 December 1952, by U. S. Naval employees

TO: Director of Special Investigations
Headquarters USAF
Washington 25, D. C.

1. SYNOPSIS: Between 1515 and 1525 hours, 17 December 1952, four members of the U.S. Navy Electronics Laboratory, San Diego 52, California, sighted two flying objects from their place of employment which they concluded were definitely not conventional flying aircraft.

2. DETAILS: This District Office is in receipt of a first indorsement from the District Intelligence Officer, Eleventh Naval District, San Diego, California, accompanied by a letter of transmittal from the U.S. Navy Electronics Laboratory, which has as inclosures the statements of four employees of the Laboratory concerning their sighting of two unconventional flying objects between 1515 and 1525 hours, 17 December 1952.

3. The sightings were made by C. F. ALTHOUSE, Electronic Scientist; H. W. VOLBERG, Electronic Scientist; NATE WADDINGTON, Electronic Mechanic; and A. J. HOPKINS, Electronic Scientist, from Room 1001, Building 33, of the U.S. Navy Electronics Laboratory.

✓ 4. Weather conditions were described as mostly cloudy, with several rain squalls to the South and East. There were other jet aircraft in the area.

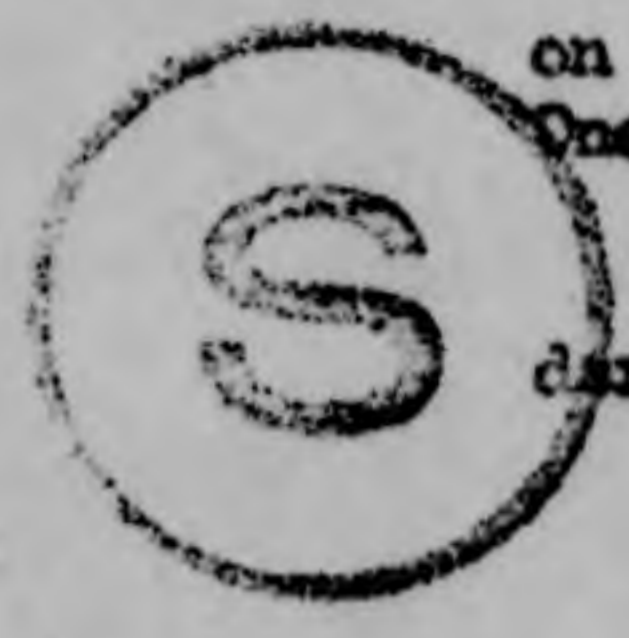
5. The speed of the two objects was described as being from the speed of present day jet aircraft to at least five times that speed or 1500 miles per hour. (?)

6. The shape of the objects was described as cigar shape or disc on edge. One felt it presented a circular surface towards the viewer. One described the objects as being round shape, well defined at edges.

7. With the exception of one who stated one object appeared quite dark, all stated the objects emanated bright light, but not dazzling.

SPOT INTELLIGENCE REPORT, dtd 19 Feb 53, Subject: Sighting of Unidentified Flying Objects in San Diego, Calif., on 17 Dec 52, by U. S. Naval employees.

8. The size of the objects varied from an opinion of small to very large.

9. The direction of the objects was considered to be in a generally northern direction, somewhere over the Western end of North Island.

10. Height was estimated by two viewers as approximately 500 feet.

11. No smoke, vapor or flame was noted emitting from the objects. Their course of flight was described as being without smoothness, given to sudden alterations in direction. The flight of the jets in the area was described as being smooth, no turbulence apparently being present.

12. ACTION: No action by this District Office taken or contemplated.
