I. Description of Incident

At 1515 Z over sixty varied military and civilian sources observed one green, disc-shaped object. The observations continued for fifteen minutes during which time the object moved in a southwesterly direction while bobbing vertically and going sideways. There was no sound. An F-94 aircraft was scrambled but a thirty minute search of the area produced negative intercept results.

II. Discussion of Incident

A check of adjacent radar sites revealed no unusual returns or activity in the area. The winds were generally from 240° below an overcast at 12,000'. Thus the object would appear to move against the wind since it must have been below the clouds. There was no air traffic reported in the area.

III. Conclusion

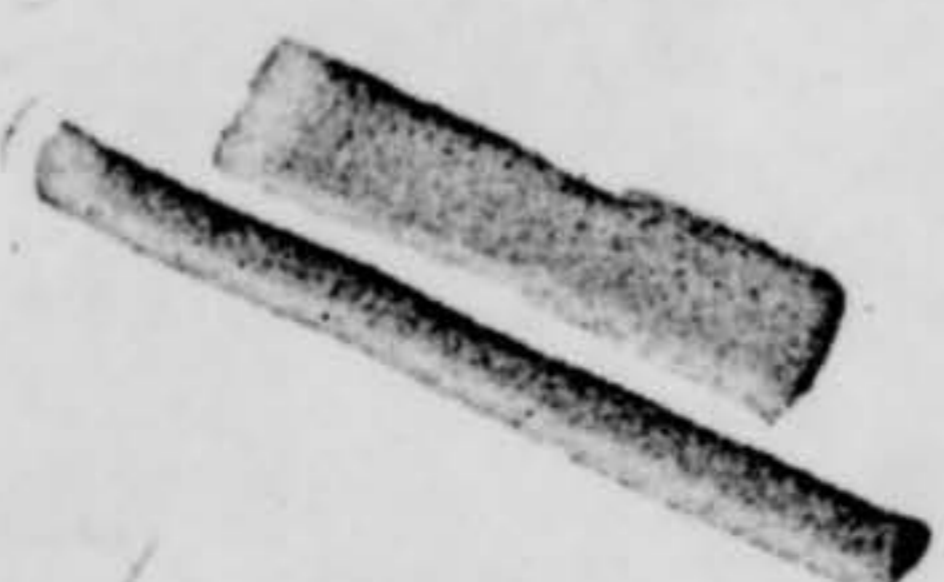

On 8 January 1953 the sighting of an unidentified flying object was reported by members of the 82d Fighter-Interceptor Squadron, a unit of the Air Defense Command stationed at Larson AFB. The following information was secured by Lt [redacted] and myself during the time following the sightings.

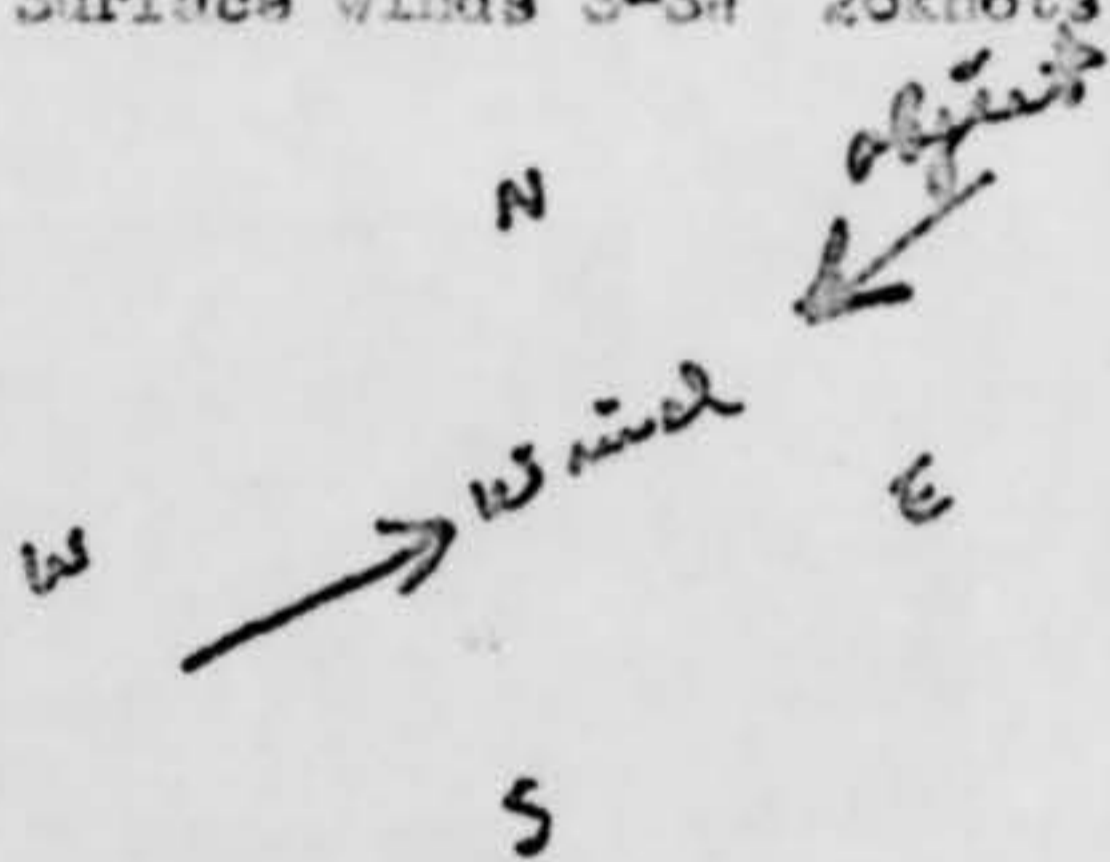
Descriptions of the object were varied, i.e., cigar shaped, round like a disc, similar to the tailpipe of a F-94, but the consensus of opinion was that it was circular somewhat resembling a large weather balloon and all agreed that it was green in color. There was no report of sound connected with the sighting and the maneuvers were described as bobbing, going sideways but always in the same general Southwesterly direction from the base.

The first sighting was at 0715 and it could not be observed after 0730.

The majority of the observers were in the squadron area on the base but several reported seeing the object while driving toward the base from EPHRATA, WASH, a small town 14 miles NNE of Larson AFB. All observations were from the ground and were visual. A check with radar sites in this vicinity show that no unusual objects or activity was noted at this time. There were no weather balloon launches from this base during the reporting period.

The following weather conditions existed over the base and in the vicinity;
LARSON AFB 0727 9,000' Broken, 12,000' overcast, Surface winds S-SW 26 knots with gusts up to 36 knots visibility 16 miles.

All Personell reported the object just below cloud layer and heading in a South West direction from LARSON which is against the above Winds aloft reports from stations surrounding this base. No one reported the object disappearing into the clouds. Most observers reported on in to their respective jobs as this unit commences work at 0730.

The Sq Commander having observed the object requested permission to send up a flight of F-94 acft and this was granted. They became airborne at 0743 and remained airborne thirty minutes mattress searching with no results.

There was no reported air traffic in the vicinity and there were no known photographs taken.
