SUBJECT: FLYOBREP

In accordance with AFL 200-5, dated 29 April 1952, subject: Unidentified Flying Objects Reporting (Short Title: FLYOBREP), the following report of an unidentified flying object is submitted:

On 10 January 1953, between 1545 hours and 1600 hours, PST (2345Z and 2400Z), Colonel [REDACTED] USAF (Ret) and Mr. [REDACTED] of the Federal Security Agency, San Francisco, California, observed an unidentified flying object while eight (8) miles northwest of Sonoma, California, from a knoll in the hills northwest of the Sonoma Valley. The object was sighted at a 45° angle northwest from the location of the observers at a very high altitude, so high that the object was compared to the flat head of a pin held two feet from the eye. Speed was estimated at four times the speed of a jet aircraft with accompanying sound similar to the USAF F-86 jet at high altitude. There was no change in sound tone or volume during maneuvers. Unusual maneuvers made by the object were; (1) - Three (3) 360° tight turns to the right, taking 2 to 3 seconds to complete each turn; (2) - Two (2) right angle (90°) turns, first to the right, then to the left; (3) - The object slowed down to almost a complete stop, then accelerated to high speed again, making this maneuver twice. The object then rose vertically and disappeared from view. Total time of observation was estimated to be between 60 and 75 seconds. There were no radar contacts with this object. No other observations of this object are known to have been made.

On 15 January 1953 at 1135 hours PST (1935Z), one Colonel [REDACTED] USAF, (Retired), appeared and was interrogated in the Office of the Director of Intelligence, Hamilton Air Force Base, Hamilton, California, stating he had observed an unidentified flying object. A tape recording of this interrogation was made and is forwarded with this report as inclosure #1. Information contained therein is as follows:

1. Description of Object:

- Shape: Unknown due to high altitude.
- Size: About the size of a pin-head held 2 feet from the eye.
- Color: Silvery, possibly due to reflection of sun against aircraft-type covering.
- Speed: Great speed. Estimated as 4 times the speed of a jet aircraft.
- Sound: Similar to sound of an F-86 at high altitude, with no change in tone or volume during maneuvers.
- Maneuvers: The object made three (3), 360° turns to the right taking 2 to 3 seconds to complete each turn. These turns were made at 5 second intervals still holding on the same course. It continued on and made an abrupt right angle (90°) turn to the right, followed 5 seconds later with an abrupt turn to the left which placed the object back on its original course. After this maneuver, the object slowed down to almost a stop and then accelerated to its previous speed, making this maneuver twice. The object then rose vertically and disappeared from view. (The observer stated that the object could possibly have been climbing

when it seemed to slow down to a stop but that he seriously doubted it). The 360° turns were said to be very tight turns, about one-eighth (1/8th) of area required for jet aircraft.

Trails or Exhaust: None observed.

Propulsion System: Not reported.

Number of Objects: One (1)

Manner of Disappearance: Object rose vertically and disappeared from view to the northwest.

Other Pertinent or Unusual Features: The glinting did not change during the maneuvers.

2. Time of Sighting:

Local Time: Between 1545 hrs and 1600 hrs, 10 Jan 53

Zebra Time: Between 2345Z and 2400Z, 10 Jan 53

Length of Time Observed: From 60 to 75 seconds by Colonel [redacted] Mr [redacted] saw object 10 seconds later when Colonel [redacted] pointed it out to him, due to the objects terrific speed and high altitude.

3. Manner of Observation: Visual without aids. The 28th Air Division (Defense) reported no radar contacts with this object during the time and date reported.

4. Location of Observers During Sighting:

Eight (8) miles northwest of Sonoma, California, from a knoll in the hills northwest of Sonoma Valley near the crest of Trinity Road connecting the Sonoma and Napa Valleys. The object was sighted at a 45° angle northwest of position of the observers. Distance of object from observers was undetermined, flying at a very high altitude in a northwest direction. Altitude was determined to be greater than that normally flown by jet aircraft.

5. Reliability of Information:

Colonel [redacted] stated he had a total of over 1,000 hours flying time and is familiar with various types of aircraft. However, he stated that Mr. Hunter's background does not indicate much familiarity with aircraft.

6. Weather, Winds and Visibility at Time and Place of Sighting:

Observers Report: The sun was dropping in the West. Visibility was good, ceiling was unlimited with sufficient light for good observation.

I. Description of Incident

At 2345 ~~3~~ two civilian sources observed one small flying object moving at a great rate of speed and performing violent maneuvers. The object's sound was similar to that of a jet aircraft. The object made three 360° right turns in nine seconds then performed abrupt 90° turns first to the right, then to the left. The object then stopped, accelerated to its former speed, rose vertically and disappeared.

II. Discussion of Incident

The only known aerial object capable of appearing to go through the described maneuvers would be a balloon; however, the time factors and velocity estimates do not support this conclusion.

III. Conclusion
