1. The following information is in confirmation of information furnished verbally to your command on 17 June 1954, and, also, to facilitate compliance by your Command in accordance with instructions outlined in Paragraph 7, AFM 200-8.

2. On 18 June 1954, at approximately 1030 hours, this office was requested by the Provost Marshal, Air Force Missile Test Center, to contact the Air Force Missile Test Center Intelligence Officer, regarding the sighting of unidentified flying objects near Indialantic, Florida.

3. On 18 June 1954, Major A. C. SMALLSTY, Intelligence Branch, AFMTC, advised that on 11 June 1954, Mr. ██████████ Civilian, RCA Services, Patrick Air Force Base, Florida, had reported that at 2130 hours, MDT, 8 June 1954, ██████████ was looking out over the Atlantic ocean, East of Neptune Hall, Indialantic, Florida. The weather was overcast, with intermittent showers. An intense white beam, brighter than a flashlight beam, but approximately the same size as a large flashlight beam, was noted shining from a point of approximately 100 yards offshore. The light flashes lasted for approximately four (4) seconds and rotated clockwise for approximately 10 cycles. After an approximate three (3) minute interval, the lights began to cycle again for approximately 10 cycles. ██████████ turned on the spotlight of his automobile and directed the spotlight at the area of the lights. At this time, the light quit cycling and nothing could be seen. The lights did not reoccur after the spotlight was turned off. A check of the local charts and tide tables indicate approximately forty (40) feet of water at the time of the above occurrence as the time it occurred.

4. On 18 June 1954, this office was requested to determine circumstances surrounding an entry in the Air Police Deck Sergeant's log, concerning the sighting of an unidentified aerial object on 18 June 1954, by an air policeman on guard duty in front of Air Force Base, entry 740, recorded at 2135 hours.

MOSELEY called two airmen from Base Operations to witness the object. These two (2) airmen were: BYRON D. TILLEY, A/SC, AF-12430040, and JAMES R. DUNCAN, A/SC, AF-14406280, both of 5650th Air Base Group, Patrick Air Force Base, Florida. The object was first sighted SSW of MOSELEY, at a 20 degree angle of elevation, and as a bright light moving in a northerly direction. The object moved northward to a position directly west of observers, at an angle of elevation of 50-60 degrees. The object traveled a general northerly course during this movement and appeared to veer right and left at sharp angles while moving. The rate of speed was greater than that of an aircraft. The color of the object was a blue fluorescent, changing intermittently to white. No discernible features were visible, no sound was heard, and no trail or exhaust was discernible. The light blinked continually and at regular intervals. The object appeared to climb in a northwest direction after the stop directly west of Patrick AFB. The object appeared to continue to climb and was visible until obscured by cloud coverage at 0015 hours, EST, 17 June 1954. The object appeared to be several times larger than the brightest visible star. A full moon was visible in the sky also. Occasionally, when the light blinked and became brighter, it appeared that the object might be crescent shaped on the lower side. No air traffic was known to be in the area at the time. It was noted that Major MOSELEY is a Senior Pilot and also on duty as Airdrome Officer at the time of the sighting. SUBJECT: (Unclassified) UNIDENTIFIED FLYING OBJECTS

15 June 1954, under Air Police Desk Sergeant's log, reflected that A/SC LEON R. MANLEY, AF-14479480, 6650th Air Police Squadron, Patrick Air Force Base, Florida, saw a bright object flying approximately 100 feet high, to the Northwest of Post #26. The object turned from white to red, to green, and to blue. The control tower was notified. MANLEY was interviewed on 18 June 1954, and advised that approximately 2130 hours, EST, 18 June 1954, he noticed a glowing light in the sky, Northwest of Post #26, at approximately 200 feet altitude, over the size of the flying field or the Banana River. The glow appeared nearly round in shape and resembled an aircraft landing light. The glow was first noticed as a bright white, turning to red and disappearing without moving from original position sighted. The glow appeared almost immediately in the same position, red in color, changing to bright white; remained visible a short time and disappeared suddenly. The entire period of visibility was approximately five (5) minutes. MANLEY stated that he saw a small cloud drift behind object while visible. MANLEY stated that the moon was visible south of his post and was practically obscured by clouds. The object sighted was approximately one-fourth the size of the moon, which was nearly full. It is noted that MANLEY has previously completed most of the Air Force pilot's training course.
