INFORMATION AT APPROXIMATELY 2130E TIME. A NEIGHBOR MRS [REDACTED]
[REDACTED], CONCORD MASS, [REDACTED] CALLED HER ATTENTION TO UNUSUAL
LIGHTS TRAVELING AT HIGH SPEED IN THE SKY DESCRIBED AS BEING CIRCULAR
TO OBLONG, WHITISH IN COLOR WITH ROUNDED EDGES. MRS [REDACTED] COULD GIVE NO
ESTIMATE AS TO SIZE OR SPEED EXCEPT THAT THEY WERE TRAVELING AT VERY HIGH
SPEED APARENTLY IN A CIRCLE. WHEN SHE FIRST SAW THEM THEY WERE TRAVELING
FROM LEFT TO RIGHT, STOPPED AND MOVED FROM RIGHT TO LEFT. THEMOST SEEN
AT ANYONE TIME WAS THREE. ONE TIME ONE SEEMED TO BE ABOVE THE OTHER WITH

ONE BEHIND. NO SOUND WAS AUDIBLE. NO KNOWLEDGE OF WHERE THEY DISAPPEARED
TO AS THEY SEEMED TO GO DOWN BEHIND TREES WHICH OBSTRUCTED HER RANGE OF
VISION. OBJECTS VISIBLE FOR A PERIOD OF ABOUT 20 MINUTES. SEEMED TO BE
DIRECTLY OVER CONCORD CENTER MASS. AT TIME OF SIGHTING L G HANSCOM FIELD
TOWER REPORTS THAT AT THIS TIME A SEARCH LIGHT WAS ROTATING IN THE
DIRECTION OF WALTHAM, MASS AND THEY NOTICE REFLECTIONS OFF OF THE CLOUDS
AS A RESULT OF THE SEARCH LIGHT. L G HANSCOM WEATHER WAS REPORTING
AT 2130E TIME SURFACE WINDS WESTERLY 10 TO 14 KNOTS, 12,000 FT SCATTERED
TO BROKEN CLOA, VISIBILITY 10 MI. AT THE TIME THE ORIGINATOR OF THIS
MESSAGE TALKED TO MRS [REDACTED] SHE WAS STILL UNCERTAIN AS TO WHAT SHE HAD
SEEN WAS A RESULT OF THE SEARCH LIGHTS BUT BETWEEN THE TIME OF HER CALL
TO BASE OPERATIONS THIS COMMAND AND THE ORIGINATOR TALKING TO HER SHE
