

- (2) Description of course of the object:
- (a) Observer awoke at 21/0747Z and saw a yellow object, shining brighter than any star. He then awakened his wife to verify his sighting.
  - (b) The object was in a westerly direction at approximately 20 degrees elevation.
  - (c) Five (5) or six (6) degrees elevation.
  - (d) The object seemed to be vibrating at a fairly high speed. First it would move back and forth horizontally, then it would vibrate vertically. Vibration was so slight that it was hardly noticeable. Object did not appear to be on any set flight pattern and it did not move in any direction other than to vibrate and finally to descend below the horizon.
  - (e) Object descended slowly from sight, reappeared once and then slowly disappeared from sight behind a cluster of trees and was not seen again. Observers watched the horizon for approximately ten (10) minutes for the return of the object.
