In compliance with AIR 200-2, dated 26 August 1953, the following report is submitted:

- (1) (a) Object was round.
 - (b) Size estimated to be approximately equal to that of an orange held in the hand at about arm's length.
 - (c) Object was orange colored.
 - (d) One object was observed.
 - (e) N/A
 - (f) No discernible features or details noted.
 - (g) No tail, trail, or exhaust noted.
 - (h) No sound was heard.
 - (i) Observer did not notice object until it was almost directly overhead and at first thought the object to be a shooting star but immediately noted that it was too low and much too large to be a star. Observer further noted that the object was orange colored instead of white as previously observed shooting stars.
- (2) (a) Observer was in the front yard of her residence watering shrubs and flowers by the light of a kerosene lantern. Observer's back was to lantern when she noticed a large flash. Observer feared that lantern had exploded and had turned to face the lantern when she noticed the light in the sky.
 - (b) Angle of elevation of the object when first observed was approximately 90 degrees.
 - (c) Angle of elevation of the object upon disappearance was about 45 degrees.
 - (d) Object flew a straight and level flight path when observed. First observed almost directly overhead and flew approximately northward until it disappeared.
 - (e) Object disappeared by passing out of view (Observer's home obstructed line of vision).
 - (f) Object was observed between two and four seconds.
- (3) (a) A visual ground observation was made.
 - (b) No optical or electronic aids used.
 - (c) N/A
- (4) (a) Object sighted 220500Z July 1954.
 - (b) Light conditions: Night.
- (5) Observation made from observer's residence, 109 East Castle Hills Lane, San Antonio, Texas.
- (6) Observation made by Mrs. [REDACTED] Civilian, [REDACTED] Occupation: Landlady. Reliability unknown.
- (7) (a) Observer stated that it was a clear night with a few scattered clouds and no moon.
