On Tuesday evening, 17 August 1954, a newspaperman from Hampton, Virginia, two (2) civilians from Warwick, Virginia, and a Langley AFB Airman, reported that at approximately 0010Z Hours, 18 August 1954, they observed an unusual phenomena over this area in the form of a glowing white spherical object, appearing from WSW direction and disappearing on an ENE heading.

This glowing object which varied in size according to the individual observers moved on a straight and level path, vanishing suddenly as a light bulb turned off.

The Wednesday morning edition of the "Daily Press" from Newport News, Virginia carried an account of the incident, and by 1700Z, 18 August 1954, two more observers had called in and stated that they had witnessed the phenomena.

11. Known traffic over Langley AFB, Va. consisted of two (2) B-36's; also in the vicinity were one (1) B-57 and numerous conventional type aircraft. In addition the NewportNews-Hampton area is within the local flying area for the Naval aircraft from Oceania and the Norfolk Naval Air Station.

12. Base Intelligence Officer's Comment:

In addition to the observers contacted (Item 6) two other persons were reported by the newspapers as having seen the object. Preliminary attempts to interview these persons have been unsuccessful. It is believed that the sighting was the exhaust of a jet aircraft or a tail light on a low flying jet aircraft.
