Dear Mr. [redacted]

Not knowing to what department I should address this letter I am sending it to you with request that you forward it to the proper department for whatever attention it warrants.

I am writing this letter believing that some department in the Government might be interested in the strange phenomenon witnessed by my wife and I on October 22. Also I would like to have some one who knows explain the nature of the phenomenon and what caused it.

While working in our yard my wife ^{and I} saw in the western sky a fast moving object moving in a south easterly direction which was in the direction of the Dayton Air port.

It was too high and too far away to see an outline of it but in a bright sunshine it was very bright and about the size of a large toy balloon. It moved so rapidly that it was within our vision only a minute or two. This may have been a jet plane but all jet planes I have seen leave in their wake a streamer of smoke or gas. Watching the fast moving object we saw, ~~we~~ observed no streamer of gas or smoke.

However our curiosity was not aroused until after the bright shining object had disappeared beyond our vision, when a strange phenomenon occurred.

Immediately following the disappearance of the bright object, we saw in the direction of the spot where the fast moving object had disappeared, ~~we saw~~ dozens of objects floating in the sky. Perhaps I can best describe their look by saying we were reminded of the pictures we have seen of paratroopers being dropped from army planes.

These objects varied in size, some being as large as a foot to a foot and half in diameter while others were much smaller. They were round in shape and very bright. At first they seemed to be as far off as the bright fast moving object we had watched before it disappeared. But of course the distance and the size may have been deceptive by an optical illusion.

As we watched these dozens of objects floating towards the earth some came towards us and one floated directly over our heads but before it came near us it lost its round shape and lengthened into a streamer shaped object and attached itself to the antenna of our TV set. Where it attached itself to the antenna it was thread like but it thickened from the end attached to the antenna to the loose end. At the loose end it was an inch or an inch and a half in diameter. As we watched it, it floated like a streamer in a horizontal position in a line with the TV beam between our antenna and the Dayton TV station. Further observation brought to our vision dozens of thread like objects floating from our antenna all pointing to the Dayton TV station in Dayton.

This streamer was at least 15 feet long.

Not this was not all. We also saw shiny thread like objects floating from the tree tops in the front of our yard to the west.

Later we noticed some of this material on the bushes near us. At examining it closely it was ribbon like, that is flat rather than round and took on the appearance of rainbow colored plastic. In width also it was probably 1/32nd of an inch in size or smaller, and no thicker than a hair.

A few days later we heard a news broadcaster at WLW and also on the WHIT broadcast news program describe the phenomenon we had seen, from a report they had received from Marysville, Ohio. These broadcasters said the spectacle had been seen by two school teachers and their sixty pupils.

Telling a friend about this strange spectacle he said that we had seen what was probably spider webs as it was generally known that spiders weave large webs and float them in the air to carry the spiders from place to place.
