In compliance with AFR 200-2, dated 12 August 1954, Subject: Unidentified Flying Objects Reporting (Short Title: UFOB), the following report of referenced object is submitted:

On the morning of 23 November 1954 at 1655Z, a Unidentified Flying Object was sighted by two persons, Mr. [redacted], a pilot with CARCO Airlines, and a Mr. [redacted], a control tower technician at Los Alamos, New Mexico. The sighting by Mr. [redacted] was made from the control tower at Los Alamos, by Mr. [redacted] from a CARCO aircraft, airborne, heading toward the object. The shape of the object is unknown, size is unknown, it was a single object, silver in color, having no trail or exhaust and was traveling slow, sixty to one hundred knots. The object had no sound audible to the observers, the propulsion system and any aerodynamic features are unknown. The object had no other unusual features. The object was sighted visually, the weather and winds were stated by the observers to be "clear with high ceiling and no visual obstructions." No physical evidence was received. Two F-86's were diverted to look for this object but results were negative. There was no traffic in this area at this time that might account for the sighting.
