Dear Mr. [REDACTED]

This is to acknowledge your letter of 29 January 1958 concerning unidentified flying objects which you photographed during the period of 1954-1956. The long time interval since the sighting, the lack of supporting information, and the poor quality of the photograph made it most difficult to properly evaluate this sighting.

However, enlargements show the objects appear to be birds on the rise, probably pheasants. Also, the foggy condition of the sky indicates smoke, possibly from a forest fire or brush fire.

We are returning the original photograph with one enlargement, together with the latest Department of Defense fact sheet on unidentified flying objects, dated 5 November 1957.
