SUBJECT: Report of UFO Sighting Based on Interrogation
of [REDACTED], Mo.

On the 14 of February, 1955 at 1715 CST (2315Z) [REDACTED] and [REDACTED] were driving north on State Highway #5, five miles north of Milan, Missouri. Miss [REDACTED] caught a glimpse of a shiny, metallic object, which appeared to be hovering in the air at a very high altitude and at a very great distance. She immediately called her companion's attention to the unusual object. Her companion, [REDACTED] after a brief glance returned his attention to his driving and could not give a description of the object. Miss [REDACTED] thought no more of the object at the time and upon arrival at home began thinking of it. She then called the Editor of the Green City Paper ([REDACTED]) and told him of the incident. Mr. Elmer Morris contacted me on the next day and told me of this sighting.

The distance between the two sightings was approximately 8-10 miles with a difference of fifteen minutes in time. (In reference to Mr. [REDACTED]'s sighting.)

It is the opinion of the investigating team that the object seen was one of the balloons (weather) recently released.
