BOTH MEN WERE VERY SINCERE IN THE WAY THEY EXPLAINED THE SIGHTING TO ME., NO DESCRIPTION COULD BE GIVEN EXCEPT FOR THE OBJECT BEING ROUND AND GIVING OFF A VERY BRIGHT LIGHT. OBJECT WAS AT AN ESTIMATED FOUR TO FIVE HUNDRED FT. HIGH, IN A DOWNWARD DESCENDING ANGLE OF 30 DEGREES., SPEED 100 MPH. FROM THE QUESTIONERS AND COMMENTS OF THE TWO OBSERVERS, I BELIEVE IT TO BE POSSIBLY AN AIRCRAFT, EXCEPT THAT THE LIGHT GIVEN OFF THE THE OBJECT WAS STEADY AND NOT FLUCTUATING.
