 - (a) Son, age 8 years, first sighted object and called his father's attention to it.
 - (b) Angle of elevation approximately 85° and azimuth approximately 270° when object first sighted.
 - (c) Angle of elevation approximately 30° and azimuth approximately 270° when object disappeared.
 - (d) Object flew on a straight and level flight path. First observed almost directly overhead and flew West until it disappeared.
 - (e) Object disappeared by passing out of range of vision.
