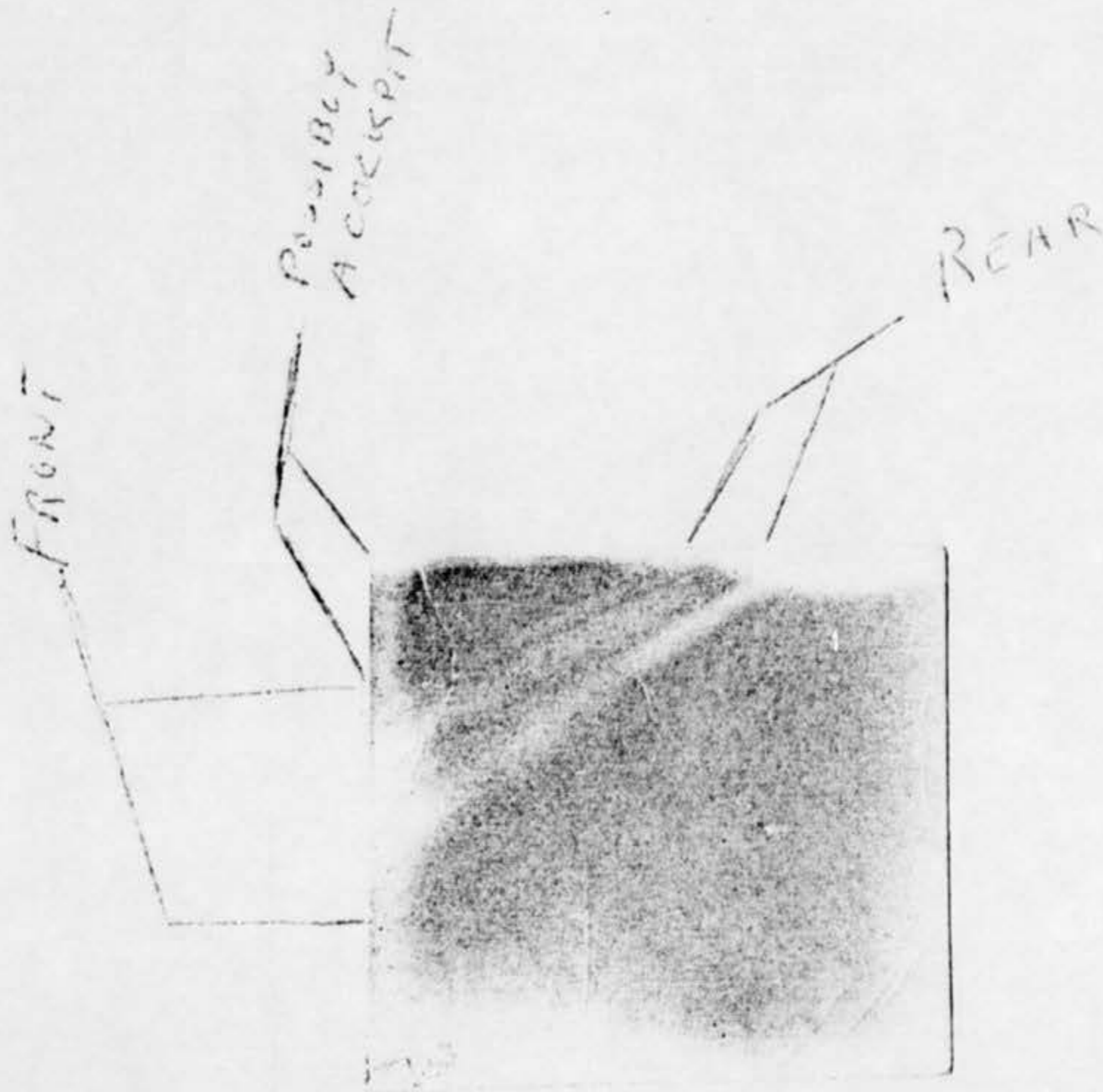




SUBJECT: Request for Photo Negative
