On Feb 29, 1956 at 6:50 P.M. I had spotted a bright light in the sky. which I watched for about 5 mins before drawing it to anyone elses attention of which when I did this person also saw the bright-lighted object. After I left this person I continued to walk up the street, and when I reached the top of our street and the object was still there I then went into a gas station and brought it to the attention of the attendant when I was sure he had also seen the object I then called it into the Filter Center. After I left the gas station I continued to observe this strange light when I noticed that was also another one of the same description except for one detail which was that it had a green - haze around the outside also in the sky about 25-40 miles away from the first one, when I was sure that it was not the same object I made a second call into the Filter Center and reported the second one. I had observed the lights for about 4 hrs. before going into a building. At about that time I went into the house for about 15 min. I returned outside to find both objects still in the sky, one overhead, and one about 4 or 5 miles to the S.E. The second light disappeared about 15 - 20 mins after I came out the second last time, although I did not see it go, it was gone. But the first one was still at about the same distance as it was all night. It was quite lowwhen I last saw the first one. I then went into the house and went to bed; so as I did not see it after that. Both my mother and several witnesses saw the object.



II. RELIABILITY: SOURCE was relaxed, self-confident, and very precise in his manner as well as in his answers. SOURCE stated that this was his first experience with anything of this nature and expressed a desire to do anything possible to help in identification of the object. Other personnel in both the 763rd AC & W station and the 47th FIS stated that Capt Solon was an excellent officer, a capable pilot and a man of high integrity. SOURCE appeared to be the type of person who would employ the good reasoning powers he possessed in evaluating this situation. Therefore, in the investigator's opinion, information given by SOURCE is considered to be reliable.

III. DESCRIPTION OF CHIECT BY SOURCE:

- I. SOURCE was on standby duty at 47th FIS, Niagara Falls AFB (GEOREF GJLP 5806) when he was scrambled by the 763rd AC & W station to intercept an unidentified flying object in the Hamburg, N.Y. (GEOREF GJMN 1042) area. The 763rd AC & W had been notified of this object by the Buffale GOC Filter Center. SOURCE scrambled in an F-86D type aircraft at approximately 01/0210Z Mar 56 and flow to the Hamburg area.
- 2. SOURCE then made visual contact with the object and retained his contact for the next 40-50 minutes. During the time of observation there were many stars, no moonlight, no clouds from 4,000 feet up, and no trace of daylight. SOURCE estimated actual size of the object to be larger than an aircraft, but at no time did it appear larger than a half dollar held at arm's length.
- 3. SOURCE seemed to be greatly impressed with the brightness of the object. It always appeared to him to be of a white luminous color except for the red light seen in the object when he was at an altitude of 32,000 feet. The actual brightness of the object was never constant and it continually changed in intensity. SOURCE described the object as being similar to roving type searchlights without a beam reflector.

- 4. SOURCE had no definite opinion as to identity of the object, however, he was absolutely sure that it was not a contemporary aircraft. SOURCE did state that object could possibly be a refraction of light, but the processes causing such a phenomenon were unknown to him.

- 1. Departed Niagara Falls AFB at approximately 2110-29 Feb 56 after being notified by GCI that G.O.C. had reported some unidentified lites in the Hamburg Area of Buffalo, N.Y.
- 2. After leveling out at 4000' indicated and contacting GCI,-I was vectored into the Hamburg Area of Buffalo, N.Y.
- 3. When I arrived over the Hamburg Area I did not notice any lites, but I did notice a large bright lite that appeared to be directly over the down town portion of Buffalo, N.Y. At this time I started to investigate. My heading was 300 degrees magnetic - at first I thought it was a transport or a bomber - but I could not decrease my range from this object. At this time I thought this must be a star so I reported back to the Hamburg Area - with the intentions that this star would stay in the same relative position.
- 4. When arriving over Hamburg I look outside and there this was again off my left wing. At this time I was a little confused. I then took up a heading of north and reaching the south shore of Lake Ontario I did a 180 degree turn and flew about 15-20 south of Buffalo - still this bright object was off my right wing - never any azimuth separation. After passing Buffalo I decided I would determine if this was my imagination, a star or an object. I concluded that if this was a star by pointing my aircraft directly at this object and climbing to the maximum altitude of the F-86D I would stall out with the object in the same position. I started climbing and it was always up and ahead of me. But while I was climbing it appeared that I was getting closer in range. The object definitely got brighter and finally at 32,000' I was level with the object-because at this point instead of looking up at it, I was looking out and level with it at my flight altitude. This was the first time I seemed to be getting closer, then I notice a flashing red lite - intermittently flashing from this object. At this time I was 91 N-miles W-NW of home plate - all of a sudden it seemed to increase the gap between me and the object, at this time I was running low on fuel - and called it quits - after turning back for home I kept this object in sight with the rear view mirror in the A/C - I decided to take one last look, -I banked the A/C around and there was behind me - then, all of a sudden it disappeared -I banked the A/C around and returned to my Base, landing at 2230 est. At no time did I even get a radar contact with my radar equip. -that was operating very satisfactorily.



SUPPLEMENTARY INVESTIGATIVE EFFORTS:

- 1. A check with the 47th FIS Intelligence Section, Niagara Falls AFE, Niagara Falls, N.Y. (GEOREF GJLP 5806), revealed that Capt. A had been scrambled in his F-86D to intercept or observe the UFOB. No further information could be immediately gained, as Capt. was off duty and could not be reached by the Intelligence Section by phone. He was fully interviewed on the following day at 02/1230Z Mar 56 for two (2) hours.
- 2. A trip was made to the Buffalo Filter Center, Buffalo, N.Y. (GEOREF GJMN 1055), where a check revealed that they had relayed information to the 763rd AC & W Squadron on the UFOB the previous night. Lt. Charles Stout, Adjutant, and Capt. Charles Turner, Commander, were inteviewed. Neither had seen the object, and had no opinion on what it was, but vouched for Mr. White and Mr. Smith as to their reliability.
- 3. Lt. Rouce from the 763rd AC & W Squadron was contacted. He had scrambled the F-86D on the basis of the report received from the Buffalo Filter Center. He had also sent out the initial report. It was learned from him that similar type reports had been called in intermittently during the week, concerning unidentified lights over Eastern LAKE ERIE (GEOREF GJLN 5045).
- 4. Capt. Earle Flagg, Buffalo Filter Center, explained that the Buffalo News was carrying news articles on the "strange lights" over Lake Erie. The conclusions of the newsmen seemed to lean towards the idea that the object was a normal aircraft in the area.
- 5. A check with local weather station substantiated the winds aloft report given in the imitial report. The following additional information was also gained:

- 6. A check was made with Division Operations, which revealed locations of lights and beacons shown in Incl. #1.
- 7. A check was made with Division AAA representative, Lt. Col James N. Lewis, and Fort Niagara Operations Officer, Maj. John Scott. It was learned that two (2) radar sets were on surveillance on the night of the 29th, and a third was put in operation when the calls from Capt. Solon in his F-86D were heard. These people from Fort Niagara at NIAGARA FALLS (GEOREF GJLF 5806) did not actually observe the object. Attempts at radar pick-up proved negative.

COMMENTS OF PREPARING OFFICER:

- 1. It is the opinion of the Preparing Officer that the object was probably the planet Venus for the following reasons:
 - a. Using the process of elimination, the object was no doubt not an airplane, balloon, or star, as explained in Part Four, par. 8 of this report.
 - b. B. A. Manning and Lt. G. Dormer tend to support the possibility that the object could have been a glob of ionized gasses, but it is also their opinion that such a theory would be very difficult to prove. The Venus hypothesis seemed more probable.
 - c. As stated by Dr. Fredrickson (Part Four, par. 10), Venus is the brightest object in the sky during this time of year. It would definitely be setting around 2200 2230 EST, during which time it would give off a red color similar to the setting sun. A pilot would certainly not be cognizant of any notable closure on the planet Venus due to its distance from the Earth 60 million miles
 - Venus can be seen for at least four (4) hours at night prior to setting. During setting, Venus would appear further away due to decreased intensity. The object was seen in the West, which is the direction which Venus can always be seen this time of year.

COMMENTS of Approving Officer:

- 1. It is the opinion of this headquarters that this sighting was definitely caused by the planet Venus. The following is given in support of the above hypothesis:
- a. The planet Venus was located at the same position as the UFOB at the time of the sighting and was the brightest heavenly body in the sky.
 - b. The long duration of the sighting.
- c. Failure of airborne radar as well as three (3) ground radar sets to pick up the object.
- d. At the time of the attempted air intercept by Captain Solon, Venus was "setting" in the west and would have therefore appeared to be level with, or lower than, his aircraft. Captain heading while attempting to overtake the object was the approximate azimuth of Venus.

II. RELIABILITY: SOURCE was mild mannered, and appeared to give much thought and consideration to questions of investigators. He attempted to give concise and pertinent details of the sighting. Mr. White is well liked and considered a responsible member of his community. Due to his mild mannerism and responsible character, it is the investigator's opinion that information given by SOURCE was reliable to the best of his ability.

III. SOURCE'S DESCRIPTION OF SIGHTING:

- 1. SOURCE was working at Ben Otto Motors on the corner of Clark and McKinley Parkway, Hamburg, New York, (GJMN 1042). He was called out on the street by a friend to observe a bright light glowing in the sky at Ol/OlOOZ Mar 56.
- 2. The night was clear with scattered clouds and a slight breeze during the thirty minutes that SOURCE observed the object. Object seemed to swing with a pendulum motion due west from the observer's location. Object gave off an unusually brilliant white glow with northerly portion of object at greater intensity than the rest. Mr. White described the object as round except for a slight flatness on the bottom.
- 3. SOURCE heard no sound from the object. At times object did appear to stand still to him, but never suddenly accelerate in any direction. Glow of object seemed to change in intensity at various times during observation. However, the perimeter appeared to be fuzzy or blurred during entire observation.
- 4. Observation was made over a period of one and one-quarters hours, but was actually seen for only thirty minutes due to cloud obstructions at various times. Similar observations had been made by SOURCE during the past week.

Shortly a cloud obscured the object and later perhaps 15 mins. I again saw it but more to the NE towards Buffalo. I came home about 9:15 and it still was in the sky but appeared farther away.



II. RELIABILITY: SOURCE was a serious minded youth who appeared very interested in the GOC program. SOURCE's ability to identify configurations of various aircraft seemed to be high in accordance with that required of GOC observers. SOURCE was very cooperative and made every attempt to give accurate information. Information given by him is considered to be fairly reliable.

III. SOURCE'S DESCRIPTION OF SIGHTING:

- 1. On 29/2350Z Feb 56, SOURCE waswalking down South Shore Boulevard toward his home in Lackawanna, New York (GJMN 0949) when he spotted a bright light in the sky. After observing the object for approximately five minutes, SOURCE brought his mother's attention to it. It was learned through SOURCE that a gas station attendant also observed the object.
- 2. SOURCE stated that he observed one object for a period of three hours and forty minutes. SCURCE sighted a second object approximately twenty five to forty miles East of the first object. This object was sighted for approximately one hour during his observation of the first object.
- 3. The first object gave off a bright white glow during the entire observation. The second object gave off a bright glow but also had a green halo around the perimeter. Both objects had a fuzzy outline to their appearance.
- 4. During this observation of nearly four hours, SOURCE was in and out of his home, talked with his mother about objects and phoned Buffalo Filter Center and reported this sighting.
- 5. SCURCE has seen a similar type phenomenon during past week while carrying out his duties as GOC observer. SOURCE heard no sound from either object and stated that objects seemed to flicker, change intensity at times and although they did not accelerate to any appreciable speed, both objects did move South across the sky.
