MOROCCO - REPORT OF UNIDENTIFIED FLYING OBJECT AT CASABLANCA

4506.

Ref: (a) OPNAVINST 3820.9

1. GENERAL. On 6 April 1956 the local press carried an article stating that a mysterious flying object had flown over the city of Casablanca. The press article further stated that the object was luminous with a fiery yellow color, appeared in the east and appeared to cross over the city at a low altitude, turning at the same time, and disappeared a few seconds later in a southeasterly direction.

2. OBSERVER NO. 1. The object was reported by M. Tahiri, an employee at the local newspaper LA VIGIE, who describes the object as follows (enclosure (1) to reference (a)):

Description of object:

- a. Round or slightly oval shape.
- b. Size unknown.
- c. Yellow, fiery color.
- d. One in number.
- e. Not applicable.
- f. There may have been ~~something~~ something below the bright object that was part of it.
- g. There was no tail or trail.
- h. There was no sound.

Description of course of object:

- a. The observer first noticed the object because of its brightness.
- b. Object was first observed in the east and observer states it had an altitude of 2,000 - 3,000 meters.
- c. Object maintained its altitude throughout sighting.
- d. Object had a straight flight at a very low speed; however, observer further states object circled the city and disappeared toward the southeast (approximately Casas Airport direction).
- e. Object disappeared behind a cloud.
- f. Object was in view during 2 or 3 minutes. ← 0

Manner of observation - ground-visual.

Time and date of sighting - 2015, 5 April 1956 (light condition - dusk)

Location of observer - Across from Admiralty in front of the Jardin Public,  
Casablanca, Morocco.

Identification of observer - M. Tahiri, n/a LA VIGIE MAROCAINE Newspaper,  
83, bd des Youssef 5<sup>me</sup>  
Casablanca, Morocco

Weather at time of sighting - Ceiling was 7/8 cloudy at 400 meters.  
Wind from the southwest, 10 knots.

Observer No. 2. The object was viewed by another observer, Mr. Paul Hillion, who is employed at the Meteorological Station, Casablanca Airport, Casablanca. He made the following statement:

"I left Casablanca Airport to go home at about 2000 on 5 April 1956. I live across from the Italian Consulate (rue Margin). As I was about to open the gate to the house, I looked at the sky and saw something like a round fiery ball, an orange color, bluish on the edge. This lasted for only a few seconds. It was travelling east-west (on a perpendicular with rue Margin) and in a trajectory that seemed to take it toward the sea. I took it for granted that this was a meteorite."

COMMENT: The locations of the two observers was separated by a distance of approximately one mile. Observer No. 1 (M. Tahiri) would have had more opportunity to keep the object in unobstructed view for a longer period of time than observer No. 2. It appears likely the sighting was of a meteorite; however, this sighting is reported to make it a matter of record. USAF notified in accordance with reference (a).
