F3D's tried interception with succes due to extreme altitude of object.		11. COMMENTS Concur with the opinion of the rptng officers that this sighting was caused by a balloon. All facets of these sightings could not better fit a balloon hypothesis. Not only was balloon released in that area but a NOTAM had been /sent by the Ontario, Calif aprt about a balloon in the area at the time. Check w/ADC WX revealed that there was also a balloon(origin unknown)plotted E of the aeea few hrs earlier. This balloon drifting toward area of sighting.

9 TWO F3D A/C, FRONTPAGE BRAVO, ON CAP MADE ORIGINAL VISUAL SIGHTING, ATTEMPTED INTERCEPT AND COULD NOT REACH ALTITUDE OF OBJECT. TWO F3D A/C FRONTPAGE CHARLIE SCRAMBLED SUBSEQUENTLY BECAUSE OF VISUAL SIGHTINGS AND SCOPE READING (59,000FT ALT WITH NO SPEED) FROM P-76 MT. LAGUNA CALIF. THIS FLIGHT COULD NOT REACH ALTITUDE OF OBJECT.

10 ONE ADC UNKNOWN TRACK IN GENERAL AREA FADED JUST PRIOR TO FIRST REPORTS. NOTAM FROM ONTARIO, CALIFORNIA AIRPORT RECEIVED AT APPROXIMATELY 30/0600Z STATED THAT A BALLOON WAS OBSERVED IN THE GENERAL AREA IN QUESTION AT APPROXIMATELY THE SAME TIME AS THE SIGHTINGS TOOK PLACE
