2. Description of course of object:

- a. Mrs. Barry at 0600, 28 Nov 56, awoke and upon looking out her bedroom window observed a "flying saucer" which was approximately 4'x6' in diameter, dome shaped, and white in color.
- b. Object about 25 degrees above the horizon in a Westerly direction.
- c. Object remained at about the same elevation, moved to the North and disappeared.
- d. After watching approximately five minutes, the object moved Northward and disappeared. Shortly thereafter it returned to approximately its original position.
- e. After remaining in position approximately another five minutes, it again moved northward and disappeared.
- f. Ten minutes.

- b. Surface pressure rising continuously since 1400Z previous day. Ridge of hi pressure over Washington was rising in intensity and high pressure area was centered over Tallahassee, Florida. Although as indicated above surface winds were strong previous day they were absolutely calm at the time of sighting. Pressure rose from 29.79hg to 30.05 hg over past 30 hours. Radar set inoperative.

The windows of the [redacted] residence are covered with a plastic material which serves as a storm window. It is possible that some light refraction or distortion occurred and was mistakenly identified as an UFOB. Mrs. [redacted] did not appear to be seeking any personal notoriety. The reliability of this report is unknown.
