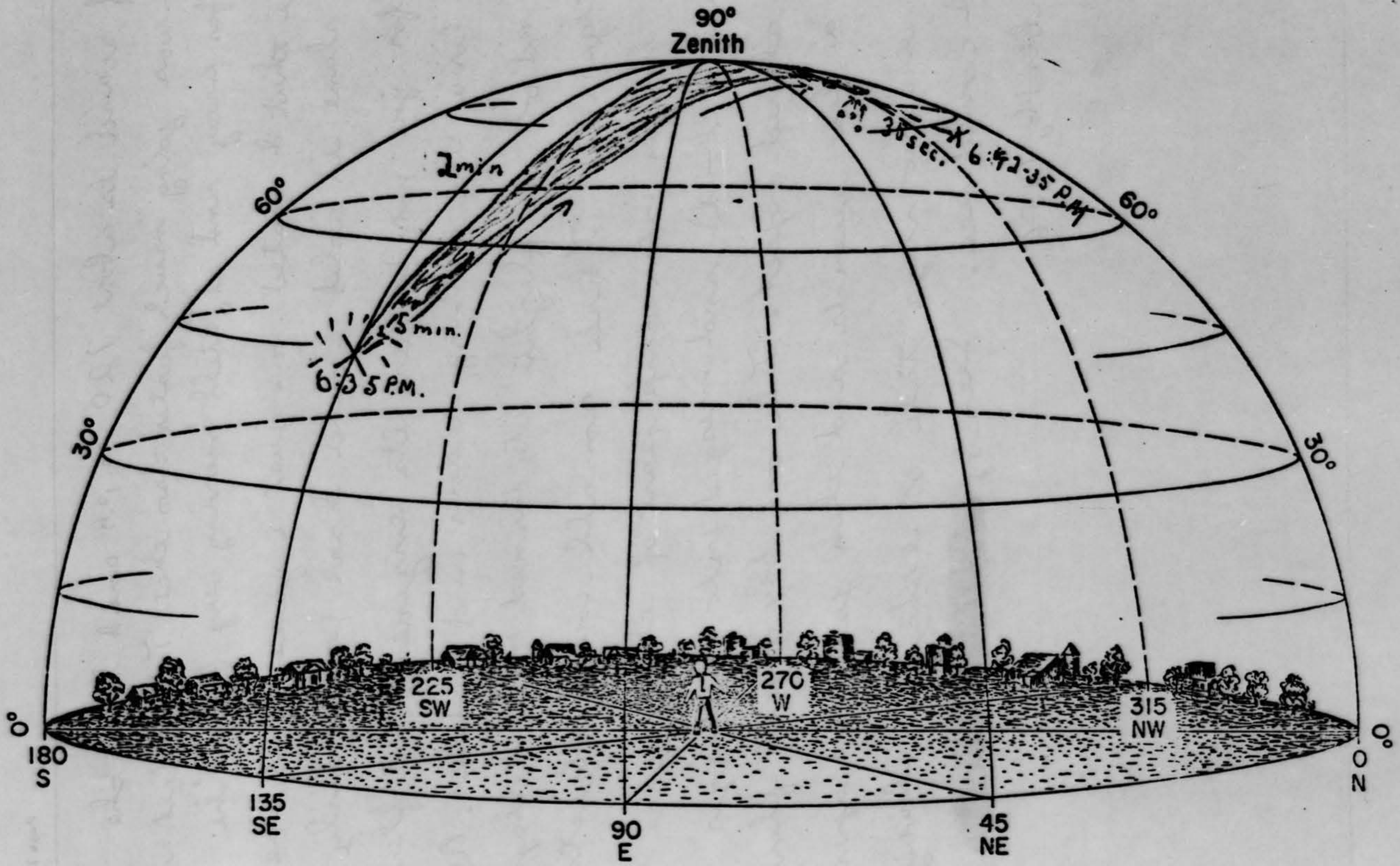

When I first saw it, it looked fairley far away. It was hovering in one position. The color was a dull red. It hovered for five minutes. Then it sped up quickly in a soucheast to North course (158° to 20°). As it built up speed the color turned to a bright red. The speed was at least 1000 m.p.h. (I figured out its speed by this method, about a week before I saw this thing, I saw a jet plane, F-86, break the sound barrier. There was a great thunder clap. And a short time later there was another one. The



approximate

speed of sound is about 720 m.p.h. and I know the object was going much faster than that. The object was pretty far away and it ^{was} still moving very fast. The altitude that I stated was just a guess. If it was an air plane it ~~would~~ would have to be fairly high for you not to hear its engines. It flew along for a time getting redder and redder. At the end of its flight it turned into a shape of a cigar (P.3). Three small round objects came from an extra dark part of the sky (probably a cloud) and merged into the bigger cigar shaped object. The one big object flew on for a few seconds and then just disappeared. There were no wings tail or exhausts showing that I could see. Seen by ~~████████████████████~~

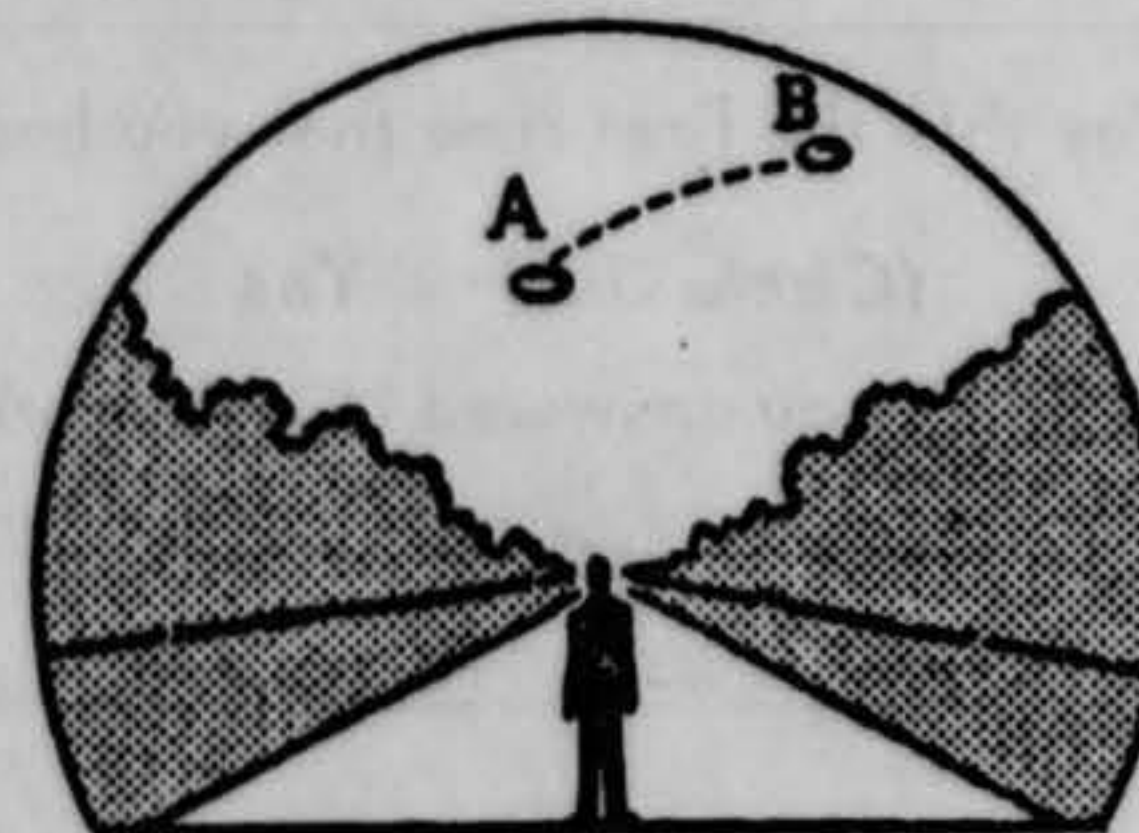
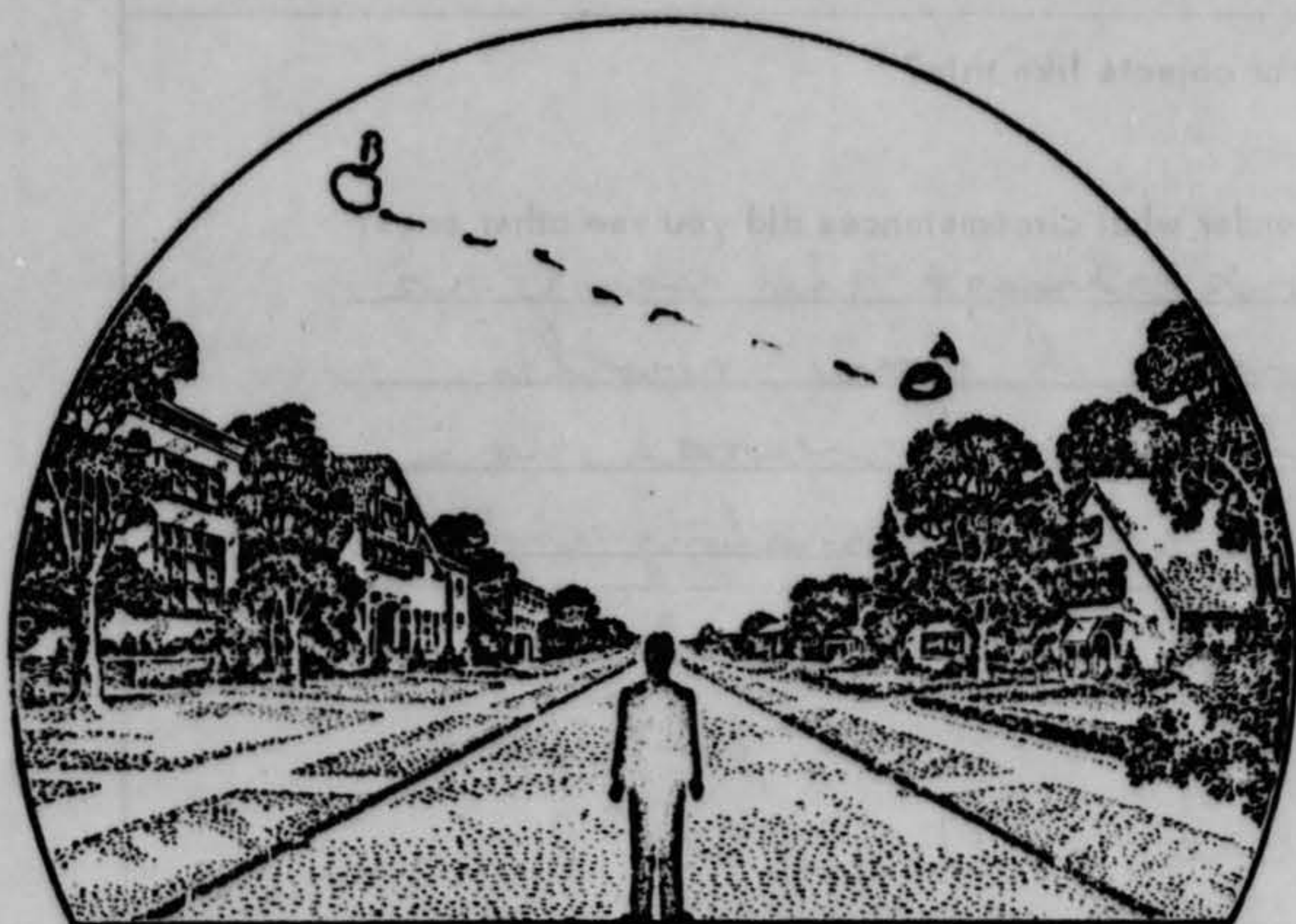
