Dear Sirs:

Due to the recent information being released by magazines and such leads me to believe that I might as well tell you of my experience years ago. I realize that this might be just another letter to throw in the trash can but I have nothing to lose or gain, so I'll start at the beginning.

I first saw this "object" about 1956. I'm not exactly sure, but I think it was winter time, anyway, I was with a girlfriend taking an afternoon ride. We were somewhere on route 52 outside of Philadelphia around 5 P.M. The area around there at the time was open fields with a house maybe every couple hundred yards or so. I haven't been there in years, so I'm not sure exactly where it was.

I was heading back towards Phila, where we both lived at the time. Thinking back, I'm pretty sure it was winter time because it was getting dark around 5 P.M. We were talking when my girl said "What are those lights I see ahead?" I really didn't look too close and said "Oh maybe a helicopter or something". We were getting closer all the time and my girl said "It's not a helicopter, we would hear the noise of it." I said "Well maybe it's a T.V. tower or something with lights on top." But we could both see that these lights were directly over a corn field off the right side of the road, and there was definitely nothing between the ground and this object. We both kept looking. I stopped the car, we both got out and walked over on the shoulder of the road, and the best I can describe this object would be almost round & dark, it wasn't lit up or glowing or anything. It appeared to be about 30 feet off the ground and maybe

about the size of a bread truck. It had 2 or 3 lights on it somewhere. I can't be sure now. Maybe they were red & green & white, but like I say, I can't really remember for sure.

Just about then a light like a search light shone down on the field and started to shine towards my car. I mean to tell you that my girl and I jumped back into the car fast. The light did shine over my car across the road and into the field on the other side, then the light went off and this object just went over top the car in the direction that the light had shone. No noise. Just ZIP.

out of sight. We drove away, and just around the first curve I came to there were about 5 cars stopped on the side, and the people were all out of their cars, looking up. Apparently they all saw what I did. I didn't stop. I told my girl not to say anything about it to anyone or they would say we were kookie or something. I got about another 100 yards when my headlights burned out. I stopped, and the switch on the dash was burned out. I fixed it and went on. It might have been coincidence. But that's all there was to the whole story. You can take it for what it's worth. I just thought it's about time I told it to someone.

The girl with me has since married, and is now living in New York State somewhere. I don't know where.
