

FIREBALL OF 1957 JANUARY 17

A.M.S. No. 2367

P. F. BROGAN and C. P. OLIVIER

On this date at about 6:45 p.m., P.S.T., a spectacular fireball appeared over Oregon, went roughly N.N.W., and ended over British Columbia. Immediately after its appearance P. F. Brogan, A.M.S. regional director for the region, made efforts to secure reports, both through newspapers and by personal contacts. In all, 13 which appear to belong to this body were obtained, 11 by him, 2 by Miss Eleanor Sandmeyer of Buhl, Idaho. Most of the reports are incomplete, partly due to some observers being in cars or indoors. The fireball's color, reported by 5, was blue, green or white, or a combination of these colors. There is no specific estimate of brightness or angular size except "large." However, one in a newspaper, of unknown origin, stated that its diameter was half that of the Moon. An aviator reported seeing it from Nevada but, as usual, with no coordinates. Why aviators, who must know what altitudes and bearings are, practically never give them is a mystery? Only 4 persons attempted to give the altitude of beginning point and 6 its azimuth. From these latter a roughly determined sub-beginning point is found and an even less certain height H₁ for beginning point.

The sub-endpoint is based on 6 apparently good, and 3 confirmatory azimuths. The stations were all far to the south and their maximum deviation at end point is only 52°. A single good Canadian observation would have been very valuable. As to the end height H₂ we have 11 altitudes, and one confirmatory. Hills and other obstacles behind which the fireball disappeared had to be allowed for, with consequent uncertainty. However, one does not wish to discard many reports made in good faith and some with considerable trouble, so a solution is made, which is the best we can derive from inadequate data. As stated, these reports were all gathered by Brogan except the 2 in Idaho. He also prepared the observations and made a preliminary chart. The final solution was made by Olivier. It is obvious that the heights here derived are much greater than usual for fireballs, but they are what the data offer. However, the one observation which gives a point on the path, though it is referred to the Pointers, gives an impossibly great height, and unfortunately can not be used as a check, as we usually do. Due to the great uncertainty in H₁, no orbit is calculated. The usual results follow:

RECENT SIGHTING REPORTS

DIAMOND-SHAPED FORMATION OVER BINGHAMTON, NEW YORK

January 25, 1957: CSI member Mrs. ██████████, of Binghamton, New York, sent us the details of a personal observation made at 6:35 a.m. on January 25. She saw four white lights in the southeast quadrant, traveling slowly east parallel to the horizon and 6 to 8 degrees above it, in a diamond-shaped formation. "The sky was overcast, so that the lights were diffused; at times the lights at the front and rear of the formation flashed brighter." They were in sight for about ten minutes, and were then lost in the thick overcast. As they moved away toward the east the lights became less bright, but did not diminish in size. Mrs. ██████████ was quite certain that they could not be planes because of the intensity of the front and rear lights.

NORTH ANDOVER HAS NOCTURNAL INTRUDER

January 28, 1957: CSI member [redacted], of North Andover, Massachusetts, describes in detail an observation by his father. At 10:15 p.m. Mr. [redacted] had put his car in the garage and was walking to the house when he saw "an object giving off a light blue luminescence...in a shallow climb and traveling at a speed approximately that of a fast jet plane." The object was circular and appeared to be "slightly larger than a basketball." Its distance was estimated to be slightly more than a half-mile away and its estimated altitude was 1,500 to 2,000 feet. No structural detail was seen. The object was silent and left no trail. Visibility was good, with scattered clouds at about 20,000 feet. There was no moon and only a very slight wind.

"The UFO was traveling west to east and seemed to be rapidly spinning, like a child's top in motion." Its speed seemed to increase as it traveled away from the viewer. Growing smaller, it finally went out of sight. Mr. [redacted] had watched it for about 30 seconds.



Gentlemen;

Recently our organization has undertaken an investigation of some strange material which apparently fell from the sky into a residential New Jersey community.

I have enclosed a resume' of the case. Because the material looks somewhat like melted porcelain, ceramic, or glass, with drops of melted copper-like material included in it, my mind connected it with recent information I have come upon, about government experiments with high-temperature re-entry cones on missiles.

A ceramic nose-cone, as I understand it, coated with a thin sheet of copper or coprous alloy would withstand high temperatures during re-entry, as the copper melted and evaporated, thus cooling the ceramic, which could then withstand the temperatures at lower altitudes by itself.

I should like to know if the material described briefly herein could, in your opinion, be attributed to any such experiments, if such activities have indeed been conducted by your agency or any other department.

Please accept my apologies...I realize this is a rather vague request. But I felt if such experiments have been conducted, your office would know, and would further know if the area or results are to be connected in any way with U. S. missile activity.
