1. SYNOPSIS: Civilian person, New Orleans, La., re-  
ported observing two (2) unidentified flying objects 1845  
hours (CST) 3 Feb 57. (CST, P-6)

2. DETAILS: On 4 February 1957, Mr. [REDACTED]  
[REDACTED] Street, New Orleans, La., reported to representa-  
tives of this District that he had observed two (2) unidentified  
flying objects in the vicinity of New Orleans at about 1845 hours  
3 Feb 1957. The following pertinent information was obtained  
through interview of BREWER:

*prob meteors*

a. DESCRIPTION OF OBJECTS:

- (1) Shape: Circular and flat.
- (2) Size: Appeared approximately size of tennis ball.
- (3) Color: Bright with greenish tinge; appeared to have aura of light around them.
- (4) Number: Two (2).
- (5) Formation: Parallel, with one slightly above the other.
- (6) Discernible Features: Besides the aura of light, the objects appeared to have two (2) round lights in the body.
- (7) Tail, trail, or exhaust: None.
- (8) Sound: None.
- (9) Speed: [REDACTED] calculated the speed of the objects at 8,313 miles per hour, estimating that they were at 30,000 feet altitude and remained within a 120 degree arc of his sight for three seconds.

*How did he compute this - and how approaching darkness 57!!*

*Generally, very complex and elaborate precision instruments required to determine this.*

b. DESCRIPTION OF COURSE OF OBJECTS:

- (1) How noted: Attention brought to objects during casual observation of sky.
- (2) Angle of elevation and azimuth: When first observed, the objects were above observer, about 3 or 4 degrees to the east of vertical and proceeding at an azimuth of about 182 degrees. When last observed, the objects had moved out of his line of vision over the horizon on the same azimuth as when first observed.
- (3) Flight path and maneuvers: Flight path was straight and no maneuvers were observed.
- (4) Manner of Disappearance: Out of sight over the horizon.
- (5) Length of time in sight: Estimated three (3) seconds.

c. MANNER OF OBSERVATION:

- (1) Manner: Ground-visual.
- (2) Optical aids: None.

d. TIME AND DATE OF SIGHTING:

- (1) Time of sighting: 040045Z Feb 57.
- (2) Light conditions: Dark.

- (1) Latitude: 29 degrees 58 minutes.

(b) Wind Velocity:

1 Surface: Nine (9) knots per hour as of 1905 hours observation.

2 Aloft: Only reading available was taken at 1500 hours at maximum altitude of 8000 feet where winds were 21 knots from 250 degrees. By interpolation on a map recording readings from other sites at 1830 hours 3 February, it was estimated that winds at 10, 20 and 30 thousand feet altitude would have been from the same general direction at about the same velocity.

(c) Ceiling: Generally unlimited.

(d) Visibility: Twelve (12) miles.

(e) Amount of cloud cover: .2

(f) Thunderstorms and precipitation: None.

h. UNUSUAL ACTIVITY IN AREA: None

i. EXISTENCE OF PHYSICAL EVIDENCE: None

3. OSI COMMENT: The agent who interviewed Mr. [redacted] reported [redacted] as very coherent and articulate in explaining his sighting. [redacted] appeared to be above average in intelligence. Because this office has no further information as to [redacted]'s background or veracity, his evaluation as a source cannot be made.
