b. The description of this incident indicates that an intercept by jet aircraft occurred. If the objects' speed were that estimated by the observer, it would have been approximately 9000 mph and it would be difficult to follow such movements even for the time period estimated. The thunder-like boom further indicates that the sonic barrier was penetrated and was most likely caused by jet interceptors. Mr. [redacted] apparently is not seeking any personal notoriety. The reliability of this report is unknown.
