SIR:

Athabasca Indian Scout's report large flying object crashed in the western Canadian wilderness of the REAL FOREST AREA of British Columbia Province. The object reported to be a saucer or flying saucer shape, Indian report object is about 200 yards diameter, about estimated weight of 1000 lbs. The strange space machine reported by Chilcot and Athabasca Indians was reported from the area of Alsea Mountains at height of 150 miles then the object descended on a glide into a lake near the Canadian settlement of Aragsa, British Columbia. In view of several reports by U.S. Air Force in Alaska of objects in stratosphere, would it not be advisable to investigate location of space object in the Canadian wilderness area?

The Athabasca (British Columbia) report that object is concealed under heavy growth of timber in British Columbia.

Apparently the object struck the lake area in British Columbia on a large body of water, skidded across lake (Lake Fraser?), into air and then hit Fraser River area of Fraser River, Canada in the interior of the

Object reported to emit a sort of ray or radiation or glow at night. Indians fear to approach object which is on a plateau or elevated area of British Columbia northwest of Fraser River along river shore about several miles in timber.

Space object struck into timber, west under timber onto top of Plateau, the object skidded uphill at high velocity into a heavy growth of timber.

Perhaps the strange rocket? satellite? Space Ship or Missile could be located by Geintellometer instruments from Low Flying airplane - the object is not visible from air Also Indians report some strange appearing persons in the area northwest of Aragsa, British Columbia. Is it possible that secret satellite crashed there? The information here is contained in transmitted via relay mail system from interior of British Columbia.

In view of the Space development program would not such an object be of value to Space Program of Allied Free Nations - U.S.A., Canada, Etc.? Would it not be advisable to send low flying plane to try to pick up radiation ray counts also in timber would it not be advisable to try to locate object on foot reconnaissance? Object is in REAL FOREST AREA, BRITISH COLUMBIA, CANADA, located in heavy growth of timber.

Athabasca -Chilkoot Tribes -Rain Forrest area -British Columbia:

Febr. 1960

Sirs:

Please be advised that a group of Canadian Indians request investigation of a mysterious rocket device now in the interior of the Rain Forrest in western Canada in area known as the RAIN FORREST OF BRITISH COLUMBIA, CANADA.

The Athabasca Indians report that a large device or some sort of a Space ship (Rocket?) has been reported by Athabasca Indian Scouts in British Columbia, object Crashed in the interior of Canadian Province of British Columbia.

The Space Object is reported to be about 200 yards in diameter, about weight of 1000 tons. Object was reported to have come from direction of Alaska — in long horizontal glide of about 40 degrees from great height.

Object may have been a rocket? Sattellite? or some sort of Space ship?


The Athabasca Indians call the device a "SASQUATCH SHIP" and report that object emits radiation rays of some sort at night or faint glow in the dark. According to information received hear the object is in the interior of the Rain Forrest of British Columbia near the small Canadian settlement of AGGASSIS, BRITISH COLUMBIA  
WESTERN CANADA

The Space Ship? or Rocket? is said to be atop of a plateau area, or level hill top near Fraer River, Canada

The object or Rocket is said to have hit Lake Fraser? or some Lake near Rain Forrest area, then skidded across the lake about five miles, then the device rose into air about several miles, then landed on the surface of the Fraser River. The Space object or Shperrical (circular object) then skidded uphill into some sort of heavy timber in the Rain Forrest and is there under a heavy growth of timber now. The Athabasca Indians report that the object is concealed from air and is not visable from airplanes.

The Athabasca Indians are reportedly owners of the Rain Forrest area. The Chief of the Athabasca Indians requests Govern-mental investigation of object to ascertain if object is ~~RADIUM~~ RADIUM DEVICE or is emitting radiation rays, in the interior of the Rain Forrest area of western Canada near Aggassis, British Columbia, northwest of British Columbia settlement of Aggassis, Br. Col. in vicinity of Ruby Creek and Fraser River in heavy growth of timber in the Rain Forrest area of western Canada.





Sirs:

Please be advised that the ATHABASCA INDIANS of BRITISH COLUMBIA PROVINCE in Western Canada, Commonwealth of Canada, report that some sort of a SPACE SHIP or "FLYING SAUCER" has been seen in the heavy timbered area of the British Columbia Rain Forrest Area. The Athabaskan Indian tribe Scouts refer to the Space Ship as "SASQUATCH SHIP" in Athabasca language meaning "SKY BOAT".

According to recent reports from a group of hunters with the Athabasca Indians of British Columbia, the object is said to have come out of sky and hit a lake (Lake Fraser?) then rose into air and hit on Fraser River in British Columbia Province of Canada. The Space object (Missile? or possibly rocket?) is said to be a heavy timber area of the place known as

RAIN FORREST  
AGGASSIS, BRITISH COLUMBIA, (Canada)

The Space ship or Satellite is reported to be circular, about 200 yards in diameter, and the Indians state with weight estimated of 1000 tons, object is made of white metal. The British Columbia Indians report that object is on a plateau area after it slid from Fraser River uphill into (and Thru) timber and is not visable from air but is concealed by a heavy growth of timber in the British Columbia timbered area named "RAIN FORREST". (Near Aggassis, British Columbia, Canada).

The Athabasca Indians reported that the object emits a glow at night or "LIGHT" (possibly radiation?). In view of recent reports of unidentified flying objects (U.F.O.) perhaps it may be advisable to send some competent investigators from the R.C.M.P. office? It may be possible to locate the Space Ship (or Missile-Satellite?) by use of a low-flying plane over Rain Forrest-plane equipped with a Geiger counter and Scintellometer aerial URANIUM LOCATING DEVICES, might be able to find the object as Indians believe it is radioactive object?

British Columbia Indians report that the strange object is 50 miles from Aggassis, (N.W.?) in the heavy Rain Forrest area.

## Military and other Devices of Unknown Origin

1. With reference to the above and correspondence forwarded by the Officer i/c C.I.B. Victoria on 30-3-60, inquiries on a confidential basis have been carried out as requested.

2. Referring to the information contained in letter from [REDACTED] there appears to be little information of value referring to locations in the Agassiz area, and for purposes of clarification they are enumerated as follows:

3. Sasquatch is a common term used in the Agassiz-Harrison Lake area for a number of years and it is a myth or fable in that area referring to a large hairy individual or bogey-man and has been used for a number of years prior to any satellites or space ships being invented.

4. There are no known Athabaskan Indians in the Agassiz area and from references checked, the Athabaskan Indians or Athapascan Indians are centered about the Yukon and McKenzie Rivers and extending into Alaska. There is also some indication these Indians extend south into New Mexico, Arizona and Texas.

5. There are a number of Indians in the Agassiz area and go under the band names of:

Chehalis Indians or Samalupam Band  
Port Douglas Band  
Skokomehuk Band  
Scotts Bay Band  
Strawhook Band  
Seabird Island Band  
Cheam Band

6. There are no known Indian guides in this area and knowing the Indians, locally, it is felt that if they were aware of any strange object the matter would be reported to the police without undue delay.

7. There is no Lake Fraser in this area and the only one which can be located in the Province is a Lake Fraser in the Vanderhoof Detachment area in the Prince George Sub-Division.




8. No area known as the Rain Forest can be located and enquiries made through the B.C. Forest Service produced no information of any location or forest of this name.

9. It would appear from the letter this object is 50 miles northwest of Agassiz, if such is the case it would be in the Pitt River area in the New Westminster Sub-Division and the north end of Pitt Lake is approximately 25 miles north of the Fraser River. It is noted in the letter the initials W.W. appear under the initials N.W. both followed by a question mark. In the event the direction is meant to be 50 miles northeast of Agassiz, this would place the object in the Coombs Pass area, which is approximately 20 to 25 miles east of the Fraser River. The Fraser River flows approximately straight west from Agassiz and if this object is supposed to be near the Fraser River and 50 miles from Agassiz then it would be almost in New Westminster. It might be mentioned the Fraser River, between Agassiz and the Pacific Ocean, is well settled and built up and the possibility of any object landing in or near the Fraser River without being seen by local residents is very remote.

10. Limited and discreet enquiries were made regarding the possibility that a Martin KRAMER could be known in the Agassiz or Harrison Lake area, but these enquiries produced negative results.

11. From the information contained in the letter and from a knowledge of the local area, it is the opinion of the writer there is no foundation to the allegations contained in the letter from Martin KRAMER dated March 6th. Should further enquiries be considered necessary, it is requested the author be interviewed regarding his source of information.

12. It might also be mentioned the area northwest of Agassiz is very rugged mountainous terrain and although there are some logging camps in certain areas, the majority of the country is covered by various mountain ranges and the area could only be surveyed by plane. Should the Department consider it necessary to make such a survey it is requested the required instructions and arrangements be completed and this office advised.

ATHABASCA INDIANS REPORT THAT THE OBJECT IS ABOUT 200 YARDS IN DIAMETER, ESTIMATED WEIGHT OF ONE THOUSAND TONS, (1000) TONS.

OBJECT STRUCK A LAKE FROM TRAJECTORY OF ABOUT 30 DEGREES APPARENTLY SLID ACROSS LAKE AT HIGH VELOCITY, THEN ROSE IN AIR TO STRIKE INTO FRASER RIVER, THEN OBJECT SLID INTO A HEAVY GROWTH OF TREES, N.W. OF AGGASSIS, BR. COL.

OBJECT REPORTED TO BE NOT VISUAL FROM AIR. IT IS CONCEALED BY GROWTH OF HEAVY WOODS IN THE INTERIOR OF THE CANADIAN RAIN FOREST. OBJECT REPORTED TO BE CIRCULAR, MADE OF A METAL APPEARANCE OF STAINLESS STEEL. INDIANS REPORT THAT THE OBJECT EMITS SOME SORT OF RAY OR RADIATION RAY, POSSIBLY A MAGNETIC RAY BEAM MOTOR.

PERHAPS OBJECT CAN BE LOCATED BY USE OF SCINTELLATOR OR GIEGER COUNTER DEVICE FROM LOW-FLYING PLANE. SUGGEST THAT THE UNITED STATES MILITARY INTELLIGENCE INVESTIGATE.

IF SUCH A TYPE OF OBJECT AS AN INTERPLANATORY SPACE MACHINE STRUCK IN THE AREA, IT CAN READILY BE SEEN THAT SUCH AN OBJECT IS OF THE GREATEST VALUE AS A MILITARY DEFENCE UNIT.

6. There are a number of factors which tend to discredit this report. The envelope is postmarked Davenport, Iowa (attachment nr 2), and not Paris, France. The weight and size of the object must be assumed exaggerated. An object 600 feet across and with a weight of 2,000,000 pounds would have ripped a swath through woods that could easily be seen from the air; and an object two football fields in diameter would not be hidden by trees. The report states that the Indian witnesses said that the object was giving off some type of radiation. No particulars about the individual witnesses was provided ATIC, but the Encyclopedia Britanica 1959 states that the Athabaska Indian tribes are a backward people.

7. All indications are that this report is a hoax, but an investigation must be conducted to remove even the slightest doubt of it being true.
