COMMENTS Observation by one witness, however all indications except the direction point to a balloon observation. It is quite possible that the witness could have made an error in his estimation of direction. Speed of the object and duration of the sighting conform to a balloon observation. Enough information is consistent with evaluation of this sighting as a balloon.
