COMMENTS The description and duration fits that of a jet A/C with afterburner in operation at a considerable distance from the observers. A fighter group is stationed in the area where the sighting occurred. It is possible that the witness observed an A/C through the inversion layer, with the illusion distorted due to refraction.

Subject: Advanced Report of UFO's

1. At approximately 2000, I received two calls from the Headquarters USAF Command Post with the following information:

a. A UFO was sighted at 2330 Z south of Loring AFB by the Tower and other personnel. It reputedly had a long red tail and moved from 350° to 170°. One aircraft reported it might have been a celestial body.

b. The above information was relayed through Major Bragg, 8th AF OD via Major Edge, SAC CP.

c. According to Col. Richardson, Boling AFB, Wallops Island launched a balloon today which coincided in time and possibly in appearance with the UFO.

2. Loring will probably follow up with a UFO report.

UFO ANALYSIS SHEET

Location Corwall, Vermont

Date 27 February 1960 Hour (Z) 2328Z

WX 7/10 cloud cover, ceil 4500', vis 30 mi, winds WNW & W at 12 to 75 knots

Description Round, size of pinhead, silver or reflected light, tail 5-7 deg of arc, red at head of tail fading to pale yellow at end, first seen 170 deg 30 deg elev, disapp 140 deg 15 deg elev, appeared to be descending and/or moving away to the east, seen for 1 1/2 minutes

Direction of Motion East

Satellite: (AFCIN-4F3, Phone 69219) Ruled out - none known to be moving East of West around the Earth

Astronomical Phenomena (Meteor, Comet, Planet, etc) Duration excessive for a meteor - moved too fast for a star or planet

Radar Analysis (AFCIN-4E1) None

Natural Phenomena (Ball Lightning, etc) Ruled out

Aircraft, Balloons, Airships, etc. Possibly Aircraft -

Ruled out - witnesses (several) fighter pilots.

Other Possibly illusion due to the inversion present at the time.

Evaluation of Source Reliability Probably Good -

Analysis and Conclusions: The description of this object fits that of a jet aircraft with the afterburner operating. A fighter group is known to be in the area where the sighting occurred. . . . It is most probable that all witnesses were victims of an illusion resulting from some distant and moving light source being brought into view by the inversion layer.

Final
