1. It has been brought to my attention that an unidentified flying object has been sighted by a civilian employee of NAD Crane, Indiana. The details of the sighting are as follows:

a. Between 0130 and 0200 (Zulu Time) on 6 April 1960, [REDACTED] age 46, who resides at [REDACTED], Loogootee, Indiana, and employed in the Quality Evaluation Laboratory as an Engineering Technician, GS-11 (Pay No. 1067), was driving east on Highway 50, about 2 miles west of Loogootee. There were no other passengers in the car. This is approximately 84°-30' North Latitude and 37° -15' West Longitude. A yellow-red light, approximately a foot in diameter and two feet long passed in front of him from left to right. The light came from behind a group of trees, passed over the highway and behind a hill to the right. The direction of travel was north to south. The object seemed to be about 300 feet above the ground, traveling at a slow rate of speed. It was visible for approximately 10 to 15 seconds.

b. He further reports that the sighting occurred between dusk and nightfall. Both visibility and weather conditions were clear. He saw no air traffic in the vicinity. He heard no sound from the object, nor did he see a tail or exhaust trail on it.

c. The weather station located at the Fire Department on the Depot reports that the wind was from the West at 5 miles per hour at approximately the same time that the sighting took place.

2. No other reports of this light have been called to my attention.



1. The foregoing reported sighting of an Unidentified Flying Object is forwarded to your station, the active Air Force base closest to the reported sighting, for investigation in accordance with para 4b, AFR 200-2.

2. Bakalar AFB is an Air Reserve Base, in accordance with ConAC Plan for Air Reserve Flying Units (Air Reserve Technicians) and message, Headquarters USAF, AFPDC 47324, 5 July 1957, with limited area support responsibilities due to the restricted ART manning. Assumption of responsibility in this type of investigation is paralleled in para 19a, AFR 62-14, which provides for the nearest Air Force base commander with technically qualified personnel and proper equipment assuming the investigating responsibility, excluding ANG and AFRes.



2. The town of Loogootee, Indiana is located on the Western edge of the Hoosier National Park at the junction of US Route 50 and 231, approximately 35 miles East of Vincennes, Indiana.

April 6; Loogootee, Indiana - A large yellow-red UFO which crossed the highway from north to south ahead of his car was reported by John V. Hand, a civilian employee (15-11) of the Army. Mr. Hand, an engineering technician, said the UFO travelled slowly, leaving no exhaust and making no audible sound. The UFO was elongated horizontally and roughly elliptical in shape. It was seen in a clear sky between dusk and nightfall, and remained visible for 10-15 seconds. The Tenth AF Station reported the sighting to the Air Force.

WX Clear, winds West at 5 MPH

Description Yellow-red light, about a foot in diameter and two feet long passed in front of the observer, appeared from behind a group of trees and crossed the highway at about 300' alt moving very slow, visible for about 10 to 15 seconds, size of object was about 1' dia and 2' long

Direction of Motion South

Astronomical Phenomena (Meteor, Comet, Planet, etc) Poss a meteor-however, the duration was excessive for the terrain from which it was seen

Analysis and Conclusions: It is possible that the witness saw a meteor; however, the duration was excessive for type of terrain in the area. Due to the lack of corroborating witnesses, this report is evaluated as insufficient data, 1 witness.
