Shortly after the object fell, an explosion-like sound was heard.		11. COMMENTS An attempt was made to recover the object but with no success. Due to about 3 ft of mud in the bottom of the bay and a shortage of funds, the recovery attempt was abandoned. Object was probably a meteorite.	

MEMORANDUM FOR RECORD:

An attempt was made to recover the object that was reported to have fallen into Pensacola Bay on 15 July 1960. Due to the type of bottom, the presence of debris, and a shortage of funds, the recovery attempt was abandoned. The object observed was probably a large ~~meteorite~~ meteorite that failed to burn up in the earth's atmosphere, or possibly a part of an artificial earth satellite. However, due to the apparent size of the object, it was more probably a meteorite.

SYNOPSIS: Assistance in identifying and recovering an object which reportedly fell into Panama (Fla.) Bay about 15 Jul 1960 was requested by COL William VAN HESTER, USAF, Aero Space Technical Intelligence Center. Investigation disclosed independent sightings from four different positions in the locality by the following apparently reliable witnesses: Mr. [redacted], fisherman; Mr. [redacted], charter boat captain; Mr. [redacted], service station attendant; and Mr. [redacted], garage owner. Mr. [redacted] fixes the date of the sighting as 15 Jul 1960; others agree that this was approximately the date, and the hour was about 0345 to 0310 GMT. Object generally described as round, from about three feet in diameter to about the size of a basketball, emitting a fiery red or orange glow, and falling straight down from the skies. Object reportedly fell with excessive noise; entered bay with bubbling sound, rendering shocks or explosion effects as result of its entry into the water. Encl. (1) reflects approximate positions from which witnesses reportedly sighted object and the spot where object reportedly fell into Panama Bay. Commanding Officer, NAS-Panama and activities of SIXTH Naval District are rendering assistance in efforts to recover the object.

ADMINISTRATIVE NOTES: DIO-6ND is requested to advise the Aero Space Technical Intelligence Center, Wright Patterson Air Force Base, Dayton, Ohio of the results of this investigation to date.

Files of DIO-6ND contain no previous record of the individuals named in this report.

PREDICATION

1. This investigation is predicated on a telephonic request of 25 Jul 1960 by Colonel William VAN METER, Aero Space Technical Intelligence Center, Wright Patterson Air Force Base, Dayton, Ohio, requesting the aid of Resident Agents Office, Pensacola, Fla., in attempting to identify and recover an object reportedly seen by [REDACTED] a Pensacola, Fla., fisherman, and described as a screaming, red hot, bubbling object that fell into the waters of the Pensacola (Fla.) Bay at approximately 0345 about the 15th of Jul 1960. All facts were reported to District Intelligence Officer, SIXTH Naval District, who directed further inquiry. This investigation was conducted by Special Agents [REDACTED], Jr. and [REDACTED]

DETAILS

2. Special Agents of RAO-Pensacola, Fla., identified [REDACTED] as [REDACTED] [REDACTED] Pensacola, Fla., and interviewed him on 25 Jul 1960. Few additional facts were elicited beyond those originally reported by Colonel VAN METER. [REDACTED], who is believed fairly reliable, declared that a Naval officer, on leave from his duty station somewhere in Georgia and who was visiting the area, was the original individual to whom he reported the sighting, and that this individual undoubtedly made further report to his superiors. [REDACTED] related that at approximately 0345, about 15 Jul 1960, he was in his fishing boat, west of the Pensacola Bay Three Mile Bridge, U. S. Highway 98, and east of the Municipal Pier, when he sighted a red hot object, which appeared to be three feet in diameter, falling straight from the heavens into the waters of the Bay. He said the object, upon entering the water, engendered three distinct shocks to the hull of his craft. [REDACTED] reiterated the fact that the object was red hot, but could contribute nothing further to help in identifying it. He added he had taken a bearing of the approximate spot the object entered the water and felt he could come within about 300 feet of that spot in any future attempt to locate the object (see encl. (1)). [REDACTED] added there were several shrimp boats in the area, but he questioned their crews and found that none had seen the object. He attributed this failure to observe to the fact that they had been out all night, were probably dosing, and further intimated some of the crews were probably intoxicated. He remarked he later understood that a man by the name of [REDACTED] a charter boat captain, had seen the object from across the Bay, a distance estimated as possibly seven miles.

3. Mr. [REDACTED] was reinterviewed on two subsequent occasions, but could add nothing further to the information he originally furnished.
4. On 26 Jul 1960, CAPT H. C. DeLONG, Commanding Officer, NAS-Pensacola, Fla., was briefed on the foregoing information and directed his Boat Division Officer, [REDACTED], to make an attempt to locate the object through use of Navy scuba divers. On 27 Jul 1960, LCDR BRUNNER, CWO [REDACTED] and [REDACTED] rendezvoused in the critical area, and with the benefit of the latter's estimated place of entry into the bay, commenced diving operations in order to recover and identify the object. This operation was conducted with limited personnel and proved unsuccessful. [REDACTED] pointed out that in the area under examination, the water is approximately 30 feet deep with a mud bottom of about 18 inches. It was further noted that several shrimp boats had dragged the area, which might preclude recognition of the spot of the object's possible entrance into the Bay mud.
5. On 9 Aug 1960, the charter boat captain mentioned by [REDACTED] as having seen the object was fully identified as [REDACTED] East Pensacola Heights, Fla., owner of the craft [REDACTED] Mr. [REDACTED] who is separately reliable, was interviewed that same day and stated his charter boat is harbored at the Breezeaway Marina on the south end of the toll bridge between U. S. Highway 98 and Santa Rosa Island. Captain [REDACTED] said he could not fix the exact date on which he sighted an unidentified object in the sky, but believed it was about the middle of July. He related he had left his home in East Pensacola Heights, by automobile, proceeded across Pensacola Bay Three-Mile Bridge toward Ft. Walton Beach on U. S. Highway 98, and was approximately a half mile beyond the southern end of the bridge and about opposite the Gulf Breeze, Fla., Post Office (see encl. (1)), when he heard a noise, and turning about, noticed a fiery object dropping straight from the skies behind the trees and into Pensacola Bay to the west of the bridge he had just crossed. He stated it was approximately 0305 in the morning and was still dark, but that it was a clear night. He added he first thought it was a signal from a Vary pistol, and described it as brilliant in color. He declared he had no basis for comparison and was unable to arrive at a conclusion as to the size of the object. Shortly after the object fell behind the trees, he said he heard a noise that sounded like the explosion of "both barrels of a double-barreled shotgun." Captain [REDACTED] added he did not see the object enter the water, but from its place of disappearance from view, he believed he is pretty certain of the area in which it landed. Captain

related that he drove a short distance down the road and pulled into a Standard Oil Station (see encl. (1)), where the night attendant asked him if he had seen the previously described object. He added they compared notes as to the sighting and were in agreement on the appearance of the object. said later, upon his arrival at the marina (see encl. (1)) where his boat is moored, he encountered an individual, who was one of his charter party, and this person queried him as to whether he had also seen an unidentified object in the sky. Captain does not recall the name of this individual.

6. On 9 Aug 1960, the filling station attendant at the Standard Oil Station on U. S. Highway 98 (see encl. (1)) was identified as whose residence address is Myrtle Grove, Fla., and mailing address is P. Myrtle Grove, Fla. According to Mr. operator of this station, was proven a dependable and reliable employee. stated he is on night duty at the aforementioned station from 1900 to 0700 and is the lone attendant. commented he could not recall the exact night, but during the middle of July, about 0400, while he was washing the islands surrounding the gas tanks, he noted an object falling straight from the sky which emitted a bright orange glow, becoming brighter as it continued its path downward. He declared the object disappeared behind the trees, northwest of the station and shortly thereafter, he heard an explosion that shook the windows of the filling station. He said it was a clear night, but he could not give any further information that would be helpful in identifying the object. mentioned having talked with Captain HURD about the object and recalled that a garage man from further down the road had stopped by the station on his way fishing and had also mentioned the spectacle.

7. On 10 Aug 1960, Mr. Gulf Breeze, Fla. (see encl. (1)) was identified as the garage man who operates a business on U. about a quarter of a mile south of Pensacola Bay Bridge. Mr., who is apparently reliable, when queried, instantly recalled sighting an object on the morning of 15 Jul 1960 from the back porch of his home at about 0410 fixed the exact date by the fact that his brother from Mississippi was visiting him and both had arisen at that early hour to go fishing on the Pensacola Beach pier (see encl. (1)). related that on opening the back door of his home, facing the northwest, he was greeted by the sight of an object that was fiery red,

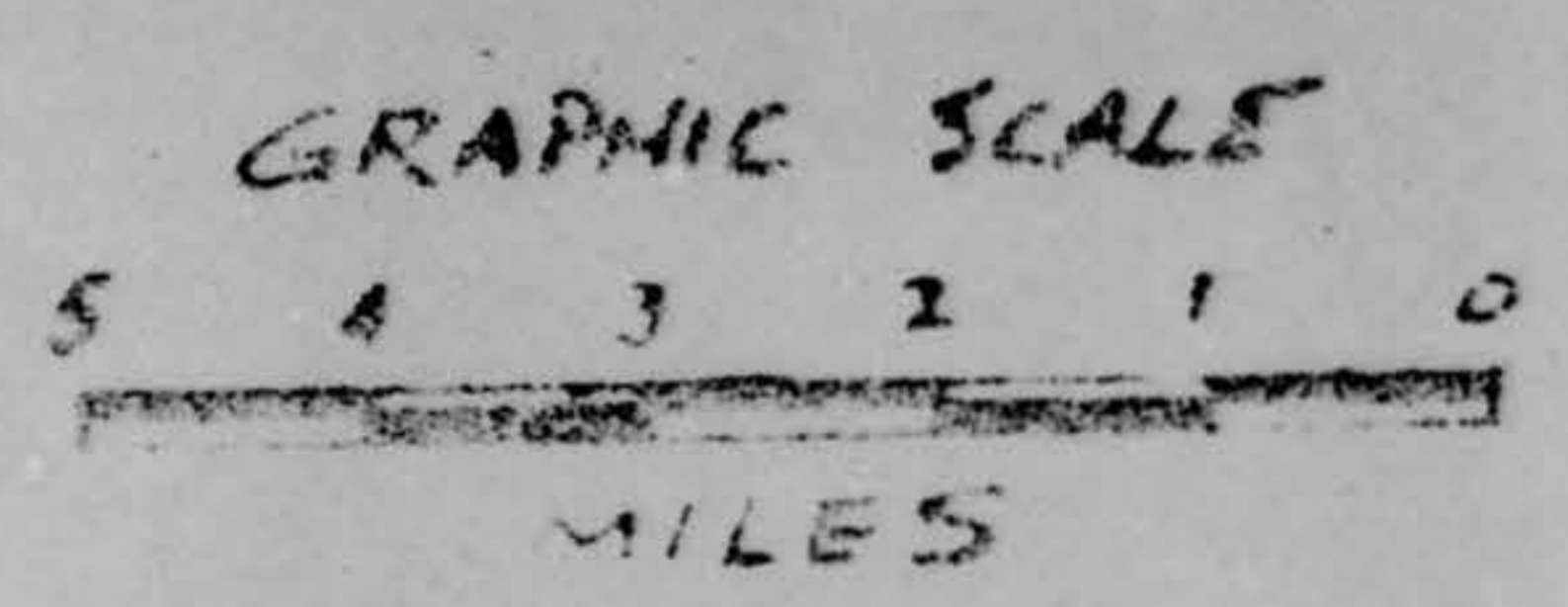
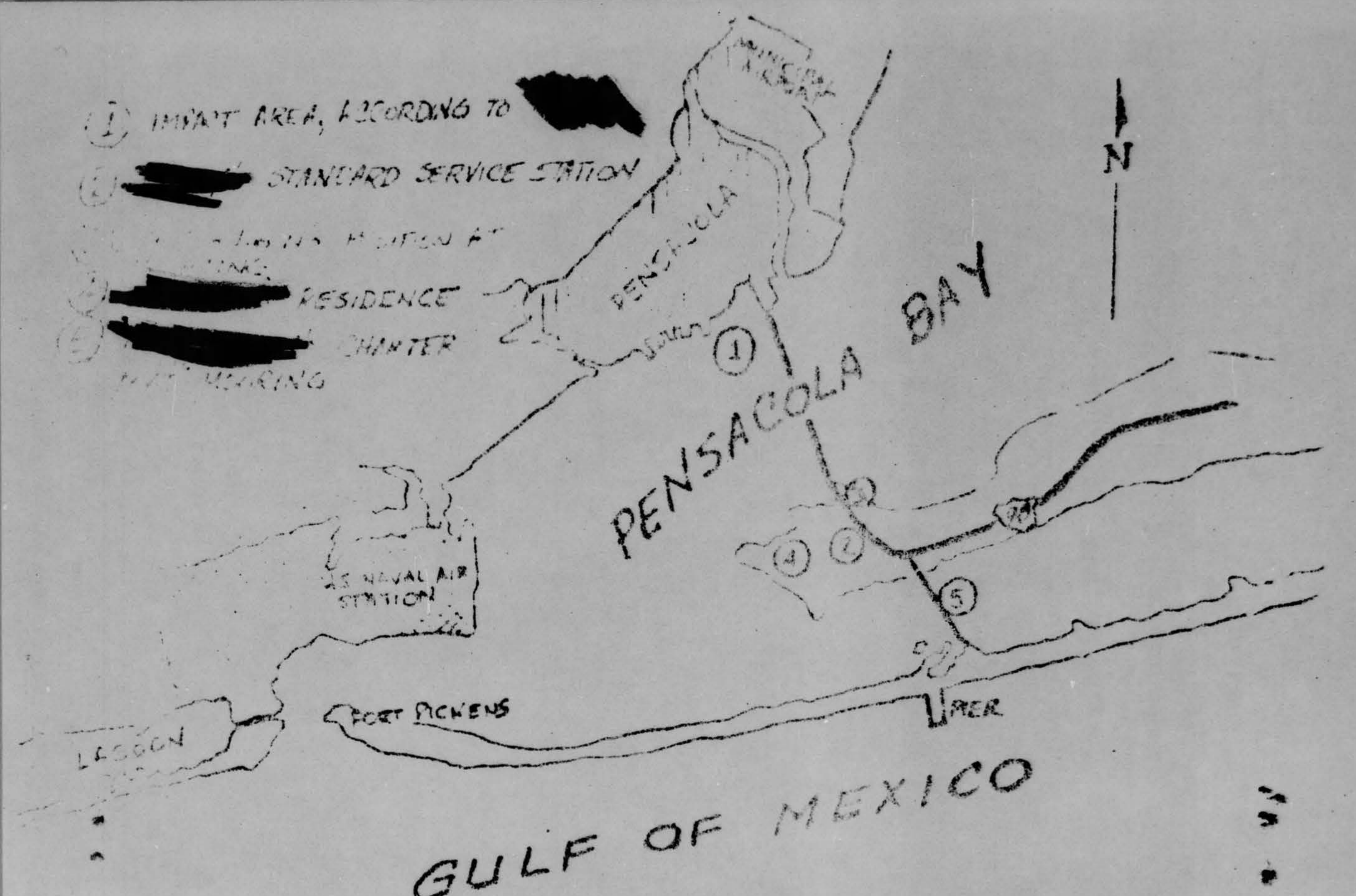

and about the size of a basketball, falling straight downward from the sky. He related that the object disappeared behind the trees and adjacent houses and shortly thereafter, he heard an explosion which reminded him of "dynamite blasting of stumps." He said he first thought it was a jet plane that exploded and then discounted the thought, owing to the roundness of the object. Mr. [REDACTED] described the night as clear, but he could not recall any other distinguishing features of the object. He added that when he reached the fishing pier on Pensacola Beach, two or three other fishermen, names unknown, asked him if he had seen the fiery object, and upon comparing notes, all were in agreement with what he described as having seen.

[REDACTED], Executive Officer, NAS-Pensacola, Fla., was advised of additional confirmation regarding the sighting of the object, and as a result of a conference with the Commanding Officer, NAS-Pensacola, and [REDACTED] Boat Division Officer, arrangements are presently being made to bring in Ordnance Disposal Unit No. Two from Minecraft Base, Charleston, S. C., with new sonar equipment, and another unit of divers from Mine Test Station Unit, Panama City, Fla., for further extensive search of the Pensacola Bay area in an endeavor to locate and identify the object.

...The unidentified lights at Sheep Rock Mountain, near Coeburn, Virginia were back in the news again this past July. Last year, local authorities and hundreds of citizens joined in a search for the source of the persistently-appearing objects, but uncovered nothing. This time the sighters were Hiram Adkins and his son, who said they saw a light on each of two successive nights. Each was traveling in a northerly direction about 500 feet above the hills near their home. The first time, the light seemed to go into the side of Sheep Rock Mountain, and the second one disappeared from view before it reached the mountain.

.....A nicely detailed sighting made last July 1st is reaching us only now, almost a year later. The object was seen by several people near Montpelier, Idaho. It was bright, silver colored, and appeared to be made of highly polished metal having the shape of two dinner plates face to face. One of the sighters estimated that it had a diameter of 135 feet, and was 14 feet through the center. Five transparent bubbles projected from the bottom. The object was viewed from a distance of only about 400 feet, and was seen to descend to a height of 50 feet above the ground. It then suddenly ascended and took off at tremendous speed. There was no evidence of jets, rocket exhaust, propellers, fumes, or smoke, and no sound was heard....

Dear Sir:

I am writing again in regard to the UFO residuals which have been discussed in previous correspondence (see my letter dated 9 March 1960 which you answered 14 March 1960)

We have delayed sending this material to A. T. I. C. for several reasons. We feel for one thing that Air Force analysts should have an opportunity to study the complete history of the material before attempting tests of their own.

A complete report of this type has been prepared for some time but we have encountered problems in getting it published. These problems appear at present to have been resolved and copies will be forwarded to your office and to A.T.I.C. as soon as possible.

For reasons not entirely clear, you have chosen to withhold comment on our suggestion that the proposed tests be performed by an independent testing agency under the cognizance of USAF and APRO representatives.

I urge the sincere consideration of this procedure for this reason: The accusations of Donald Keyhoe together with certain grave inconsistencies between fact and Air Force public information releases has resulted in a loss of public confidence which frankly speaking is shared by APRO. The procedure we recommend would eliminate any basis for suspicion concerning test results by demonstrating the good faith of all parties concerned.

I would also like to inquire whether or not the Air Force has reached any official conclusions concerning the following listed cases and, if so, what these conclusions are:

(1) The case at Red Bluff, California, August 13, 1960, involving Sgts. Scott and Caron and jailer Clarence Fry (simultaneous viewing from two locations provided range and altitude data).

(2) The incident near Boulder, Colorado (in Left Hand Canyon) on 11 August 1960 involving Ray Hawks. He stated "saucer" "repaired itself" in mid-air, caused engine of his tractor to stop and described emotional reactions symptomatic of Gamma radiation.

(3) The case at Leefe, Wyoming involving five employees of the San Francisco Chemical Company who described a UFO hovering as if to land on a slag dump on July 1, 1960.

We will be interested in their results and, of course, would like to check this material ourselves at the Aerospace Technical Intelligence Center.

We speeded up because we were afraid and the car got so hot we could hardly breathe. It woke up my daughter and her husband in the back seat. They actually woke up "flapping for air." FLYING SAUCER

On July 2, 1960, at 3:18 A.M., I observed from the terrace of my residence, which faces east, a white form moving in the sky. This form was circular and whitish and many times bigger than the biggest star in sight. It was not bright nor did it have clearly defined borders like a circle drawn on paper. It can be compared with a thin powder puff. Focusing on it with a small telescope I saw something like shafts of light emerging from a center or core.

I called my wife who was sleeping and she also saw this form moving in the sky.

It was not an airplane, nor a star or planet, nor the reflection of a searchlight. The night was clear and the stars were visible. I live in a place where the residences have big lots and it is quiet and peaceful.

The form was at an approximate angle of 40 degrees from the horizontal plane and was moving slowly at approximately 40 degrees from the vertical—to the southeast. It faded gradually and disappeared completely at 3:24 A.M.

SUBJ: UFO Sighting Around July 4, 1960, Revere Beach, Mass.

After six years, you are probably wondering why I finally decided to report my sighting. Curiosity, time, and courage to write are my answers. I am now a married mother of one child, and I was in the library the other day and decided to obtain a book on UFO'S. I think the title was something like, "The Air Force and UFO'S" by a Lt. Col. Talbert (not sure of author's correct name). In that book, I noticed that most letters from civilians are answered, even a few that border the ridiculous.

Could you please tell me whether anyone reported this sighting and whether it has been explained or not? Approximately 1,000 people might have been watching the same Fourth of July Fireworks and seen the same thing. Here is my story.

The Fourth of July Fireworks were held within a few days ~~XXXXXX~~ of the 4th, 1960. My then boyfriend, [REDACTED] of Salem, Mass. (have not seen for five years) and myself were parked along the beach waiting for the fireworks to begin at about 10:00 p.m. About 9:45 p.m.
