Seemed to travel 3-4 times as fast as Echo.		11. COMMENTS Maneuver performed by the object rules out the possibility of it being a satellite or astronomical body. Witnesses are located on the SW edge of Boston and there are a large number of a/c both large and small, civil and military, flying in the area. It is possible that the object observed by the witnesses was an a/c. However there is insufficient info in the report to allow a valid conclusion.
