Witness was lying in bed at time and reportedly did not have much of the sky in view. Witness is an arthritic and could not go to the window for a better view. They were possibly fireflies. However, this is highly doubtful. There was only one witness to the sighting, therefore classed as insufficient data.

Dear Sir,

I wish to make some explanations regarding these objects which my mother has seen as aforesaid. (My mother is arthritic and could not get out of bed to go to the window to try to see more of these objects or follow them. She certainly would have if she could.) From the window which afforded her the view, not much of the sky is visible due to a number of pine trees approximately 200 ft. from the house. Now, she claims that she saw these objects in front of or before these trees. Therefore, these objects couldn't have been more than 70 or 80 feet off the ground, whatever they were. If these objects were in the sky, they would only be visible through the limited openings in the tree branches. But my mother emphatically claims the contrary.

I feel this explanation is absolutely necessary in order to truly evaluate what my mother has seen.
