I am writing in reference to an article that appeared in our St. Louis Post-Dispatch this Thursday, September 29th, in regards to an object seen in the sky by several pilots and reported to you.


We too, have seen an object which seemed to be exactly as was described in the paper, even to it's movements. I spotted this object the first time directly west and to the best of my memory about four or five days later north-northeast. This was the first part of September. The first time we saw it my twelve year old daughter and I were sitting on the front porch. We watched it very closely with the glasses and fixed it between tree branches. It seems to bounce slightly as it hovers and in both cases moved to our right. Since my family seemed to think I was seeing things, as I enjoyed watching for the Satellite on clear nites and it came up in the same place, is probably the reason I was concentrating so, and saw this object. Normally you wouldn't notice it moving. The second time I saw it a little later which by the way coincides also. This first time about 9:15 or so and the second time close to 10 o'clock. This time I called an older daughter and a nineteen year old son who had already retired but is quite interested in such things. We all took turns with the glasses and they too were convinced. We watched until the trees finally

slected our view. On both occasions we called our Air Tower, which is due west of us less than five miles and we could get no information. I also called the Weather Bureau and they told me it was probably Venus. I had never seen Venus in three definite colors before and we had just been to The Hayden Planatorium in New York several weeks before.

The children and I would certainly enjoy a reply from you if you find it within your interest.
