Gentlemen:

A little over a month ago I ordered a few publications from the Division of Public Documents--concerning outer space, etc.--at the same time inquiring about any information on UFO's. Since they had nothing on the UFO's they referred me to your office.

I am greatly concerned because of having seen a strange object some time ago---feeling certain that this was no known earthcraft (since I had lived very near an airport most of my life!)

Also, I have some photos (taken quite recently by a friend) which have puzzled us very much. They were taken of the moon alone, and when developed, strange objects and lights appeared on the negatives, and so on the finished photos.

The camera has been scrutinized by experts. The conditions under which these photos were taken are indisputable--and we have positive proof that the negatives were not retouched!

These objects are not meteors---they are "things" in flight going around and to the moon!

This is no hoax, and we sincerely wish to know whom to contact or what to do. Is this important information to our government? Please let us know as we are greatly concerned.

SUBJECT: Request for Photoanalysis

1. It is requested that an analysis be made of the attached photographic prints and negatives to determine the nature of the images.
2. The following information about the camera is the extent known at this time:
 - a. Kodak, with bellows, and is around 20 years old.
 - b. Shutter speed - 6 - 8 seconds.
 - c. "F" stop - F11
3. It is requested that the negatives and prints be forwarded to ~~ME~~ upon completion of the analysis in order that they may be returned to the witness.

1. Source is reported to have implied that these photos are the results of his attempts to photograph the moon. The interviewer states that the camera had a focal length of approximately 4 to 6 inches. The 3/4 inch diameter image appearing on the negative could not be that of the moon unless it was taken with a lens of approximately 6.6 foot focal length. There could be many possible explanations for this image. For example it might be explained as a view of a back-lighted circular opening.

2. The random traces appearing on all of the negatives probably were caused by a small concentrated light-source (or possibly a highly reflective object) moving about in relation to the lens and in the field of view.

The photographs of an unidentified object which you loaned to the Air Force have been analyzed. The random traces which appear on all of the negatives were probably caused by a small concentrated light-source moving about in relation to the lens and in the field of view.

The 3/4" diameter image which appears on the negatives could not possibly be that of the moon unless it was taken with a lens of approximately 6.6 foot focal length. This image could be that of a back-lighted circular opening. It is possible that the company which processed the film mixed the rolls and returned the wrong set to you or that you mistakenly sent a roll of film which you had taken of some other object rather than the pictures which you had taken of the moon.

The prints and negatives which you loaned to the Air Force are being returned with this letter. The Air Force thanks you for your interest and cooperation in this case.
